SUBJECT: Safe Routes to School Projects Update

RECOMMENDATION:

It is recommended that the City Council approve the proposed Safe Routes to School grant changes to project budgets (Attachment "A") and concepts (Attachment "B"), and authorize staff to present said changes to Caltrans for review and approval.

BACKGROUND:

- 1. In November 2007, the City was awarded a grant for the Federal Cycle 1 Safe Routes to School (SRTS) Program, based on its grant application. The City was awarded \$994,126 of Federal funds with no local match requirement. However, the City's grant application identified a commitment of \$185,369 of local funds for a total project of \$1,179,495.
- 2. In 2008, the City was awarded a grant for the State Cycle 7 Safe Routes to School (SR2S) Program, based on its grant application. The City was awarded \$860,531 of State funds with a local match requirement of \$96,965, for a total project budget of \$957,496.
- 3. In February 2009, the City was again awarded a Federal grant, based on its grant application for the Federal Cycle 2 SRTS Program. The City was awarded \$999,850 of Federal funds for this project with no local match requirement. No local funds were committed in this project.
- 4. In May 2012, City staff presented project concepts for City Council review and approval for the State Cycle 7 SR2S Project. City Council approved revised project concepts and staff subsequently requested Caltrans approval of a change in the grant scope of work.
- 5. In October 2012, Caltrans approved a reduced scope of work and a corresponding reduced grant amount for the City's State Cycle 7 SR2S Project. The State reduced the grant from \$860,531 to \$595,674 and the local match requirement from \$96,965 to \$66,186. This grant deadline is June 30, 2016. (The Federal grants have no set deadline.)

- 6. City staff and consultant subsequently applied the City Council approved Cycle 7 SR2S project approach to the other two Federal projects and prepared bid documents for all three projects. However, staff did not proceed with the competitive bid process.
- 7. On July 15, 2013, staff presented project concepts for all three projects to the City Council for re-consideration and further direction. City Council requested the agenda item be rescheduled for further discussion.
- 8. On September 3, 2013, City Council continued the discussion. The City Council strongly expressed concerns about the proposed construction of additional bulb-outs throughout more City streets. No formal action was taken. The projects have since been on hold.

ANALYSIS:

The Safe Routes to School Programs are focused on increasing the number of children who walk or bicycle to school, by funding projects that remove the barriers that prevent them from doing so. Those barriers include: lack of infrastructure, unsafe infrastructure, and lack of educational programs that promote walking and bicycling.

There are two separate Safe Routes to School Programs, both administered by Caltrans: the State program is referred to as SR2S and the Federal program is referred to as SRTS. Both programs are intended to achieve the same goal of increasing the number of children walking and bicycling to school by making the infrastructure safer. The City was awarded grants in both programs.

Grant Issues and Problems

The previous City Council approved a project concept for the State Cycle 7 grant and staff applied the same approach to the other two Federal grants. As mentioned above, staff and consultant also prepared bid documents for the projects but did not proceed with the competitive bid process. The current analysis has identified significant problems with the previous proposed scope of work and the bid documents:

- 1. The engineer's estimate for the Federal Cycle 1 grant was inaccurate. Staff conducted a peer review and found the scope of work to be approximately \$1.1 million higher than the original engineer's estimate.
- 2. The proposed scope of work for the State Cycle 7 grant and the Federal Cycle 2 grant were overlapping and duplicated work. The analysis also found that work in many of the intersections was split between the two grants.
- 3. City local match funds committed in the grant applications totaled over \$250,000, but only \$66,186 was programmed in the City budget.
- 4. The bid documents included project descriptions that did not match the bid schedules. Additionally, the bid documents were incomplete in several areas.

5. Almost all grant funds were committed to construction (approximately \$2,500,000) and project contingency (approximately \$192,000). Very little or no funding was committed to soft costs (i.e. design, engineering, plans, labor compliance, inspection, and project management). The City does not have the in-house resources or expertise to properly handle projects of this size and would likely have sought outside consultant services to assist. If the City retained consultant services, such costs could have ranged from 25% to 35% of construction costs or more, with no funding identified to handle these services.

Beyond the scope of work and funding problems described above, the current City Council has expressed an interest in revising the proposed scope of work. All of this will require the submittal of a revised scope of work and budget to Caltrans for review and approval. Staff has been in discussions with Caltrans staff about possible changes. Caltrans has advised and cautioned staff that any proposed changes must continue to address the safety issues that were called out in the original grant applications. Additionally, the scope modifications must serve the same schools identified in the grant applications.

Original Project Budgets and Proposed Project Budgets Summary

Staff has prepared revised project budgets for each grant (see Attachment "A"). Staff is proposing to re-align the grant scope of work to include critical services for plans and specifications preparation; construction management; and project management. Two million dollars of project work is a substantial amount of work to properly oversee and manage to meet City standards and Caltrans standards. The grant provisions allow for the inclusion (reimbursement) of these types of professional services. This will allow the City to ensure compliance with bid plans and specifications, as well ensure compliance with grant requirements such as labor compliance (prevailing wages).

A summary of the proposed budget changes include:

Staff is also proposing a significant decrease in the Federal Cycle 1 scope of work to address the \$1,100,000 under estimated engineer's estimate and a \$122,751 decrease in local matching funds for the same project. Instead of the original \$185,369 local match for construction and project contingency, staff is proposing \$62,622 in City staff project management services to be funded with the General Fund.

Original Project Concepts and Proposed Project Concepts Summary

The proposed project concepts will continue to address the safety issues that were originally identified in the City's grant applications. The Safe Routes to School Programs have placed high value on the installation of bulb-outs and chicanes as a safety measure. Staff has, however, removed those items per the direction of City Council and is now proposing what staff believes will be acceptable alternatives to Caltrans. A detailed list and original/proposed comparison by grant is included herein as Attachment "B". The proposed project concept has removed bulb outs, chicanes and chokers, and has added red flashing beacons and speed feedback signs.

The proposed scope of work will still address the same schools as included in the original grant applications. Project maps by grant are provided herein as Attachment "C".

BUDGET IMPACT:

Staff is proposing to re-align the grants project budgets to provide \$161,093 of funding for City staff project management services. This will however, include a local match commitment of \$62,622 that was not programmed into the City budget. The intent is to post staff hours spent on the project, to the project instead of staff hours normally charged to general Public Works Administration. While the hours will still be funded by the General Fund, the City will be able to describe the expenditures as a project local match contribution.

Additionally, if the proposed grant changes are approved, the City will be reimbursed just under \$100,000 for other City staff project management services.

CONCLUSION:

The proposed Safe Routes to School grant changes are believed to be in the best interests of the City. The proposed scope of work continues to address safety issues in the City's infrastructure around City's schools, while responding to City Council concerns. Staff is recommending that the City Council approve the proposed project concepts and direct staff to engage Caltrans in discussions to change and approve the grants' scope of work and budgets as described above.




Safe Routes to School Plan City of San Fernando

Proposed - Cycle 2









Safe Routes to School Plan City of San Fernando Cycle 7


