APPROVAL OF THE MINUTES

Commissioner Ruelas motioned to approve the minutes for the June 16, 2010, Transportation & Safety Commission meeting. The motion was seconded by Commissioner Ballin. The motion carried unanimously.

PUBLIC STATEMENTS

Lupe Fairman (Aszkenazy Development) - Ms. Fairman requested the reduction of the speed limit at Carlisle Street, have speed limit posted, and have crossing area striped out

NEW BUSINESS

- 1. Carlisle Street Speed Limit Ron Ruiz reported test results obtained from traffic counts. Mr. Ruiz informed the Commission that under the traffic calming plan, Carlisle does not qualify for speed humps. Mr. Ruiz handed out copies of email he received from Mr. Yogi Joban, owner of dialysis business, stating his concern of the speed limit and the condition of the alley. Asphalt patching and installation of pedestrian crossing signs can be done in the next few weeks. Item was tabled.
- 2. **Trolley Bus Plan Update** Mr. Ryan Snyder (Ryan Snyder Associates) presented the Trolley Bus Plan Update. Commissioner Zobel-Rodriguez motioned to recommend to City Council to combine Trolley Routes A and B. Commissioner Ballin seconded the motion. The motion carried unanimously.

UNFINISHED BUSINESS

- 1. **O'Melveny St./Workman St. Stop Signs** Mr. Ruiz informed the Commission that he is still waiting to her back from the City of Los Angeles. City has already ordered signs to include in the City of Los Angeles. Staff is also working on the map to identify specifically where signs would be installed in the City of Los Angeles. Staff and Police will review sign locations.
- 2. **Commission Task List** Commissioners discussed the task list with staff.
