VII. PUBLIC COMMENT

- Esther Schillar, Executive Director of S.A.F.E., a non-profit agency funded by the State of California, is assisting the City of San Fernando in developing and passing a smoke-free ordinance. Ms. Schillar is particularly addressing the problem of drifting smoke in multi-family units.
- Surveys are being conducted in the City of San Fernando. Completed surveys
 reveal almost one third of those living in apartments in San Fernando are
 affected by neighbors who smoke. Most of those surveyed would prefer to live in
 a smoke free building and would like to see a law passed that would prohibit
 smoking in multi-family units.
- Ms. Schiller will continue working with the City of San Fernando to assist with the process of passing a smoke-free ordinance and would like to return to the next Senior Board meeting.

A. CSUN/San Fernando Wellness Partnership Update

- Liane Fujita reported that Healthy Family Classes are about half way through. The last day of classes will be on 11/18/11.
- Classes are planned to continue in the future. One of the goals is to create a "faith-based" partnership.

- The Las Palmas Senior Club will host their annual Halloween Dance on Saturday, October 22nd at Las Palmas Park from 7 pm to 12 am. Prizes will be awarded for best costume in various categories.
