Location: Redevelopment Agency Project Areas 1, 1A, 2, 3, 3A, and 4.

Applicant: City of San Fernando Redevelopment Agency

Proposal: The proposed 2010 Amendments to the Redevelopment Plans

for Project Areas 1, 1A, 2, 3, 3A, and 4 and the draft Amended Redevelopment Plan for the Merged Project Area ("Amended Plan") prepared in connection with the 2010 Amendments

Proposal: The proposed project is to convert an existing single-family

residence into a commercial dental office. The subject site is an approximate 6,896 square foot interior lot, located along the 400 block of North Maclay Avenue, Between Fourth and Library Street within the Maclay District of the SP-4 (Corridors Specific
