#### **Recommendation:**

Staff recommends that the Planning and Preservation Commission approve Conditional Use Permit 2010-01, allowing the operation of a business that warehouses and distributes automotive glass product from within an existing 43,700 square foot industrial building, pursuant to Planning and Preservation Commission Resolution 2010-07 and conditions of approval attached as Exhibit "A".
