**Subject:** Consideration to Adopt a Resolution Approving the Warrant Register

#### **RECOMMENDATION:**

It is recommended that the City Council adopt Resolution No. 17-041 (Attachment "A") approving the Warrant Register.

#### **BACKGROUND:**

For each City Council meeting the Finance Department prepares a Warrant Register for Council approval. The Register includes all recommended payments for the City. Checks, other than handwritten checks, generally are not released until after the Council approves the Register. The exceptions are for early releases to avoid penalties and interest, excessive delays and in all other circumstances favorable to the City to do so. Handwritten checks are those payments required to be issued between Council meetings such as insurance premiums and tax deposits. Staff reviews requests for expenditures for budgetary approval and then prepares a Warrant Register for Council approval and or ratification. Items such as payroll withholding tax deposits do not require budget approval.

The Finance Director hereby certifies that all requests for expenditures have been signed by the department head, or designee, receiving the merchandise or services thereby stating that the items or services have been received and that the resulting expenditure is appropriate. The Finance Director hereby certifies that each warrant has been reviewed for completeness and that sufficient funds are available for payment of the warrant register.

#### **RECOMMENDATION:**

It is recommended that the City Council:

- a. Approve a Non-exclusive License Agreement (Attachment "A" Contract No. 1846) with Neighborhood Junior Tennis Program (NJTP) for the use of office space at Recreation Park; and
- b. Authorize the Interim City Manager to execute the Agreement.

#### **BACKGROUND:**

- 1. Since October 2015, the City has collaborated with Southern California Tennis Association (SCTA) and Neighborhood Jr. Tennis Program (NJTP) to implement year-round tennis programming and competition for both children and adults at Pioneer Park.
- 2. In the summer of 2015, the SCTA and NJTP secured approximately \$15,000 in grants to refurbish the tennis courts at Pioneer Park. Since reopening the courts, the NJTP has conducted weekly free and low-cost programs for the community.
- In October 2016, the SCTA and NJTP, along with City staff, discussed potential opportunities
  to improve youth tennis programs, which included moving the NJTP operations to one of
  the City's park facilities.

#### **ANALYSIS:**

# Neighborhood Jr. Tennis Program (NJTP)

The NJTP is a non-profit 501(c)(3) organization with a well-established group of partners, including the United Parcel Service, United Way, LA 84 Foundation, Riviera Country Club Foundation, Southern California Tennis Association, Tennis Tutor, and JP Morgan Chase Bank. NJTP offers affordable group tennis lessons, private lessons and tournaments for children and adults in the Northeast San Fernando Valley. The goal of NJTP is to improve the community and the lives of children through tennis. NTJP provides the community an opportunity to learn a life sport that will inevitably help academics and health by teaching the participants discipline, hard work, and the importance of physical activity.

The City and NJTP began their collaboration in 2015, at which time NJTP was able to secure funding to revitalize the existing tennis court at Pioneer Park. This included court resurfacing, painting new blended lines, installing nets and repairs to court perimeter fencing. Since then, NJTP and the City have continued to work together towards the development and implementation of programs that address issues of common interest for the benefit of the community.

# **Proposed Agreement**

NJTP will continue to coordinate tennis programming, promotion, and perform facility maintenance at Pioneer Park. In addition, NJTP is requesting access to office space at Recreation Park in order to conduct the administrative functions.

The office space identified is approximately 100 square feet, located on the northwest side of Recreation Park. The underutilized office space was previously used for the Senior Meal Program supply room. However, the space has been cleared, has the appropriate phone and electrical supply lines, and is ready to be occupied.

The main components of the License Agreement are as follows:

- Initial three year term and a maximum of two consecutive one-year extensions;
- Office hours to match Recreation and Community Services' "normal hours of operation" that currently include being open between 8:00 a.m. and 10:00 p.m., Monday through Friday, and open from 8:00 a.m. to 5:00 p.m. on weekends;
- Shared use of facility restrooms and conference room;
- NJTP to make all physical improvements to office space needed to initiate operation at their sole expense;

• NJTP to pay the City a monthly fee of \$225 (equivalent to \$2.25 per square foot for use of 100 square feet of office space) that would result in an annual license fee of \$2,700 to the City for use of the office space.

#### **BUDGET IMPACT:**

The City Council's approval of the Non-Exclusive License Agreement between the City and NJTP would result in an increase to the General Fund revenue of \$225 per month, or \$2,700 for a 12-month period, for the term of the License Agreement.

#### **CONCLUSION:**

Staff recommends that the City Council authorize the City Manager to execute a Non-exclusive License Agreement (Attachment "A" – Contract No. 1846) with Neighborhood Junior Tennis Program (NJTP) to grant access to office space at Recreation Park.

# **NON-EXCLUSIVE LICENSE AGREEMENT**

# **Neighborhood Junior Tennis Program**

NON-EXCLUSIVE LICENSE AGREEMENT (Parties: City of San Fernando and NJTP)

(Facility: Office Space at Recreation Park, 208 Park Ave, San Fernando, CA)

THIS 2017 NON-EXCLUSIVE LICENSE AGREEMENT ("Agreement") is made and entered into this 4th day of April 2017 ("Effective Date") by and between the CITY OF SAN FERNANDO, a municipal corporation ("CITY") and NEIGHBORHOOD JUNIOR TENNIS PROGRAM (NJTP), a non-profit organization. For purposes of this Agreement the capitalized term "Parties" shall be a collective reference to both CITY and NJTP/SCTA. The capitalized term "Party" may refer to either CITY or NJTP/SCTA interchangeably.

# **RECITALS**

This AGREEMENT is made and entered into with respect to the following facts:

WHEREAS, CITY is the owner of certain real properties located on 208 Park Avenue and 828 Harding Ave, San Fernando, CA 91340, commonly referred to as Recreation Park and Pioneer Park (hereinafter, the "Properties"); and

WHEREAS, the Properties include a multi-use recreation facilities (hereinafter, the "Facilities"); and

WHEAREAS, the Facility includes a 100 square foot room at Recreation Park commonly referred to as the "ENP Office" (hereinafter, the "Office"); and

WHEAREAS, the Facility includes two 2,106 square foot tennis courts facilities at Pioneer Park commonly referred to as the "Pioneer Tennis Courts" (hereinafter, the "Courts"); and

WHEREAS, the NJTP wishes to use the Facilities on an intermittent and non-exclusive basis for the purpose of conducting administrative and operational functions for the sport programs they conduct in the CITY; and

WHEREAS, this Agreement is intended to confer upon NJTP a license for the use of Facilities and to set forth the reciprocal duties and obligations of the Parties and the terms, conditions and restrictions governing NJTP's use of Facilities.

### NOW THEREFORE, THE PARTIES AGREE AS FOLLOWS:

# <u>AGREEMENT</u>

#### SECTION 1. GRANT OF LICENSE AND TERMS OF USE

# A. Grant of License to Use Facilities

- i. Grant of License. Subject to the terms and conditions set forth under this Agreement, CITY hereby grants to NJTP a non-exclusive license to access and use the Facilities for the limited purposes set forth in Exhibit "A" which is attached and incorporated hereto by this reference. The forgoing notwithstanding, the Parties acknowledge, understand and agree that the use of Facilities authorized under this Agreement shall be subordinate to the use of the Facilities as public office space.
- ii. <u>Term</u>. This Agreement shall have an initial term of Three (3) year commencing from the Effective Date ("Term"). City in its sole and absolute discretion may authorize Two (2) extension terms of one (1) additional year commencing upon the expiration of the initial Term. The foregoing notwithstanding, nothing in this subsection shall operate to prohibit or otherwise restrict CITY right to terminate this Agreement at an earlier date as provided under this Agreement.

# iii. <u>General Terms of Use</u>.

- a. <u>Facility Access</u>. NJTP shall be authorized to access the Facilities during "normal hours of operation" that currently include being open between 8:00 a.m. and 10:00 p.m., Monday through Friday, and open from 8:00 a.m. to 5:00 p.m. on weekends.
- b. <u>Limitations of Use</u>. NJTP may not use the Facilities for any other use other than those set forth in Exhibit "A". NJTP's use of the Properties does not encompass the use of offices, other rooms, or facilities within on the Properties. NJTP shall not permit unauthorized persons onto the Properties and shall not allow any persons other than CITY personnel and NJTP's personnel and program participants to enter Room while it is being used by NJTP. NJTP shall not restrict CITY's authorized personnel from accessing the Room at any time.
- c. <u>Facility Improvements.</u> NJTP to make all physical improvements to office space needed to initiate operation at their sole expense;
- d. <u>Maintenance of Room</u>. After each days use of the Room, NJTP will collect all equipment and materials belong to NJTP and leave the room in a neat,

- clean and orderly condition. In addition, NJTP is to adhere to City of San Fernando Facility Rental and Usage Terms (Exhibit "B").
- e. <u>Consideration for Use of Room by NJTP</u>. In consideration for CITY's grant of a license to <u>NJTP</u> to use the Office, <u>NJTP</u> shall pay to CITY a monthly fee of \$225 (hereinafter, the "License Fee").
  - NJTP is to maintain an active 501 (c)3 Non-profit status and actively seek additional funding sources to provide monies to offset any costs the City may be incurring in this scope of work in this agreement.
  - ii. NJTP shall provide the Director of Recreation and Community Services a monthly activity report containing a summary of all students enrolled and donations collected for activities described in the scope of work.

#### SECTION 2. INDEMNIFICATION

NJTP shall indemnify, defend with counsel approved by CITY, and hold harmless CITY and CITY's elected and appointed officials, officers, employees, agents and volunteers from and against all liability, loss, damage, expense, cost (including without limitation reasonable attorney fees, expert fees and all other costs and fees of litigation) of every nature arising out of or in connection with (i) NJTP's use of the Room; and (ii) NJTP's performance or non-performance of any of its duties and obligations under this Agreement or NJTP's failure to comply with any of its obligations under the same. The foregoing duty to indemnify, defend and hold harmless shall not embrace liability, losses, damages, expenses, costs which is caused by the sole negligence or willful misconduct of CITY. Should conflict of interest principles preclude a single lawyer from representing both CITY and NJTP, or should CITY otherwise find NJTP'S legal counsel unacceptable, then NJTP shall reimburse the CITY its costs of defense, including without limitation reasonable attorney fees, expert fees and all other costs and fees of litigation. The NJTP shall promptly pay any final judgment rendered against the CITY (and its officers, officials, employees and volunteers) covered by this indemnity obligation. It is expressly understood and agreed that the foregoing provisions are intended to be as broad and inclusive as is permitted by the law of the State of California and will survive termination of this Agreement.

#### **SECTION 3. INSURANCE.**

- A. NJTP shall procure and maintain the following insurance coverage, at its own expense, for the duration for this Agreement or any extended period set forth herein:
  - i. Workers' Compensation Insurance Employer's Liability Insurance. NJTP shall procure and maintain Workers' Compensation Insurance affording coverage at least as broad as that required by the State of California with Employer's Liability Insurance with minimum limits of no less than One Million Dollars (\$1,000,000.00)

per accident for bodily injury or disease. The Workers' Compensation insurer shall also agree to waive all rights of subrogation against CITY and CITY's elected and appointed officials, officers, employees, agents and volunteers for losses paid under the terms of the insurance policy. Workers' Compensation insurance shall also provide or be endorsed to provide; there will be no cancellation, suspension, reduction or voiding of coverage without thirty (30) calendar days prior written notice by certified mail, return receipt requested, to CITY. If any reduction of coverage occurs, NJTP shall furnish CITY with information regarding such reduction at NJTP's earliest possible opportunity and in no case later than five (5) calendar days after PCS is notified of the change in coverage. Any failure to comply with reporting or other provisions of the policy, including breaches of warrants, shall not affect the coverage provided to CITY and CITY 's elected or appointed officials, officers, employees, agents or volunteers.

- B. All varieties of insurance required under this Agreement shall be procured from insurers admitted in the State of California and authorized to issue policies directly to California insureds. Except as otherwise provided elsewhere under this Section, all required insurance shall be procured from insurers, who according to the latest edition of the Best's Insurance Guide have an A.M. Best's rating of no less than A;VII. CITY may also accept policies procured by insurance carriers with a Standard & Poor's rating of no Insurance Employer's Liability Insurance, CITY may authorize less than BBB according to the latest published edition the Standard & Poor's rating guide. As to Workers' Compensation lower ratings than those set forth in this Section.
- C. With respect to all varieties of insurance required under this Section, all deductibles and self-insured retentions shall be declared to and approved by CITY. CITY, at its option and in its sole and absolute discretion may require that: (i) the insurer reduce or eliminate such deductibles or self-insured retentions as respects CITY and CITY's elected or appointed officials, officers, employees, agents and volunteers; or (ii) NJTP shall provide a financial guarantee satisfactory to CITY guaranteeing payment of losses and related investigations, claim administration and defense expenses.
- D. If any of the required insurance coverages contain aggregate limits, or apply to other operations of NJTP not related to this Agreement, NJTP shall give CITY prompt, written notice of any incident, occurrence, claim settlement or judgment against such insurance which may diminish the protection such insurance affords NJTP, CITY and CITY's elected and appointed officials, officers, employees, agents and volunteers. NJTP shall also immediately restore such aggregate limits or shall provide other insurance protection for such aggregate limits. CITY may, at its option, specify a minimum acceptable aggregate for each line of coverage required. NJTP shall not make any substantial reductions in scope of coverage which may affect CITY's protection without CITY's prior written consent.

- E. All varieties of insurance required under this Section shall contain standard separation of insureds provisions. In addition, such insurance shall not contain any special limitations on the scope of protection afforded to CITY and CITY's elected or appointed officials, officers, employees, agents or volunteers.
- F. All polices of insurance provided by NJTP shall be primary to any coverage available to CITY or CITY 's elected or appointed officials, officers, employees, agents or volunteers. Any insurance or self-insurance maintained by CITY or CITY's elected or appointed officials, officers, employees, agents or volunteers shall be in excess of NJTP's insurance and shall not contribute with it.
- G. No policy of insurance or endorsement thereto that is procured by NJTP pursuant to this Section shall allow (either expressly or by the omission of any express prohibition) any insurance carrier to seek subrogation from CITY or CITY 's elected or appointed officials, officers, employees, agents or volunteers for any sums paid by the insurance carrier on behalf of NJTP or NJTP's subcontractors or sub consultants or on behalf of CITY or CITY 's elected or appointed officials, officers, employees, agents or volunteers. All policies of insurance required under this Section shall contain provisions waiving or shall be endorsed to waive any subrogation rights or other like rights of recovery by the insurance carrier against CITY or CITY 's elected or appointed officials, officers, employees, agents and volunteers for any sums paid on behalf NJTP or NJTP's contractors, subcontractors or subconsultants or on behalf of CITY or CITY 's elected or appointed officials, officers, employees, agents or volunteers by the insurance carrier. The CITY Representatives may waive this requirement as to CGL Coverage but only upon NJTP's delivery to CITY of endorsements demonstrating that CITY and CITY's elected or appointed officials, officers, employees, agents and volunteers have been named as additional insureds under the CGL Coverage.
- H. NJTP acknowledges, understands and agrees that CITY's ability to verify the procurement and maintenance of the insurance required under this Section is critical to safeguarding CITY's financial well-being and, indirectly, the collective well-being of the residents of the CITY of San Fernando. Accordingly, NJTP warrants, represents and agrees that its shall furnish CITY with original certificates of insurance and endorsements evidencing the coverage required under this Section on forms satisfactory to CITY in its sole and absolute discretion. The certificates of insurance and endorsements for each insurance policy shall he signed by a person authorized by that insurer to bind coverage on its behalf, and shall be on forms provided by the CITY if requested. All certificates of insurance and endorsements shall be received and approved by CITY as a condition precedent to NJTP's commencement of any work or any of the Services. NJTP shall also provide CITY with certified copies of all required insurance policies as a condition precedent to the commencement of any work or any of the Services. CITY shall not, and shall be under no obligation to, issue a Notice to Proceed until NJTP fully complies with this Section. The

requirements of this Section cannot be waived and any attempted waiver shall be void, invalid and non-binding upon CITY.

- I. All polices of insurance required by this Agreement shall contain an endorsement providing that the policies cannot be canceled or reduced except upon thirty (30) calendar days' prior written notice to CITY. NJTP agrees to require all its insurers to modify the certificates of insurance to delete any exculpatory wording stating that the failure of the insurer to mail written notice of cancellation imposes no obligation, and to delete the word "endeavor" with regard to any notice provisions.
- J. In addition to any other remedies CITY may have under this Agreement or at law or in equity, if NJTP fails to comply with any of the requirements set forth in this Section, CITY may, but shall not be obligated to: (i) immediately suspend NJTP's permission to engage in any of the uses or activities authorized under this Agreement; or (ii) terminate this Agreement. CITY 's exercise of any of the foregoing remedies, shall be in addition to any other remedies CITY may have and is not the exclusive remedy for NJTP's to failure to comply with the insurance requirements set forth under this Section.
- K. NJTP shall include all persons and entities performing work on its behalf as insureds (including all contractors, subcontractors and subconsultants) or, in the alternative, shall furnish separate certificates of insurance and endorsements for each such persons or entities evidencing their independent procurement of insurance. All coverages for such persons or entities shall be identical to the requirements imposed upon NJTP under this Section.
- L. NJTP 's procurement of insurance shall not be construed as a limitation of NJTP's liability or as full performance of NJTP's indemnification duties set forth under this Agreement.

# SECTION 4. TERMINATION FOR CONVENIENCE AND FOR CAUSE.

A. <u>Termination for Convenience</u>. The Term of this Agreement notwithstanding, either Party may terminate this Agreement for convenience and without cause or penalty upon fifteen (15) days' prior written notice from the terminating Party to the non-terminating Party.

# B. <u>Termination for Cause</u>.

i. In the event either Party fails to perform any duty, obligation, service or task set forth under this Agreement (or fails to timely perform or properly perform any such duty, obligation, service or task set forth under this Agreement), an event of default (hereinafter, "Event of Default") shall occur. For all Events of Default, the Party alleging an Event of Default shall give written notice to the defaulting Party (hereinafter referred to as a "Default Notice") which shall specify:

- a. the nature of the Event of Default;
- b. the action required to cure the Event of Default;
- c. the date by which the Event of Default shall be cured, which date shall not be later than the period allowed by applicable cure period set forth under subsection 4.B.2, below.

The Event of Default shall constitute a breach of this Agreement if the defaulting Party fails to cure the Event of Default within the applicable cure period or any extended cure period allowed under this Agreement.

- ii. NJTP shall cure the following types of Events of Defaults within the following time periods:
  - a. Within twelve (12) hours of CITY's issuance of a Default Notice for any failure of NJTP to routinely clean the Room after use in the manner contemplated under this Agreement;
  - b. Within twenty-four (24) hours of CITY's issuance of a Default Notice for any failure of NJTP to timely pay any monetary sums owed to CITY at the time specified in this Agreement or by law. Except as provided under this preceding sentence, CITY shall be under no obligation to entertain any request by NJTP for additional time to pay any monetary sums owed to CITY.
  - c. Within fifteen (15) days of CITY's issuance of a Default Notice for any other Event of Default under this Agreement. Prior to the expiration of the cure periods prescribed under this subsection, NJTP may submit a written request for additional time to cure the Event of Default upon a showing that NJTP has commenced efforts to cure the Event of Default and that the Event of Default cannot be reasonably cured within the cure period. The foregoing notwithstanding, CITY shall be under no obligation to grant additional time for the cure of an Event of Default under this subsection that exceeds fifteen (15) calendar days from the end of the initial applicable cure period.

The foregoing notwithstanding, NJTP's failure to allow authorized CITY personnel with access to the Room shall constitute an immediate Event of Default and must be cured immediately upon verbal or written notice to NJTP by such CITY personnel. The failure to provide such immediate access upon verbal or written demand of the CITY shall constitute a breach of this Agreement.

iii. CITY shall have thirty (30) days from the date NJTP issues a Default Notice to cure any Event of Default, unless the Event of Default cannot reasonably be cured within the 30-day cure period. CITY shall be granted an additional thirty (30) calendar days to cure any Event of Default upon CITY's written request for such an extension of time and CITY's demonstration that it has commenced the

cure of the Event of Default. Alternatively, CITY may at any time during the initial 30-day cure period submit a written objection to the Default Notice along with any written declarations or other evidence which disprove or rebut the assertions in the Default Notice. In the event CITY and NJTP are unable to agree as to whether or not an Event of Default on the part of CITY has occurred or whether CITY's proposed cure will adequately cure the Event of Default, NJTP shall either waive the Event of Default in writing or issue a written notice declaring the CITY to be in breach of the Agreement. NJTP shall have no authority to issue a breach notice to CITY prior to the earlier of the following: (a) the expiration of CITY's initial 30-day cure period or any additional 30-day cure period invoked by CITY; or (b) CITY's issuance of a written objection to the Default Notice. In the event CITY is in breach of this Agreement, NJTP's sole remedy shall be the termination this Agreement.

- iv. No waiver of any Event of Default or breach under this Agreement shall constitute a waiver of any other or subsequent Event of Default or breach. No waiver, benefit, privilege, or service voluntarily given or performed by a Party shall give the other Party any contractual rights by custom, estoppel, or otherwise.
- v. The rights and remedies available to CITY hereunder shall be in addition to and not a limitation of any rights and remedies available to CITY at law. In addition to any other remedies available to CITY at law or under this Agreement in the event of any breach by NJTP, CITY, in its sole and absolute discretion, may also pursue any one or more of the following remedies:
  - a. Terminate this Agreement and revoke the license conferred herein for cause. Under such circumstance CITY may immediately order NJTP, NJTP's personnel and program participants to vacate the Room, the Facility and/or the Property; or
  - b. CITY may agree to some mutually acceptable alternative resolution of the breach with NJTP, provided such resolution is memorialized in writing; or
  - c. CITY may proceed by appropriate court action to: (a) enforce the terms of the Agreement; (b) obtain enforcement of the provisions of this Agreement; (c) obtain declaratory relief; and/or (d) seek recovery for any damages or other losses suffered by CITY as a result of NJTP's breach of this Agreement; or
  - d. The CITY may exercise such other rights or remedies as may be available to it at law or in equity.

vi. <u>Suspension of License</u>. Concurrent with, or as an alternative to, CITY's initiation of the Default Notice process or the issuance of a notice of intent to terminate this Agreement, CITY may also suspend NJTP's permission to access and use the Room for a period of one (1) or more days for any Event of Default. The term of this Agreement shall not be tolled during any suspension period. Nothing in this subsection shall operate to prohibit or otherwise restrict the ability of CITY to commence proceedings for the termination of this Agreement and the license conferred hereunder during any suspension period or concurrent with the initiation of suspension proceedings.

#### SECTION 5. MISCELLANEOUS.

A. <u>Notices</u>. Except as otherwise specifically set forth and allowed under this Agreement, all notices herein required to be given or which may be given by either Party to the other shall be deemed to have been fully given when served personally on CITY or NJTP, or when made in writing and deposited in the United States Mail, certified mail, return receipt requested, postage prepaid and addressed as follows:

- B. This Agreement shall be construed by, and in accordance with, the laws of the State of California.
- C. Whenever the singular number is used in this Agreement and when required by the context, the same shall include the plural and the masculine gender shall include the feminine and neuter genders.
- D. This instrument contains all of the agreements and conditions entered into and made by and between the Parties and may not be modified orally, or in any manner, other than by an agreement in writing signed by all the Parties hereto or their respective successors-in interest.

- E. Time is, and shall be, of the essence for each term and provision of this Agreement.
- F. Each and every term, condition, covenant and provision of this Agreement is and shall be deemed to be a material part of the consideration for CITY's entry into this Agreement and any breach hereof by NJTP shall be deemed to be a material breach. Each term and provision of this Agreement performable by NJTP shall be construed to be both a covenant and a condition.
- G. The headings of the several paragraphs and sections of this Agreement are inserted only as a matter of convenience and for reference and in no way define, limit or describe the scope or intent of any provisions of this Agreement and shall not be construed to affect in any manner the terms and provisions hereof or the interpretation or construction thereof.
- H. In the event any covenant, condition or provision herein contained is held to be invalid by a court of competent jurisdiction, the invalidity of any such covenant, condition or provision shall in no way affect any other covenant, condition or provision herein contained, provided the invalidity of any such covenant, condition or provision does not materially prejudice either CITY or NJTP in its respective rights and obligations contained in the valid covenants, conditions and provisions of this Agreement.
- I. All exhibits and addenda referred to herein, and any exhibits or schedules which may from time to time be referred to in any duly executed amendment hereto, are by such reference incorporated herein and shall be deemed a part of this Agreement as if set forth fully herein.
- J. This Agreement shall be interpreted and construed only by the contents hereof, and there shall be no presumption or standard of construction in favor of or against either Party.

#### (NJTP Scope of Work)

#### Overview:

The purpose of this proposal is to secure a sustainable partnership between the City of San Fernando (City) and the National Junior Tennis Program (NJTP) to develop year-round tennis training and competition for both children and adults. Both parties have valuable resources when combined can create a cost neutral community program.

To accomplish this, the NJTP is proposing year-round tennis and competitions in City facilities for both children and adults allowing them to develop both mentally and physically while enjoying the sport of tennis with other residents.

#### **Details:**

The City and NJTP will work together towards the development and implementation of strategies and programs that address issues of common interest and concern, within each organization's respective mission, exchange ideas, and share best practices in the delivery of high quality, cost-effective local sports venues for NJTP program participants.

#### 1. Programming:

- a. The City will allow the NJTP to schedule programming as they deem necessary to provide service to the community of San Fernando.
- b. The CITY does retain the right to schedule events and or programming at the Pioneer Park Tennis Courts.
- c. Any programs the CITY schedules will be provided to the NJTP well in advance of any changes as to not cause conflict with NJTP programming.
- d. NJTP is aware that the CITY allows the Special Olympics access to the courts on Sundays for programming. In the event those days change the city will notify NJTP.

#### 2. Promotion and Marketing:

- a. The City and NJTP will promote organizational collaboration to each of their affiliates. In addition, the City will encourage individuals to register with NJTP's network to ensure they are notified of any and all tennis opportunities.
- b. The City will promote NJTP opportunities among its City partners and staff.
- c. The City and NJTP will work to publicize this relationship to their respective constituents to further increase public awareness towards the mission of providing tennis opportunities to residents.

- d. The City and NJTP will exchange relevant publications, bulletins, and other information on a regular basis for education and the stimulation of innovative ideas and approaches to providing tennis oppollunities to residents.
- e. Neither party shall use the other party's name, logo, or any other mark without that party's prior written consent and/ or advance approval.

#### 3. Scheduling/ Court Use:

- a. The City and NJTP shall work together during the biannual sport field allocation meetings to determine and resolve facility use needs.
- b. The City will provide the NJTP facility keys to access the courts during preapproved times.
- c. The City will provide NJTP with dates and times in advance for any city related facility use.
- d. The City will provide facility staff if requested for and Regional or State Competition.

#### 4. Facility

- a. The NJTP will maintain the tennis courts at their own expense upon implementation of this agreement. The CITY will continue to maintain the fencing and landscaping surrounding the courts. Additionally the CITY will ensure the operation of the drinking fountain at the main gate of the tennis courts.
- b. All maintenance and upgrades within the fencing will be the financial responsibility of the NJTP. Prior to implementing any upgrades the NJTP must provide the CITY with a detailed plan. The CITY must provide approval of any and all upgrades or modifications to the tennis courts.

**EXHIBIT "B"** 

#### **RENTAL AND USAGE TERMS**

- 1. NJTP further states that, to the best of his/her knowledge, the CITY property, for use of which application is hereby made, will not be used for the commission of any act intended to further any program or movement the purpose of which is to accomplish the overthrow of the Government of the United States by force, violence or other unlawful means.
- 2. Agreement is only good for activities and times stated. Any additional activities and/or hours will require submission of appropriate application.
- 3. The use and/or advertising of drugs, alcohol or tobacco products are **NOT ALLOWED AT ANY TIME** on or in CITY facilities. **NO SMOKING** is allowed on or in CITY facilities. Betting and/or other forms of gambling is **NOT ALLOWED**.
- 4. Responsible adults (21 years or older) must be present AT ALL TIMES when a group of minors are using the facilities.
- 5. NJTP League shall have a copy of this agreement available on site at all times.
- 6. Arrival of set party **shall not** be earlier than set time on the application. Departure of set party **shall not exceed** set time on application. Set-up/Clean-up time <u>MUST</u> be accounted for in the set time of the contract. A penalty charge **will be assessed** if arrival is earlier or if departure is later than set time.
- 7. Persons in attendance shall restrict their activities to those facilities, or portions thereof, their application entitles them. Failure to comply may result in the termination of the event.
- 8. There will be **no storage provided**. Items/articles **CAN NOT BE LEFT PRIOR** to the event nor **AFTER** the event (ex. food, decorations, etc.). The CITY is not responsible for any personal items/articles lost, stolen, or misplaced.
- 9. Upon the conclusion of the event, the agent and/or the organization must leave the facilities in the **same condition** as found. Such condition to be determined by an authorized representative. Failure to comply will result in forfeiture of damage/cleaning deposit and may result in a penalty fee if time exceeds contract time. If the League leaves the facilities in same conditions as found a \$250 credit will be applied to the yearly impact fee invoice.
- 10. Keys can only be used during permit hours. All keys shall be returned upon expiration of permits. Failure to return keys shall result in a fee for key replacement and may result in a fee for re-keying of facilities.
- 11. NJTP and/or their representatives shall maintain a civil attitude, mutual respect and team cooperation at all times. Failure to do so may result in revocation of permit.

- 12. NJTP and/or their representatives shall promptly report any deficiencies of facilities or service requests to the Recreation and Community Services Department at (818) 898-1290.
- 13. NJTP and/or their representatives shall arrive with sufficient amount of time to inspect facilities and allow for repairs.
- 14. Any repair inquiries must be placed to the Recreation and Community Services main office no later than 1:00 p.m. and will be forwarded to the CITYS Public Works Department that same day. The following is the contact information for the main office:

#### **RECOMMENDATION:**

It is recommended that the City Council:

- a. Approve the proposed Side Letter of Agreement (Attachment "A" Contract No. 1789(a)) to the existing Memorandum of Understanding (MOU) with the San Fernando Police Officers' Association (SFPOA); and
- b. Authorize the City Manager to make non-substantive corrections and execute all related documents.

#### **BACKGROUND:**

- 1. In July 2015, the City and SFPOA executed a four year MOU for the term of July 1, 2015 through June 30, 2019 (Contract No. 1789).
- 2. For the last few years, the Police Department has been experiencing staffing shortages in the ranks of the sworn classifications, which has presented scheduling difficulties when authorizing leave time and meeting minimum deployment requirements.
- 3. In March 2017, the City and SFPOA met and conferred in good faith and tentatively agreed to modify Article 4.02 of the MOU regarding holiday leave.

#### **ANALYSIS:**

Due to the persistent staffing shortage being experienced by the Police Department (currently 4 of the 31 total allocated positions [13%] are vacant), it has been difficult to grant time off to sworn officers while still maintaining minimum deployment requirements. Whenever a sworn

officer is granted time off, the City has to pay overtime to another sworn officer to ensure minimum deployment requirements are met.

Under Article 4.02 of SFPOA's current MOU, sworn officers accrue 48 hours of holiday leave bank every six months, i.e. in January and July. If the officer does not take 48 hours off in the six month period, they are not awarded a new 48 hour leave bank. Consequently, many Officers are taking time off so they do not lose their holiday leave bank hours. As a result, the City incurs additional overtime costs in order to backfill vacation time.

SFPOA approached the City to work toward a resolution that benefits both the City and unit members. Unit members proposed amending the holiday provision of the existing MOU to pay out 3.69 hours per pay period (96 hours/26 pay periods) for holiday in-lieu hours. By paying out the holiday bank every pay period as holiday in-lieu rather than forcing employees to take time off to avoid losing holiday bank hours, the City should realize some savings from reduced overtime costs to backfill vacation time.

The Side Letter Agreement contains the following terms:

1. Effective beginning July 1, 2017 and for the duration of the MOU, Article 4.02 of the MOU is hereby amended to read as follows:

The City recognizes the following holidays:

- New Year's Day
- Martin Luther King, Jr. Birthday
- Lincoln's Birthday
- Washington's Birthday
- Cesar Chavez' Birthday
- Memorial Day

- Independence Day
- Labor Day
- Columbus Day
- Veterans' Day
- Thanksgiving Day
- Christmas Day

Employees shall, in lieu of being given the above holidays as paid time off, be compensated each biweekly pay period for 3.69 hours at the employee's regular rate of pay. Any remaining holiday leave accrued prior to July 1, 2017 may be taken as paid time off, subject to a supervisor's approval, or cashed-out at the employee's regular hourly rate of pay upon separation.

2. Effective beginning July 1, 2019, Article 4.02 of the MOU shall revert to the language as presented in the original MOU (Contract No. 1789), unless it is expressly extended or otherwise amended by the parties in writing.

#### **BUDGET IMPACT:**

It is expected that, by paying out the holiday bank every pay period as holiday in-lieu rather than forcing employees to take time off to avoid losing holiday bank hours, the City will realize some savings from reduced overtime costs to backfill vacation time. Holiday in-lieu pay is not a PERS-able form of income.

#### **CONCLUSION:**

The proposed amendment to the existing MOU between the City and SFPOA represents a fair compromise that does not force employees to take time off (or risk losing holiday bank hours) and will save the City additional overtime costs.

#### **RECOMMENDATION:**

It is recommended that the City Council:

- a. Approve a Change Order to the Purchase Order with Galpin Ford Motors, Inc. (Galpin Ford) to purchase one (1) additional 2016 Compressed Natural Gas (CNG) Ford F-250 Utility Body Truck with Aluminum Service Body (Attachment "A"), in the amount of \$46,434.85; and
- b. Authorize the Interim City Manager to execute the Purchase Order; and
- c. Designate Unit No. PW-3322 as surplus City-owned personal property; and
- d. Authorize the Interim City Manager to dispose of said surplus City-owned personal property in accordance with Chapter 2, Article VI, Division 7, of the City of San Fernando Municipal Code.

#### **BACKGROUND:**

- 1. In 1991, the State passed Assembly Bill 2766 that, in part, provides local governments with annual funding from the Air Quality Management District (AQMD) to implement programs that reduce air pollution from motor vehicles.
- 2. AB 2766 Subvention Funds must be used to develop programs or purchase equipment that promote the reduction of motor vehicle emissions, which includes purchasing alternative fuel fleet vehicles to replace traditional gas or diesel fueled fleet vehicles.
- Funding was including in the fiscal year (FY) 2015-2016 Budget to purchase two CNG fueled Public Works operations trucks with AB 2766 AQMD funds to replace existing aging vehicles in the City's fleet.

4. In April 2016, Public Works Equipment Maintenance staff requested bids for two Utility Body Trucks from three vendors: Galpin Ford, Altec and Wonderies Ford. From the bids received (Attachment "B"), Galpin Ford provided the most competitive bid with two CNG fueled F-250 Utility Body Vehicles at a total cost of \$46,437.50 per vehicle. Subsequently, the City Council approved a purchase order with Galpin Ford for the purchase of two CNG trucks.

#### **ANALYSIS:**

In November 2016, Galpin Ford notified Public Works staff that an additional 2016 CNG Ford F-250 Utility Body Truck (UBT) was available for immediate purchase. Since the City had recently purchased two 2016 F-250 UBTs from Galpin Ford at a cost of \$46,434 per vehicle, they offered to honor the same cost for the new truck if the City decided to purchase it.

The new CNG truck will replace a gas fueled 1985 Chevrolet G30 Bus with 89,935 miles, which meets the requirements for using AB 2766 AQMD funds. Replacing the vehicle will reduce overall vehicle maintenance costs and improve fuel efficiency within the City's fleet. Additionally, the new truck will be available for use on a variety of tasks within the Public Works Department.

The new truck will primarily be used by the Facilities Management Division to conduct day-to-day operational activities. Below is a brief description of the vehicle that is being recommended for replacement due to age, condition, and mileage.

Unit No. PW-3322 is a utility bus used in Public Works operations activities. This vehicle is approximately 32 years old and has reached the end of its useful life for maintenance and operations functions.

#### New Vehicle Purchase

The proposed replacement truck is a 2016 Ford F-250 CNG Utility Body Truck, providing the City with a fully functional aluminum service body. The proposed truck is of similar design to those used in several neighboring cities for similar work functions and is fueled by compressed natural gas. The vehicle meets the requirements for use of AQMD funds, helps in the reduction of greenhouse gas emissions, and will reduce ongoing vehicle maintenance costs.

#### **Bid Process**

Since the City awarded a competitively bid contract to Galpin Ford for the same vehicle within the last 12 months, and Galpin Ford is offering the vehicle at the same competitively bid price, staff proposes waiving the formal bidding process and issuing a change order to the April 2016 Purchase Order to add one (1) additional 2016 CNG Ford F-250 Utility Body Truck.

#### Schedule

There is an estimated lead time of 90 days for Galpin Ford to prepare truck for delivery. Based on this, delivery is expected in July 2017.

#### **BUDGET IMPACT:**

The total cost for the 2016 CNG Ford F-250 Utility Body Truck is \$46,434.85, including taxes and fees. Sufficient funding for the proposed purchase is included in the AQMD fund in the FY 2016-2017 Budget.

#### **CONCLUSION:**

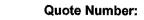

#### **RECOMMENDATION:**

It is recommended that the City Council:

- a. Determine it is in the City's best interest to waive formal bidding requirements;
- b. Authorize the City Manager to execute a purchase agreement with Galpin Motors, Inc. for the purchase of two (2) Compressed Natural Gas (CNG) Ford F-250 Utility Body Trucks with Aluminum Service Body, in an amount of \$92,876 (Attachment "A"); and
- c. Designate Unit Numbers PW-4464 and EL-2073, as surplus property and authorize the City Manager to dispose of surplus properties and sale.

#### **BACKGROUND:**

During the preparation of the City's Fiscal Year 2016 budget, funding was included for the purchase of two (2) new compressed natural gas (CNG) operations trucks to replace existing aging vehicles in the City's fleet. The new trucks will replace two (2) severely outdated trucks; one twenty-six (26) years old and the other twenty-two (22). Replacing the vehicles will greatly reduce vehicle maintenance costs and improve fuel efficiency within the City's fleet. Additionally, the new trucks will be available for a variety of tasks in the Public Works Department and ensure a prompt response to emergency situations.

#### **ANALYSIS:**

Each fiscal year the City receives a monetary disbursement from the Air Quality Management District (AQMD) through AB 2766. Since 1991, local governments have received AB 2766 funds to implement programs that reduce air pollution from motor vehicles. A Motor Vehicle Registration fee surcharge of \$6 per vehicle is collected by the Department of Motor Vehicles

and granted to the SCAQMD for disbursement. Four dollars of the registration fee is shared between four different entities with 40 percent of the funds going to local governments through the AB 2766 Subvention Program.

It is required that Subvention Funds be used to purchase equipment that promotes motor vehicle emission reduction or projects that result in the reduction of motor vehicle emissions. The purchase of two (2) CNG utility body trucks to replace two aging vehicles in the City's fleet meets this stated requirement. The new trucks will be used by both the Streets and Electrical Divisions to conduct day-to-day operational activities. Below is a brief description of the vehicles that are being recommended for replacement due to age, condition, and mileage.

**Electrical Truck** 

Unit #PW-4464 is a utility truck used in public works operations activities. This vehicle is approximately twenty-six (26) years old and has reached the end of its useful life for maintenance and operations functions. Unit EL-2073 is a utility truck used in public works electrical operations activities. This vehicle is approximately twenty-two (22) years old and has also reached the end of its useful life for operations functions.

#### New Vehicles Purchase

The proposed replacement trucks are both 2016 Ford F-250 CNG Utility Body Trucks, providing the City with a fully functional aluminum service body. The proposed trucks are of similar design to those used in several neighboring cities for similar work functions and are fueled by compressed natural gas (CNG). These vehicles meet the requirements for the use of AQMD funds, help to reduce greenhouse gas emissions, and will reduce ongoing vehicle maintenance costs.

#### **Bid Process**

In April 2016, Public Works Equipment Maintenance staff requested bids from three (3) vendors; Galpin Ford, Altec and Wonderies Ford. Bids were received from both Galpin Ford and Altec, while no response was received from Wondries Ford. The bids received are summarized below:

#### **Schedule**

There is an estimated lead time of 90 days for Galpin Ford to prepare trucks for delivery. Based on this, delivery is expected in September 2016.

#### **BUDGET IMPACT:**

Funding for the proposed expenditure is available in the City's approved Fiscal Year 2016 budget within the Public Works Department's— Special Fund: Air Quality Management District (AQMD) Fund 16.

#### **CONCLUSION:**

The proposed vehicles have already been manufactured as CNG vehicles and are ready for purchase immediately. Consequently, time is of the essence to ensure that Galpin Motors does not sell these vehicles to another buyer. Therefore, it is recommended that the City Council determine it is in the City's best interest to waive formal bid requirements and award a purchase order to Galpin Motors, Inc. based on informal quotes.

#### **RECOMMENDATION:**

It is recommended that the City Council adopt Resolution No. 7788 (Attachment "A") amending the Fiscal Year (FY) 2016-2017 Budget to appropriate funds for Executive Recruitment (\$25,000) and Labor Negotiator (\$20,000) services.

#### **BACKGROUND:**

- 1. Effective January 3, 2017, City Manager Brian Saeki resigned from the City of San Fernando to pursue an opportunity with another City.
- 2. In March 2017, staff executed a contract with Bob Murray & Associates to provide Executive Recruitment Services for an amount not-to-exceed \$25,000.
- 3. In March 2017, staff executed a contract with Liebert Cassidy Whitmore to provide Labor Negotiator Services for an amount not-to-exceed \$20,000.
- 4. In April 2017, the City will enter into negotiations with the San Fernando Public Employees' Association (SFPEA) to negotiate a new Memorandum of Understanding (MOU).

#### **ANALYSIS:**

Due to the recent separation of the City Manager, the City has begun the process of recruiting a permanent replacement. In order to ensure that the City is attracting top candidates, Bob Murray & Associates has been engaged to provide a full service executive recruitment process, including, but not limited to, developing a candidate profile and recruitment brochure, interviewing and evaluating candidates, reviewing and recommending top candidates, and negotiating a contract once an offer is made. Bob Murray & Associates has over 20 years of experience and is highly regarded in the executive recruitment industry.

The vacancy in the City Manager position is being filled by the Finance Director on an interim basis until a permanent City Manager is appointed and the Finance Director position is being filled on an interim basis by the City's Accountant. Additionally, the Community Development Director recently left to pursue an opportunity at another City, which required a temporary reorganization of the Community Development Department during the search for an interim replacement.

These staffing changes have impacted key members of the City's labor negotiating team just as the City is set to begin negotiating a new MOU with the San Fernando Public Employees' Association (SFPEA). To provide assistance with the upcoming negotiations, staff has engaged Liebert Cassidy Whitmore (LCW) to provide Negotiator Services, which includes, but is not limited to, reviewing MOU language, attending negotiations with staff, and providing negotiation consultation throughout the process. The City currently uses LCW for labor attorney services and they are highly regarded in the field of municipal labor and employment law.

Since the staffing changes were not anticipated, funds for executive recruitment and negotiator services are not included in the FY 2016-2017 Budget. Both contracts are within the City Manager's administrative authority to execute; however, staff is requesting a budget amendment to appropriate the funds in the FY 2016-2017 Budget.

#### **BUDGET IMPACT:**

In February 2017, staff provided the mid-year budget presentation along with a number of mid-year budget adjustments based on the activity in the first six (6) months of the fiscal year. After accounting for mid-year adjustments, projected General Fund revenues exceed budgeted expenditures by \$214,336 (i.e. there is a slight budget surplus). Adopting the proposed Resolution will reduce the budgeted surplus by \$45,000 to \$169,336. It is prudent to begin the fiscal year with a budget surplus to provide the flexibility to accommodate situations such as this that arise during the budget year.

#### **CONCLUSION:**

Adopting the proposed budget amendments will provide the resources necessary to ensure a top-notch executive recruitment process for the City Manager and assist staff with the upcoming labor negotiations with SFPEA.

I am writing to express the City of San Fernando's support for AB 466, your measure to create the Los Angeles River Tributaries and Watershed Working Group.

The LA River and its tributaries once flowed freely through the LA Basin, winding from the San Fernando Valley to the ocean in Long Beach. The need to control the river's flooding caused the Army Corps of Engineers to line the river and its tributaries with cement; stripping these waterways of their natural beauty. The Pacoima and Tujunga Washes present excellent opportunities to improve community access to parks and the LA River. The health of these streams ultimately improves the health of the broader LA River and the adjacent communities.

#### AB 466 – Los Angeles River Tributaries and Watershed Working Group

#### **SUMMARY:**

This bill would establish a working group for the watershed and tributaries of the Los Angeles River (LA River). This working group would be modeled after the Lower LA River Working Group established in 2014. The group would gather input from local non-profits, the Los Angeles Board of Supervisors, local cities and organizations that work with the Pacoima and Tujunga Washes. The bill aims to establish a group to coordinate interjurisdictional planning for setting conservation goals, developing project proposals, and coordinating funding opportunities.

#### **BACKGROUND:**

The LA River and its tributaries once flowed freely through the Los Angeles Basin, winding from the San Fernando Valley out to the ocean in Long Beach. The need to control the river's flooding drove the Army Corps of Engineers to line the river and its tributaries with cement, stripping these waterways of their natural beauty.

Beginning in the Angeles National Forest, the Pacoima Wash and the Tujunga Wash are two of the largest tributaries to the LA River. These streams funnel a significant amount of the LA River watershed's rainfall to the main River.

Both the Tujunga and Pacoima Washes flow through several low-income and disadvantaged communities that are starving for healthy outdoor park and green space. In recent years, local non-profits and local agencies have started excellent work to improve these waterways through public planning processes and being awarded grants from the state.

The Pacoima Wash and Tujunga Wash represent excellent opportunities to improve community

access to parks and the LA River. The health of these streams ultimately improves the downstream health of the broader LA River and the communities that sit alongside it.

Assembly Bill 466 is an opportunity to provide the planning and logistical resources needed to execute project proposals and to advocate for these two important waterways in the Northeast San Fernando Valley.

#### WHAT THE BILL DOES:

This bill adds a section to the Public Resources Code directing the Secretary of the Natural Resources Agency to appoint a working group in consultation with local agencies, cities, and non-profits that work along these two tributaries of the LA River. This working group will coordinate planning between local governments and non-profits for setting conservation goals, developing project proposals, and identifying funding opportunities.

#### **RESOLUTION NO. 6904**

# A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN FERNANDO, AMENDING THE STANDARD MANAGEMENT PROCEDURE REGARDING USE OF CITY SEAL

WHEREAS, the City Council adopted a standard management procedure for the use of the City seal on August 3, 1987.

WHEREAS, the City Council desires to revise the procedure to limit the use of the City seal, as provided in this resolution.

WHEREAS, it shall be City policy that the City seal, as described in Municipal Code Section 1-13, shall only be used as provided in this policy. The purpose of this policy is to:

- A. Ensure that the City seal is not used for inappropriate events and affairs.
- B. Control use of the City seal so as to prevent unauthorized use, which could imply City participation, support, or sponsorship in commercial, political, or non-City events.

## THE CITY COUNCIL OF THE CITY OF SAN FERNANDO HEREBY FINDS AND RESOLVES:

The City has designated an official seal, which serves to identify City involvement in some manner. Typically, the seal is used on City stationary, City vehicles, brochures and other information. It is important that some guidelines be followed so that the seal be used in an appropriate manner. Therefore, the following guidelines shall be followed pertaining to the City seal:

- 1. The City seal may be used on all City related literature, material, vehicles, etc., and for City sponsored or co-sponsored functions and events.
- 2. The City seal may be used on t-shirts, hats, calendars and other like material when sponsored by the City upon approval of the City Administrator.
- 3. The City seal may not be used by organizations other than the City without prior approval of a majority of the City Council.
- 4. The City seal may not be used for political or commercial purposes.
- 5. In cases where it is unclear whether a proposed use of the seal is appropriate, three members of the City Council must approve the use as a scheduled item on a City Council agenda.

### 'Resist March' to take the place of LA Pride Parade this June

#### **KPCC Staff**

While the L.A. Pride Festival as a whole will go on, a protest march will replace the gay pride festival's annual parade along Santa Monica Boulevard this year. The "Resist March" will start the morning of June 11 at the intersection of Hollywood Boulevard and Highland Avenue, organizers said Tuesday. Instead of cheering colorfully decorated floats, organizers said, attendees will peacefully walk from the starting point to West Hollywood, "where Pride grew up."

Organizers hope the march will become a "living, breathing human monument for human

rights," Brian Pendleton, chairman for Christopher Street West, told KPCC. Christopher Street West is the gay rights nonprofit that organizes the L.A. Pride Festival.

"We want to send a clear message that we want to resist homophobia," Pendleton said. "We want to resist xenophobia and sexism and racism."

The march will not be an anti-Donald Trump rally, Pendleton said. Rather, he added, it will be a chance for anyone beyond the gay/queer community to come together and resist what organizers call the country's "unfavorable discourse" around Muslims, immigrants and women's reproductive rights.

Christopher Street West organized L.A.'s first permitted gay rights parade in 1970, according to the organization's website. In recent years, the parade has embraced a more celebratory tone in light of recent advances in rights for LGBT Americans, Pendleton said.

"For the last eight years, [the gay rights movement] has had the wind in our sails, and we've made some incredible gains," Pendleton said. "And we don't have that now. I think now is the moment for us to refocus and get back to our roots."

A <u>Facebook event</u> had almost 9,000 people saying they will attend, along with 24,000 who say they're interested. Pendleton said that the Resist March was inspired by the success of the Women's March in January and that event's massive turnout.

#### **BACKGROUND:**

- 1. On October 17, 2016, staff provided an update to the City Council regarding a request from the Los Angeles County Board of Supervisors (BOS) that cities in Los Angeles County consolidate their General Municipal Elections on March 7, 2017 with a potential special countywide election to be held on the same day. The BOS would make their final determination whether to call for the special election by December 6, 2016.
- 2. On December 5, 2016, the City Council adopted two resolutions pertaining to the General Municipal Election. The first, Resolution No. 7773, called and gave notice of the election and requested consolidation with the County of Los Angeles (if the County were to hold a special countywide election on the same day). The second, Resolution No. 7774, approved

the submission of a ballot measure to San Fernando voters whether to convert the elected office of City Treasurer into an appointive office.

The City Council also introduced for first reading Ordinance No. 1663, subject to adoption by the electorate, an amendment to the San Fernando Municipal Code and other provisions to reflect the conversion of the elective office of City Treasurer to an appointive office as authorized by the voters of the City.

- 4. On December 6, 2016, the BOS adopted a resolution calling and giving notice of a special countywide election to be consolidated with other elections held on March 7, 2017.
- 5. On March 7, 2017, the Special Countywide Election was held and semi-official results were tabulated (election night tally did not include provisional ballots nor vote by mail ballots that were dropped off at polling places).
- 6. Between March 8–20, 2017, the Los Angeles County Registrar-Recorder/County Clerk (RR/CC) performed an official canvass; outstanding ballots were reviewed, verified and tallied.
- 7. On March 21, 2017, the RR/CC certified the results of the election and issued a Certificate of the Canvass of the Election Returns to each jurisdiction, including the City of San Fernando, detailing the results of the Special Countywide Election (Exhibit "A" to Attachment "A").

#### **ANALYSIS:**

Per Elections Code Section 10262(b), the City Clerk is required to certify the results to the City Council. In turn, the City Council, as required by Elections Code Section 10263, must meet to declare the results of the election. As soon as the result of the election is declared by the City Council, the City Clerk must enter in its records a statement of the election results. Thereafter, the City Clerk must deliver a certificate of election to each person elected and administer the oath of office to each elected official, per Elections Code Section 10265.

#### **BUDGET IMPACT:**

The Fiscal Year 2016-2017 election budget is \$68,200, which will be sufficient to cover the cost of the election.

**WHEREAS,** at the same regular meeting of December 5, 2016 the City Council also approved Resolution No. 7774 which called for the submission of a ballot measure to San Fernando voters to convert the elected office of City Treasurer into an appointed office as authorized pursuant to Government Code Sections 36508 through 36510; and

**WHEREAS,** the City of San Fernando (the "City") conducted the 2017 City Election on Tuesday, March 7, 2017 which was consolidated with the County of Los Angeles held on the same day; and

**WHEREAS,** notice of the 2017 City Election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the Election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form, and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the 2017 City Election was conducted for the purpose of electing two (2) Members of the City Council for the full term of four years and one (1) City Treasurer for the full term of four years. Also to present a City-initiated ballot measure referred to as "2017 Administrative and Election Cost Reduction Measure" to convert the elected office of City Treasurer into an appointed office as authorized pursuant to Government Code Sections 36508 through 36510, and given the ballot measure designation of Measure SF; and

**WHEREAS,** Measure SF presented the following question to San Fernando voters at the 2017 City Election:

**WHEREAS,** pursuant to Elections Code Section 15300 et seq., the Registrar-Recorder/County Clerk for the County of Los Angeles ("County Registrar") canvassed the returns of the Election and has certified the results and issued a Certificate of Canvass of the Election Returns for the 2017 City Election, which is attached hereto as **Exhibit "A"** and is incorporated by this reference as though fully set forth herein.

**WHEREAS,** pursuant to Elections Code Section 10263, upon completion of the canvass and before installing new officers, the City Council must adopt a Resolution reciting the fact of the 2017 City Election and declaring the persons for whom the highest number of votes were cast for each office.

BASED UPON THE ABOVE RECITALS, THE CITY COUNCIL OF THE CITY OF SAN FERNANDO, CALIFORNIA, DOES HEREBY FIND, DETERMINE AND RESOLVE AS FOLLOWS:

- **SECTION 1.** The Recitals stated above are true and correct and incorporated herein by this reference.
- **SECTION 2.** On March 7, 2017, the City undertook the 2017 City Election, which was administered by the County Registrar.
- **SECTION 3.** On March 21, 2017 the County Registrar issued a Certificate of Canvass of the Election Returns for the 2017 City Election (hereinafter, the "2017 Canvass"). A true and correct copy of the 2017 Canvass is attached hereto as **Exhibit "A"** and is incorporated by this reference as though fully set forth herein. Perez, and Gilbert Berriozabal. That the name of the person voted for at the 2017 City Election for City Treasurer was Margarita Solis.
- **SECTION 5.** The names of the candidates for two (2) four-year City Council seats that were up for election were Joel Fajardo and Robert C. Gonzales. Both were re-elected having the most, and second most, votes at the 2017 City Election. Joel Fajardo received 965 votes (34.6%) and Robert C. Gonzales received 848 votes (30.41%). David E. Govea received the third most votes with 325 votes (11.65%). Jason Hayes received the fourth most votes with 268 (9.61%). Marvin R. Perez received the fifth most votes with 196 votes (7.03%). Gilbert Berriozabal received the sixth most votes with 187 (6.70%).

**SECTION 6.** The name of the candidate for one (1) four-year City Treasurer seat that was up for election was Margarita Solis who was re-elected having received 1,130 votes (100%).

**SECTION 7.** At the 2017 City Election, Measure SF was passed and approved by a majority of those voting on the measure, thereby converting the elected office of City Treasurer into an appointed office. City voters approved Measure SF by the following vote count: 953 votes cast in favor and 643 votes cast in opposition out of a total of 1,802 ballots cast.

**SECTION 8.** This Resolution shall take effect immediately upon its adoption by the City Council and the City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.

**SECTION 9.** Pursuant to Elections Code Section 10265, the City Clerk shall immediately sign and deliver to each person elected a Certificate of Election and administer to each person elected the oath of office prescribed in the Constitution of the State of California.

#### ORDINANCE NO. 1663

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN FERNANDO, CALIFORNIA, AMENDING ARTICLE III (OFFICERS AND EMPLOYEES) OF THE SAN FERNANDO MUNICIPAL CODE AND OTHER PROVISIONS TO REFLECT THE CONVERSION OF THE ELECTIVE OFFICE OF CITY TREASURER TO AN APPOINTIVE OFFICE AS AUTHORIZED BY THE VOTERS OF THE CITY OF SAN FERNANDO PURSUANT TO GOVERNMENT CODE SECTION 36508 THROUGH 36510 AT THE CITY'S GENERAL MUNICIPAL ELECTION OF MARCH 7, 2017

**WHEREAS,** pursuant to Government Code Section 36508, at any municipal election, or special election held for that purpose, a city council may submit to the electors the question whether the elective office of City Treasurer shall be appointed by the City Council; and

WHEREAS, at its regular meeting of December 5, 2016, the City Council of the City of San Fernando") approved Resolution No. 7773 ("Resolution No. 7773") which called a General Municipal Election to be held on March 7, 2017 for voters of the City of San Fernando ("City") to elect candidates to fill two (2) City Council seats and to fill the elected City Treasurer seat; and

**WHEREAS,** at the same regular meeting of December 5, 2016 the City Council also approved Resolution No. 7774 which called for the submission of a ballot measure to San Fernando voters to convert the elected office of City Treasurer into an appointed office as authorized pursuant to Government Code Sections 36508 through 36510; and

**WHEREAS,** the San Fernando voters at the City's General Municipal Election of March 7, 2017 approved, by a vote of 953 votes in favor and 643 in opposition, the City ballot measure submitted pursuant to Government Code Sections 36508 through 36510 to convert the elected office of City Treasurer into an appointive office; and

**WHEREAS,** under the term of the ballot measure, the holder of the appointed office of City Treasurer shall serve at the pleasure of the City Manager in the manner and to the extent authorized under Government Code Section 36510, however, the City Council shall reserve the right to vest the appointment authority in itself by the passage of a subsequent ordinance.

# NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SAN FERNANDO, CALIFORNIA DOES HEREBY ORDAIN AS FOLLOWS:

**SECTION 1.** The facts set forth in the recitals above are true and correct.

**SECTION 2.** The current text of Division 4 (City Treasurer) of Article III (Officers and Employees) of Chapter 2 (Administration) of the San Fernando Municipal Code is hereby repealed in its entirety and is now replaced with the following text:

## Division 4 - City Treasurer.

# Sec. 2-191 Appointment of City Treasurer.

- (a) As authorized under Government Code Section 36510, the power to appoint the City Treasurer shall be vested in the City Manager and such appointee shall serve at the pleasure of the City Manager. The foregoing notwithstanding, the City Council, by subsequent ordinance, reserves the right to vest all authority to appoint the City Treasurer in itself to the fullest extent authorized under Government Code Section 36510.
- (b) Pursuant to Government Code Sections 36508 through 36510, San Fernando voters at the City of San Fernando General Municipal Election of March 7, 2017 approved a City-initiated ballot measure which converted the elected office of City Treasurer to an appointive office. In so far as the voters of the City of San Fernando also elected a City Treasurer one final time at the City's General Municipal Election of March 7, 2017, the first appointment to the office of City Treasurer as authorized under subsection (a) of this Section, above, shall be made upon the earlier the of the following: (i) upon the expiration of the term of office of the person elected to serve as City Treasurer at the March 7, 2017 General Municipal Election; or (ii) upon the occurrence of a vacancy by such person prior the expiration of his or her four-year term of office.

# Sec. 2-191 Appointee Qualifications.

- (a) Any person appointed to serve in the capacity of City Treasurer must be an employee of the City who meets such professional qualifications as may be established and from time-to-time modified by the City Manager acting in consultation with the City Council.
- (b) As provided under Government Code Section 36510, the person appointed to serve as City Treasurer need not be a resident of the City of San Fernando.
- (c) The City Council by subsequent ordinance shall be authorized to amend and/or modify the qualification requirements set forth under this section, above, provided that any such requirements are not in conflict with applicable State law.

#### Section 2-192 Duties of City Treasurer.

- (a) The City Treasurer shall perform all such duties as may be imposed upon him or her as provided by State law or under the San Fernando Municipal Code.
- (b) Pursuant to Government Code Section 36518, the City Treasurer shall execute a bond in an amount to be fixed by the City Council by resolution.

**SECTION 3.** The text of Subsection (13) of Section 2-243 (Categories of Employment) of Division 5 (Civil Service) of Article III (Officers and Employees) of Chapter 2 (Administration) of the San Fernando Municipal Code is hereby repealed and replaced with the following text which shall state the following:

(13) At-will city employees authorized by the city council.

It is understood that the modifications to the Municipal Code as called for under this Section 3 of this Ordinance are for purposes of harmonizing the provision with the outcome of the General Municipal Election wherein the elective office of City Treasurer is to be converted to an appointive office. Accordingly, any future modifications or amendments to the provisions at issue under this Section 3 shall not require a subsequent vote of the people.

**SECTION 4.** Section 2-908 (Definitions) of Article VII (Campaign Reform) of Chapter 2 (Administration) of the San Fernando Municipal Code is hereby repealed and replaced by the following text which shall state the following:

The following terms used in this article shall have the meanings set forth below. Except as otherwise provided here, the terms and provisions of this article shall have the meanings and shall be interpreted in accordance with the applicable definitions and provisions of the Political Reform Act of 1974, as amended (Government Code Section 81000, et seq.) and the regulations of the California Fair Political Practices Commission, as amended.

- (1) Candidate means any person who is a candidate for member of the city council of the City of San Fernando whether or not the person is seeking to become a member of the city council or is an incumbent member of the city council seeking reelection.
- (2) Committee means any person or combination of persons who directly or indirectly do any of the following in connection with supporting or opposing a candidate or candidates for city council or city treasurer:
  - a. Receive contributions totaling \$500.00 or more in a calendar year.
  - b. Make independent expenditures totaling \$500.00 or more in a calendar year.
  - c. Make contributions totaling \$5,000.00 or more in a calendar year.

A person or combination of persons that becomes a committee shall retain its status as a committee until such time as that status is terminated pursuant to California Government Code Section 84214.

- (3) Election means any general election, special election or recall election.
- (4) Person means an individual, proprietorship, firm, partnership, joint venture, syndicate, business trust, committee, company, corporation, limited liability corporation, association, and any other organization or group of persons acting in concert.

It is understood that the modifications to the Municipal Code as called for under this Section 4 of this ordinance are for purposes of harmonizing the provision with the outcome of the General Municipal Election wherein the elective office of City Treasurer is to be converted to an appointive office. Accordingly, any future modifications or amendments to the provisions at issue under this Section 4 shall not require a subsequent vote of the people.

**SECTION 5.** Pursuant to Government Code Section 36510, the City Council by approval of this Ordinance by both the San Fernando voters and the City Council exercises the City Council's right to vest authority in the City Manager to appoint the City Treasurer. The foregoing notwithstanding, voters of the City of San Fernando and the City Council approve this ordinance subject to the right of the City Council to later vest the appointment authority back to the City Council by subsequent ordinance of the City Council.

**SECTION 6.** If any provision of this ordinance or the application thereof to any person or circumstance is held invalid, the remainder of the ordinance and the application of such provision to other persons or circumstances shall not be affected thereby.

**SECTION 7.** This ordinance and the action taken hereunder is not a "project" within the meaning of the California Environmental Quality Action codified as section 21000 et seq. of the *Public Resources Code* ("CEQA") because it will not result in a direct or reasonably foreseeable indirect physical change in the environment nor does it involve any commitment to any specific project which may result in a potentially significant physical impact on the environment.

SECTION 8. The Mayor shall sign and the City Clerk shall attest to the passage of this Ordinance. The City Clerk shall timely cause the same to be published once in the official newspaper. This Ordinance shall become effective upon the certification of an affirmative majority vote of the City voters at the March 7, 2017 General Municipal Election. The foregoing notwithstanding, the provisions of this ordinance shall remain dormant until such time as the term of office of the person elected to serve as City Treasurer at the March 7, 2017 expires; or such person vacates the office of City Treasurer following his or her swearing in, whichever occurs first. Until such time all provisions of the San Fernando Municipal Code which have been amended by this ordinance shall remain in place.
