NEW BUSINESS

TRANSIT PROGRAMS AND PHONE APP OVERVIEW – Deputy City Manager/Public Works
Director Chris Marcarello provided and overview of transit services (Dial–A-Ride and Trolley
Services). Dial-A-Ride provides curb to curb service to San Fernando residents. Trolleys
operate on a fixed route (29 stops). Mr. Marcarello briefed the Commission on future plans
for the Transit program. A demonstration of phone application was presented.

COMMISSION DISCUSSION

Commissioner Holy Scott – It was brought up to her attention that Environments Plus (1700 First Street) has large box trucks taking up street parking. Commissioner Scott also reported that vehicles are stopping at Hewitt/Maclay and Coronel/Maclay vehicles even though there isn't a stop sign.

Commissioner David Bernal – Lighting issue on Jessie Street near bike path. Commissioner Bernal would like to see cross traffic doesn't stop sign.

Commissioner Akemon – School will start soon and so will traffic issues.
