APPROVAL OF MINUTES

Commissioner Arrizon motioned to approve the minutes for August 1, 2018 (Regular Meeting) and September 12, 2018 (Special Meeting) Transportation & Safety Commission meetings. Commissioner Bernal seconded the motion. The motion was passed unanimously.

NEW BUSINESS

- 1. DISCUSSION OF COST OF SPEED RADAR SIGNS (INFORMATIONAL)** - Director of Public Works/City Engineer Yazdan Emrani provided estimated cost of signs and installation. Staff will follow-up with the Police Department (PD) on effectiveness of these devices based on PD's research with other cities that may be using similar devices.

Also, there was discussion of speeding throughout the City. Staff asked for specific locations so that a plan can be developed for doing speed surveys for these areas of concern. PD also mentioned that once their speed trailer has been repaired, they can place the trailers at these areas of concern for better enforcement.

CONTINUED BUSINESS

- 1. ALLEY BEHIND 1000 BLOCK OF SAN FERNANDO ROAD-UPDATE ON INSTALLATION OF SPEED HUMPS** – Staff hand delivered notices to business on Truman between Maclay and Brand informing them of possible installation of the speed humps and inviting them to the Transportation & Safety Commission meeting on October 3, 2018 to voice their opinion. Motion was made by Commissioner Bernal to recommend to City Council the installation of speed humps in the alley behind the alley of 1000 block of San Fernando Road. Vice Chair Akemon seconded the motion. The motion was passed unanimously.
