### **APPROVAL OF MINUTES**

Vice Chair Akemon motioned to approve the minutes for October 4, 2017 Transportation & Safety Commission meeting. The motion was seconded by Commissioner Perez. The motion carried unanimously.

### **NEW BUSINESS**

1. **TRUMAN AND WOLFSKILL CONCERN** – Chair Trujillo briefed Commission on issue. After Commission discussion, Chair Trujillo motioned to have crosswalk restriped and to look into the possibility of LAUSD helping offset cost. Commissioner Arrizon seconded the motion. The motion carried unanimously.
2. **JESSIE STREET/FIRST STREET CROSWALK** – Same motion as New Business – Item No. 1.
3. **STREET LIGHT ISSUE AT GLENOAKS/MACLAY** – Chair Trujillo was approached by resident about there not being enough light between last street light and alley way as current light looks dim. Staff to contact Edison about issue.
4. **FIFTH STREET AT BRIDGE – CONSIDERATION OF RED CURB** – Vehicles are being parked too close to the bridge. Staff will generate work order for red curbing.
5. **REPORT ON ACCIDENTS AT FIFTH STREET/BRAND BLVD** – Mr. Fabian provided accident report for location. Chair Trujillo clarified that intersection in question was Fourth Street/Brand Blvd. Staff was asked to provide traffic collision report information and speeding ticket data on a regular basis (quarterly).
6. **PACOIMA WASH PROJECT UPDATE** – Mr. Fabian informed Commission that plans have been received and are being reviewed. Construction tentatively scheduled for Fall 2018.
