APPROVAL OF MINUTES

Vice Chair Akemon motioned to approve the minutes for November 7, 2018 Transportation & Safety Commission meeting. Commissioner Arrizon seconded the motion. The motion was passed unanimously.

NEW BUSINESS

- 1. PARKING CONCERNS ON PARK AVENUE BETWEEN FIRST AND FOURTH STREETS** – Chair Trujillo discussed parking concerns. Public Works will evaluate red curbing at the corner of Fourth Street and Park Avenue and mentioned vehicles blocking access roads. Staff will follow up on issues and report back at next meeting.
- 2. REGULATIONS CONCERNING HOMELESS NEAR SCHOOLS** – Chair Trujillo reported that he had been informed of homeless encampments near schools and on right-of-way. Sgt. Aguirre informed the Commission that issue should be called in and the Police Department will come out and address the situation accordingly.
- 3. UPDATE ON TRAIN-RELATED ACCIDENTS WITHIN THE CITY OF SAN FERNANDO** – Mr. Emrani briefed the Commission on meeting with Public Utilities Commission and Metro to look at any safety measures that need to be added. A Walk-Audit with Metro representatives will be conducted on Saturday, February 9, 2019 to address safety concerns. The Commission was invited to attend.
- 4. SPEEDING CONCERNS ON BRAND BLVD** – The following was discussed to mitigate issue: (1) traffic synchronization, (2) Speed Enforcement and (3) Speed Enforcement Trailer.

- 1. ALLEY BEHIND 1000 BLOCK OF SAN FERNANDO ROAD-UPDATE ON INSTALLATION OF SPEED HUMPS** – Commission was informed that speed humps have been installed.
- 2. LIST OF AREAS OF SPEEDING CONCERN, BY LOCATION, FROM THE PUBLIC** – Item is on the agenda to give residents an opportunity to bring issue to the Commission.
