On March 18, 2021, Timothy Hou donated \$1,250 to the San Fernando Education Commission to create a new scholarship program Gerry's Kids Scholarship (Attachment "A") in memory of Geraldine "Gerry" Hou, who was a 20-year librarian with the Los Angeles Public Library and encouraged countless young people of color to pursue college education and a lifelong passion for learning. ## Gerry's Kids Scholarship

Geraldine "Gerry" Hou was a young adult librarian for over 20 years with the LA Public Library and encouraged countless young people of color in the neighborhoods of Exposition Park, Crenshaw/Baldwin Hills, and Wilmington/Harbor City to pursue college education and a lifelong passion for learning.

This \$1,250 essay scholarship awarded annually is funded by Timothy Hou, a former Deputy City Manager and Director of Community Development at City of San Fernando, and his family in memory of Gerry and her work with students. The scholarship proceeds target students pursuing higher education at colleges and universities outside of Southern California with the aim of easing some of the financial challenges for young adults in being away from their support system at home, in many instances for the first time in their lives.

This opportunity is open to any San Fernando resident or a graduating college-bound high school senior or or current full-time enrolled four-year university student who attends or graduated from Cesar Chavez Learning Academies, Vaughn International Studies Academy, San Fernando High School or Sylmar High Schools.

Scholarships are non-merit based and need blind and can be awarded to students with the following criteria.

#### **ELIGIBILITY REQUIREMENTS:**

- 1. Live in the City of San Fernando or attend or have graduated from VISA, Cesar Chavez Learning Academies, San Fernando or Sylmar High Schools.
- 2. Attending in residence a college or university that is outside Southern California (If you are not sure your university is outside Southern California, the Southern California region consists of the counties of Imperial, Inyo, Los Angeles, Mono, Orange, Riverside, San Bernardino, San Diego, San Luis Obispo, Santa Barbara, and Ventura.)


Winners will have to show proof of acceptance and enrollment at a university outside of Southern California.



#### **Writing Guidelines**

• Essays must be in English and be 400 to 500 words in length, typewritten and double-spaced in 12 point font. Facts and quotations should be appropriately cited either in the body of the essay or in footnotes. Entries must be original, unpublished essays written by the contestants.

#### **Submission Guidelines**

- Please submit only one essay per student.

- Please include your essay as an attached PDF document.
- Entries must include your full name, e-mail address, home address, phone number, grade level, school name, and the name of your parent or legal guardian, in that specific order.

#### **Selection of Scholarship Recipients**

- The City of San Fernando Education Commission will evaluate all essays based upon creativity, demonstrated knowledge about Cesar Chavez, passion for environmental issues, and a vision for the future.
- Details of the specific evaluation methods and contest requirements are developed by The City of San Fernando Education Commission and Republic Services.

#### **2021 Essay Topics**

(Students are challenged to answer **ONE** of the following questions):

- 1.) If you lived in an apartment complex that didn't recycle, how would you inspire the manager to setup a recycling center in the complex? What would be the overall environmental impact if all residents conscientiously recycled in the state of California? How could this goal be achieved?
- 2.) If you were asked to approach a family member that was not recycling, how would you communicate the impact recycling has on our environment? How could they responsibly dispose of their trash, and what would be your strategy in encouraging recycling behavior? Give an example(s).
- 3.) Cesar Chavez was an activist. Using lessons inspired by Cesar Chavez, how would you convince your fellow students to become active recyclers and reduce waste? Discuss how your student government could create policy change at your school to reduce waste, recycle more, and compost food scraps.
- 4.) What local business most inspires you with their efforts in environmental friendliness? How can these efforts be used to work towards the City of San Fernando becoming a Green City?

# Discussion and Selection of Recipients for the 2020-2021 Scholarships and Related Matters Page 2 of 2 $\,$

Students were required to submit an essay to apply for the scholarship of their choice (one scholarship per student). Each essay (student personal information redacted) is reviewed by two Commissioners for scoring purposes to determine the final recipient(s), and at tonight's meeting, the Education Commission will ratify the recipient winners.

The Fiscal Year 2020-2021 Scholarship Budget will be reviewed and a determination will be made if funding adjustments are applicable. Finally, after the finalists and funds have been awarded, ad Hoc committees may be formed to appropriately schedule and plan an awards ceremony.

#### **BUDGET IMPACT:**

Donations are received to cover the costs of the amount of the scholarship and therefore there is no fiscal impact. Additional future costs are included in the Education Commission's Fiscal Year 2020-2021 annual Budget to include supplies for an awards ceremony.

#### **CONCLUSION:**

It is recommended that the Education Commission discuss and provide direction to City staff regarding scholarship recipients, and related recommendations, as appropriate.
