1. CONSIDERATION TO APPROVE ART MURAL PERMIT PR 2021-070

G. Marquez, Associate Planner, presented the first Art Mural Permit Application received by the City and provided some background on the ordinance allowing murals on private property and the formation of an Ad Hoc Committee to review Art Mural Permit Applications. The project specifications were provided in the presentation and details on procedures related to Art Murals was provided. There was a ten-day public notice posted for anyone to voice concerns related to this mural. In addition, this public meeting allows for public comment, however, no public comment was received.

Members of the Mural Ad Hoc Committee and Commission discussed concerns regarding cultural relevance, maintenance of the mural, the application and appeal process and possibly consulting with the artist to discuss revisions. Upon consensus, the following motion was made:

## **DEPARTMENT PROGRAM UPDATES**

2. **VIRTUAL PROGRAMMING** –J. Venegas provided an update on the Department's virtual programming such as Lunchtime Trivia, Living Trust and Will Workshop, Crafts for Senior, Bingo, Loteria, Name that Movie and Zumba classes. J. Venegas reported that May is Older Americans Month and this year's honoree will be recognized virtually on May 27<sup>th</sup>.

MMAP will air a virtual concert this Thursday in honor of Mother's Day. All program information is available online or by calling Las Palmas Park at (818) 898-7340.

3. **DEPARTMENT'S REPONSE TO COVID-19**–J. Venegas reported that Round 7 of the Residential Food Program is the final distribution and is scheduled on Saturday, May 22<sup>nd</sup>. We expect to serve 137 families. To date, 627 households have participated in this program receiving non-perishable food items and PPE. The City continues to collaborate with LA Food Bank to distribute food kits on the first Monday of each month for seniors age 60 and over.

Staff continues to partner with Providence, L.A. County and L.A. City to offer COVID-19 vaccinations and testing at Recreation Park, Las Palmas Park and other locations. The Johnson & Johnson vaccine pop clinic will be held at Las Palmas Park on May 14<sup>th</sup>. Individuals must register in advance. Information is available on the City website at www.sfcity.org.

Vice-Chair S. Richards and Chair J. Hayes thanked RCS staff for stepping up and making these services available to the public.

Chair J. Hayes asked for clarification regarding vaccine eligibility at Recreation Park. J. Venegas reported that individuals over the age of 16 are eligible. The County is holding 100 vaccine shot reservations available to City residents regularly.

4. **REOPENING EFFORTS**— J. Venegas reported that the Department is in the process of hiring 9 Recreation Leaders in preparation for the reopening of programming and activities. Upcoming activities will include pickleball and tennis. Current outdoor fitness classes will eventually transition to indoor once restrictions are lifted.

The Family Wellness Challenge ended on May 1<sup>st</sup>. Approximately 63 families participated in this five-week program. Clinics will be offered this summer for youth sports such as baseball, basketball and soccer. The goal is to offer sports leagues in the future. Other activities that are coming up include classes by the Roller Derby Club of SFV and dance classes offered by the former owner of Danzone dance studio.

The Veterans Banner Program will begin to display banners along Maclay Street beginning Memorial Day weekend through Veterans Day.

Commissioner J. Ponce inquired if there are any organizations interested in offering little league teams. Per J. Venegas, the San Fernando Little League is currently utilizing our various parks for their league. The City is interested in offering a City sponsored league in the near future.

- 5. LAYNE PARK REVITAILZATION PROJECT—J. Venegas reported that a virtual Community Meeting was held on April 12<sup>th</sup>. Two more Community Meetings will be held in-person in May and June to invite community input on the Layne Park Project. Outreach efforts are in the form of flyers, door hangers and an ad in the local newspaper. MIG is the design consultant and VCCC is handling outreach for this project.
- 6. YOUTH REINVESTMENT GRANT PROGRAM (TUTCINT YOUTH EMPOWERMENT PROGRAM) -
  - Per J. Venegas, this program is currently in their fourth cohort offering youth services on various themes and topics. The group recently visited Malibu Lagoon Museum for an educational seminar on nature and stewardship. There are approximately 30 youths currently enrolled in the program who are benefiting from various programs and activities. Anyone interested in this program can obtain more details on the City website.
- 7. **COMMUNITY THEATRE PROGRAM**—Chair J. Hayes discussed setting up a meeting sometime after June 17<sup>th</sup> and inviting all interested parties to attend.

#### **BACKGROUND:**

- 1. The mission of the Recreation and Community Services Department (RCS) is to develop and implement enriching community, cultural and recreational opportunities that foster the overall well-being and personal development of our community.
- 2. The Department conducts a wide array of programs, services, activities, and business throughout the year. Staff provides a monthly update on items discussed at the Parks, Wellness and Recreation Commission (PWRC) meeting and welcomes any guidance or recommendations regarding the items presented.

#### **DEPARTMENT UPDATES:**

## Virtual Programming

Staff continues to engage the community virtually. The Department's webpage (SFCITY.ORG/SFRECREATION) provides information on the various programs being offered to the public. In addition, health/wellness videos and fun family activities are available for the community 24/7. The table below lists the RCS Department's virtual programming for May 2021:

## <u>Department's Response to Covid-19</u>

San Fernando Residential Food Program Overview:

- The final food distribution event was held on May 22, 2021 from 9:00 am to 11:00 am at Las Palmas Park. The program provided food kits for some 88 family households for this distribution. To date, the total 627 families have participated in this program.
- The Department also collaborates with The Angeles Regional Food Bank to distribute a free food kit containing nutritious items such as meats, canned fruits, and vegetables, cereals, and grains. The distribution was held on Monday, May 3, 2021 at Las Palmas Park. The program serves seniors age 60 and over. The program serves an average of 150 seniors monthly. For more information on food assistance programs please contact Las Palmas Park at 818-898-7340.

## Vaccine Collaborations:

- The Department is collaborating with Providence Holy Cross to register residents 16 and above for the Covid-19 vaccine. In addition, staff contacted over 300 seniors and informed them of the vaccine opportunity offered by Providence Hospital. To date, RCS staff has referred 103 people the this vaccine program.
- The Department continues to host the Los Angeles Fire Department's Covid-19 Testing and Vaccination Hub at Recreation Park. The site operates Monday thru Saturday from 8:00 am to 8:00 pm. The site is offering vaccines to people with an appointment and also walk-ups. Staff received training on how to make appointments for the Recreation Park site. Residents can call Las Palmas Park at 818-898-7340 or Recreation Park at 818-898-1290 to request an appointment for a vaccine.
- The Department hosted a Vaccine Pop-up Clinic at Las Palmas Park in collaboration with Curative Health and Los Angeles County's Department of Public Health (LACPDH). The Pop-up Clinic was held on Thursday, May 27, 2021. About 88 individuals were vaccinated.

## **Reopening Efforts**

The Department is continuing to implement outdoor programming under the guidance and protocols issued by the Los Angeles Department of Public Health (DPH). On June 15, 2021, the State is expect to lift all social distancing guidelines. However, DPH may impose their own protocols for events and activities. Staff will review any such protocols to ensure the public is safe while participating in our programming. RCS staff is very cautious and slowly reopening the facilities to implement safe activities.

- Tennis Courts staff is preparing to introduce a Pickle Ball activity at the Pioneer Park tennis courts. The activity is similar to tennis, but at a slower pace and smaller playing area. The tennis courts are open to the public every Tuesday and Thursday between the hours of 3:00 pm and 5:00 pm, then again on Saturdays and Sundays between 10:00 am and 3:00 pm. Reservations are not required for these open play hours.
- Outdoor Fitness Classes continue as part of the Healthy San Fernando Campaign. The New 6-week session started May 3<sup>rd</sup> and runs through June 19<sup>th</sup>. The classes offered and current enrollment is as follow:

- Youth Sports programs planned for this summer include a series of clinics for youth, ages 3 11. The clinics will include introduction and instruction for Baseball, Basketball and Soccer. The Recreation Division will adopt the clinic-style format to help build interest for future league programming and to offer supplemental instruction during league programming. Staff is in the process of developing a Youth Baseball program for the Spring of 2022 and restarting the Youth Basketball League for the Winter of 2022 (pending indoor activity reopening).
- Adult Sports The Department offers Adult Basketball, Coed Softball, Men's Wooden Bat league, and drop-in Volleyball. Staff is working to restart the softball program in the Fall (2021), while indoor programming will be pushed back to 2022 (adult basketball and volleyball).
- The Veterans Recognition Banners are now on display along Maclay Avenue and Truman Street. The banners will be displayed until the week of November 15, 2021.
- SUMMER DAY CAMP The City will offer a limited Summer Day Camp program this summer. SPACE IS LIMITED and will be on a first come, first served basis. There are 22 youth registered for the program at this time.
