Subject: Reorganization of the Transportation and Safety Commission

RECOMMENDATION:

It is recommended that the Transportation and Safety Commission proceed with a reorganization of the Commission and the selection of its Chair and Vice Chair (if necessary).

BACKGROUND:

1. The Transportation and Safety Commission (TSC) is composed of five members – each appointed by a different councilmember.
2. Each year, the members shall elect a Chair and Vice Chair per Municipal Code 1957, § 13.25, Section 90-71 (Attachment “A”).
3. On February 3, 2021, the TSC conducted an annual reorganization and selected a new chair (Clarissa Tolentino) and a new vice chair (Francisco Arrizon).
4. On July 6, 2021, the chair of the Commission formally resigned.

ANALYSIS:

In accordance with Municipal Code 1957, § 13.25, Section 90.71, the TSC shall meet annually to choose one of its members as Chair and another of its members as Vice Chair. The terms of office of the Chair and Vice Chair shall be for one year. Since the Chair of the TSC stepped down on July 6, 2021, a new chair should be selected to complete this year’s term. Any member of the TSC can be considered, including the existing Vice Chair. If the Vice Chair were selected to be Chair, then the TSC would then continue the process to select a new Vice Chair.

Any member of the Commission may make nominations for the position of Chair and Vice Chair (if necessary). The process for selecting a Chair and Vice Chair is as follows:

Election of the Chair.

1. The current Vice Chair opens the nominations for the position of Chair.
2. Nomination(s) is/are made for Chair, and seconded.
3. Hearing no objections, a motion is made to close the nominations.
4. The Executive Assistant conducts a roll call vote and Commissioners announce their vote for Chair until one is elected by majority vote.
The Executive Assistant announces the results.

Election of the Vice Chair (if necessary).

1. The new Chair opens the nominations for the position of Vice Chair.
2. Nomination(s) is/are made for Vice Chair, and seconded.
3. Hearing no objections, a motion is made to close the nominations.
4. The Executive Assistant conducts a roll call vote and Commissioners announce their vote for Vice Chair until one is elected by majority vote.
5. The Executive Assistant announces the results.

BUDGET IMPACT:

There is no budget impact associated with the annual reorganization of the Transportation and Safety Commission.

CONCLUSION:

Staff recommends that the TSC select a new Chair to replace the former Chair and, if necessary, a new Vice Chair, in accordance with Municipal Code 1957, §13.25, Section 90.71.

ATTACHMENT:

- A. Municipal Code 1957, §13.25, Section 90.71

Sec. 90-71 - Established; composition; appointment and compensation of members; officers.

- a) There is established a transportation and safety commission of five members to be appointed by a different appointing councilperson, with such appointment to be ratified by the city council. Each member shall have full participation and voting rights. Each member shall also be a registered voter and city resident. Such members so appointed shall be persons who do not hold any office or position with the city. The terms of office of each member shall be one year.
- b) The members shall organize the transportation and safety commission and shall elect a chair and vice-chair. In the absence of the chair and vice-chair, any other member shall call the commission to order, whereupon a chair shall be elected from the members present to preside for that meeting.

Subject: Consideration to Change Regular Meeting Time for the Transportation and Safety Commission

RECOMMENDATION:

Subject: Discussion of Potential Traffic Study along Wolfskill Street between Woodworth Street and Hollister Street

RECOMMENDATION:

It is recommended that the Transportation and Safety Commission direct staff to conduct a traffic study along Wolfskill Street between Woodworth Street and Hollister Street.

BACKGROUND:

1. On July 7, 2021, the Transportation and Safety Commission received a public comment seeking potential traffic speed mitigations along Wolfskill.

ANALYSIS:

At the July 7, 2021 Transportation and Safety Commission (TSC) Meeting, Staff received a public comment expressing concern about speeding vehicles along Wolfskill Street near O'Melveny Street in the City of San Fernando. No specific traffic control/calming devices were requested as part of the public comment, but a general request to study the area was made.

Wolfskill Street between Woodworth Street and Hollister Street

Staff has evaluated the general location and it does appear that approximately 1,250 feet separates the stop signs located on Wolfskill Street between Woodworth Street and Hollister Street. If directed, Staff can set up speed and volume survey equipment at the midpoint between Woodworth Street and Hollister Street. Staff can then use this data to determine if the installation of stop signs is warranted to help control speeding on Wolfskill Street.

Discussion of Potential Traffic Study along Wolfskill Street between Woodworth Street and Hollister Street

BUDGET IMPACT:

If directed by the TSC to perform the traffic study, in-house staff time will be used to perform the analysis and report to the TSC at the September 1, 2021 meeting.

CONCLUSION:

The TSC directed staff to bring these items back for discussion at its August meeting. Based on review of the intersections, it is recommended that the Transportation and Safety Commission direct staff to proceed with a traffic study along Wolfskill Street between Woodworth Street and Hollister Street.
