DISCUSSION AND SELECTION OF THE MARCH 2022 STUDENT OF THE MONTH

The Commission was asked to provide direction regarding the two scholarships that did not receive submissions. One option is to extend the submission deadline or to repurpose those funds. The Commission discussed options including extending the submission deadline on various scholarships.

Discussion ensued on procedures pertaining to staff reviewing essays for eligibility, presentation to the Commission and the process of Ad Hoc Committees scoring the essays.

Eligibility criteria for high school and college students was discussed in detail. Staff will provide slate of candidates to the Commission prior to next Education Commission Meeting on March 29th.

J. Venegas provided updated information the avail award funding. The current balance is \$6560.00. Funds for the Republic Services and Gerry's Kids scholarships will be submitted separately. The Commission will discuss the award funds in greater detail at the next Commission meeting.

The awards ceremony will follow the recommendations set forth by L.A. County. It is expected to that the ceremony will be an in-person event. The projected date will be in late May. Chair Zobel-Rodriguez recommends May 17 or May 24 in the evening. The Commission prefers to hold the event on May 24. The location is to be determined. Staff will look at possible sites and make some recommendations at the next meeting.

Once winners have been selected, the winners are notified, a photo with a biography of each winner is forwarded to administration for social media, the Commission will prepare a press release and forward to staff, light snacks will be served, decorations are set up at the venue, a "save the date" email will be sent to each winner, and verification documents may be requested.

Commissioner Mohr was contacted by the Rotary of Greater Van Nuys seeking to recruit people for the pageant of the arts.

Vice-Chair Govea reported that LAUSD has lifted the outdoor mask mandate.

Chair Zobel-Rodriguez thanked the Commission and staff.

STAFF COMMUNICATION

- J. Salas, Community Services Supervisor, informed the Commission that in-person programming is now operating at 97%. This includes a pilot program for the Senior Billiards program and an upcoming overnight camping activity made possible by NPCA.
- J. Veneges announced the Mind, Body and Soul Health Fair scheduled on Saturday, March 26th at Las Palmas Park. This is a free event that is part of a series of health programs scheduled to make a comeback. Other programs now in session include Folklorico, Live Jazz, Total Body Conditioning, Zumba, Cycling and Yoga. The Veterans Recognition Program is offering an opportunity to honor veterans with a banner displayed in the City. Coming up, is the One-mile Run along with Dia de Los Muertos and the Summer Camp program. The Covid Vaccination and Testing Site is still operating at Recreation Park Tuesday through Saturday.

Recreation Park will experience street closures for about two months beginning in February due to gas line repairs. In addition, the water infiltration project designed to capture storm water will begin in April and will impact programming at Recreation Park.

Staff thanked the Commission for promoting the TBC teen program. The TBC group will work a tree planting event in March and the Spring Jamboree in April. Flyers will be sent to the Commission.

BACKGROUND/ANALYSIS:

The San Fernando Education Commission (Commission) was established on May 5, 2011, and acts as the liaison between City and local schools administrations, the City's local board administrators for the Los Angeles Unified School District, and other public and private schools that operate in the city. The Annual Student Scholarship Essay Program was established to assist San Fernando youths who are seeking a postsecondary education.

The Education Commission evaluated 25 eligible essays for the 2021-2022 scholarship program. A breakdown of the essays reviewed per scholarship by the Commissions are listed below:

At the March 29, 2022 Education Commission meeting discuss the essays submissions and select seven (7) students to receive a scholarship form the pool of 25. Originally, eight (8) scholarship had been awarded due to the selection process being anonymous, and one student was chosen twice. Only one scholarship per student is allowed, so that student was awarded the higher dollar mount scholarship and vacated the lower dollar amount scholarship. The students selected to receive an awarded are listed in 2021-2022 Scholarship Awardee list (Attachment "A").

Staff sent a congratulatory letter (Attachment "B") and to the awardees, which invited them to the awards ceremony and provided instructions for what the next steps would be. A second congratulatory letter (Attachment "C") was sent to the honorees school principal inviting them to the awards ceremony. Staff will also invite elected officials and donors to the awards ceremony. The event will be promoted on the City webpage and a social media campaign that will knowledge all the honorees.

The total amount awarded for the 2021-2022 Scholarship Program is \$4,900. The General Scholarship fund will account for \$1,650. Three privately funded scholarships for \$3,250 make up the difference. The Department will request the checks paid for from the General Scholarship fund and the private funded scholarship donors will be present the checks to their scholarship recipients.

The award ceremony will be held at Rudy Ortega Sr. on May 24, 2022, from 6:00 pm to 7:30 pm. The Education Commission will form an Ad Hoc Committee to plan the awards ceremony event. RCS Staff will assist the Committee with logistics for the event. The Ad Hoc Committee should meet as soon as possible to start the planning. Staff will assist coordinating the meeting via the Zoom platform or an in person meeting.

BUDGET IMPACT:

The general scholarship account balance (053-2951) will be lowered by \$1,650 amounts the Education Commissions' recommendations.

CONCLUSION:

It is recommended that the Education Commission discuss the Status of the Scholarship Award Ceremony Notifications, discuss the Social Media and Honoree Recognition, create an Scholarship Awards Event Ad Hoc Committee, discuss Logistic for the Event; and provide direction to staff, as appropriate.
