Subject: Discussion Regarding the 2021-2022 Student Scholarship Awards Event

RECOMMENDATION:

It is recommended that the Education Commission discuss the 2021-2022 Scholarship Awards Ceremony event and provide comments, as appropriate.

BACKGROUND

- 1. In December 2021, the San Fernando Education Commission ("Commission") announced the 2021-2022 Scholarship Program would be accepting applications through February 18, 2022.
- 2. On March 29, 2022, 28 essays of the 72 applications submitted were reviewed, scored and ranked by the Commission. Seven (7) students' essays were selected for a scholarship award.
- 3. On April 26, 2022, an Awards Event Ad Hoc Committee was created to plan the Scholarship Awards Ceremony. Vice Chair David Govea and Commissioner Suzanne Llamas were appointed to serve on the Committee. The Ad Hoc Committee met with RCS staff and proceeded to plan the event which would take place at Rudy Ortega Sr. Park on May 24, 2022.
- 4. On May 24, 2022, the Education Commission hosted the Student Scholarship Awards Ceremony, and awarded nearly \$5,000 in scholarships to seven deserving students.

ANALYSIS

The San Fernando Education Commission hosted its 2021-2022 Student Scholarship Awards Event celebration on Tuesday, May 24, 2022 at Rudy Ortega Sr. Park from 6:00 p.m. to 7:30 p.m. The Education Commission should discuss the event and provide feedback as to the venue of the event, the program, food and other aspects of the program to ensure future awards ceremonies can benefit from such input.
