Adult softball is on hold for the time being as there is no field available, basketball is planned to resume in the spring of next year, and volleyball open nights is planned to resume for open play. The tennis program has also resumed at Pioneer Park on Saturdays.

Leisure classes currently in progress are Folkorico Dance, Aztec Dance, Karate, Line Dance and fitness and health classes such as 3Wins.

The Lopez Adobe reopened for tours in May. Guided tours are available on the fourth Sunday of the month. A research library will be coming soon to Las Palmas Park. An intern has been working to take inventory and clean out the storage room containing artifacts. Items determined not to be of historical significance will be sold at a rummage sale to raise funds for this project. A book-signing event for the published memoirs authored by a descendant of the Lopez Family will be planned in the near future.

Other activities currently in progress include the Summer Day Camp at Recreation Park, the Senior Meal Program at Las Palmas Park, the Father's Day event, Walkable Wednesday 5K Challenge, and an update on the Fourth of July celebration was discussed.

Commissioner R. Gonzales recommended offering scholarship opportunities to families who are in need financial assistance for the Day Camp program and field trips. He further commented on how

successful the Fourth of July event was this year.

Subject: Discussion Regarding Potential Commission Action Items

RECOMMENDATION:

It is recommended that the Parks, Wellness, and Recreation Commission:

a. Discuss the items introduced at the September 13, 2022 Parks, Wellness, and Recreation Commission meeting that may potentially develop into action items; and

b. Provide staff with direction as appropriate.

BACKGROUND:

- 1. The San Fernando City Council created the Parks, Wellness, and Recreation Commission (PWRC) to advise and make recommendations to the City Council on matters related to the operation and implementation of programs, services, and facilities of the Recreation and Community Services Department.
- 2. Article II, PARKS, WELLNESS AND RECREATION COMMISSION Sections 54-28 54-67 of the City's Municipal Code (Attachment "A") govern the actions of the PWRC. In particular, sections 54-63 on "Powers and Duties", provides a guide on how the PWRC should make recommendations to the City Council for consideration.
- 3. On September 13, 2022, Commissioner Sanchez-Brooks introduced several items to be agendized for discussion. The items include maintenance, security and lighting at the bike path, a community garden, a dog park, and an all abilities playground.

ANALYSIS:

Mission City Trail-Bike Path

Although the Mission City Trail Bike Path is a recreation feature in the City, maintenance of the

path falls under the direction of the Public Works Department. The Public Works Department has recently invested more department staff resources to address safety and cleanliness issues along the trail. Public Works plans to install solar lighting along the 1.4 mile bike trail to enhance safety.

Metro has a plan to build the North San Fernando Valley Transit Corridor Project that will improve east-west transit service in the North San Fernando Valley. The Mission City Trail will run along this corridor, which restricts the building of any permanent structure along the trail.

Community Garden

The Parks and Recreation Master Plan adopted by City Council in 2018 identifies several park facilities needed in the City. However, the plan also reported that the City of San Fernando is a built-out community, which hinders the development of new park space for recreational programming.

The scarcity of land to build a new recreation facility is challenging, but building on existing city land may be an option for new park programming. Depending on the size of a proposed community garden, the PWRC may look at existing parkland for a community garden project.

The PWRC must take into account how a community garden project would be funded. Several NGO's earmark grant funds toward community garden projects. However, those grants are highly competitive and require considerable staff resources needed for the application process. Most grants require community input that is incorporated into the application.

Dog Park

At the August 8, 2022 City Council meeting, staff was directed to look at the possibility of building a dog park in the City. This directive was expanded at the October 3, 2022 City Council meeting, to include the possibility of building other park developments and updating the Parks and Recreation Master Plan. The goal is to determine if the Parks and Recreation Master Plan still meets the needs of the community.

Staff will be developing a Request for Proposals for consulting services to assist the Recreation and Community Services Department in updating the Parks and Recreation Master Plan. The possibility of building a community garden and a dog park will both be investigated. A major component of updating the Parks and Recreation Master Plan will be gathering input from residents, stakeholders, and user groups through the community engagement process.

All Abilities Playground

The Recreation and Community Services Department is addressing the ADA accessibility issue for all of the park playgrounds. Three park renovation projects include a modification to an existing playground or bundling new playgrounds that are all abilities accessible. The park renovations that address ADA accessibility are the Layne Park Revitalization Project, the Las Palmas Revitalization Project, and the Pioneer Park Playground Renovation Project.

BUDGET IMPACT:

There is no budget impact for discussing the items introduced at the September 13, 2022 PWRC meeting. However, as cited in Article II, section 54-67 of the City Municipal Code, "Neither the Commission nor any person connected with the Commission shall incur any financial liability in the name of the City."

Any projects, programs special events, or cultural activity recommended to City Council shall be accompanied by identified outside funds subject to City Council approval for implementing the Commission's recommendation.

CONCLUSION:

It is recommended that the Parks, Wellness, and Recreation Commission discuss the items introduced at the September 13, 2022, PWRC meeting and provide staff with direction as appropriate.

Secs. 54-28-54-55. Reserved.

ARTICLE II. PARKS, WELLNESS AND RECREATION COMMISSION¹

Sec. 54-56. Created.

There is created and established a recreation and community services commission in and for the city, which shall be known as the "San Fernando Parks, Wellness and Recreation Commission." For purposes of this article, the capitalized word "commission" shall hereinafter refer to said San Fernando Parks, Wellness and Recreation Commission or the recreation and community services commission.

(Ord. No. 1586, § 4, 3-16-2009; Ord. No. 1689, § 3, 11-18-2019)

Sec. 54-57. Composition and appointment of members; cultural arts liaisons.

- (a) The commission shall consist of five members, with full participation and voting rights. Each member shall be appointed by a different appointing councilperson, with such appointment to be ratified by the city council in accordance with the provisions of Government Code § 54974. Such members of the parks, wellness and recreation commission shall be registered voters and city residents.
- (b) The commission may also appoint a maximum of two persons to serve as cultural arts liaisons. The cultural liaisons: (i) shall serve in advisory capacity to the commission only; (ii) shall serve at the pleasure of the commission and the city council and may be removed and replaced at any time with cause or without cause by majority of either the commission's or the city council's full membership; (iii) shall not be considered members of the commission and shall have no right to vote on commission business; (iv) shall attend such meetings of the commission as may requested by the commission; and (v) may include nonresidents of the city. The commission reserves the right to develop such additional criteria for the appointment of cultural liaisons provided that such additional criteria is not in conflict with federal or state law, this Code or such other policies of the city as may be established and from time-to-time amended by the city council.

Sec. 54-58. Officers.

The commission's members shall select from among themselves commissioners who will serve in the capacity of chair and vice chair for the commission. In the absence of the chair and vice, any other member shall call the commission to order, whereupon a chair shall be selected from the members present to preside for that meeting. Cultural arts liaisons may not serve as chair, vice chair or any other commission officer.

¹Editor's note(s)—Ord. No. 1586, § 4, adopted Mar. 16, 2009, repealed the former Art. II, §§ 54-56—54-66, and enacted a new Art. II as set out herein. The former Art. II pertained to recreation and community services commission and derived from Code 1957, §§ 2.65, 2.66, §§ 2.69—2.74, §§ 2.76—2.78.

Sec. 54-59. Compensation of members.

The council shall fix the amount of compensation, if any, to be paid to commission members. Commissioners may not be compensated for any meetings or gatherings of the commission other than regular meetings of the commission.

Cultural arts liaisons shall not receive any compensation for their service as cultural liaisons.

(Ord. No. 1586, § 4, 3-16-2009; Ord. No. 1689, § 3, 11-18-2019)

Sec. 54-60. Meetings generally.

By resolution of the commission, the commission may establish a regular meeting schedule, provided that the commission shall schedule no more than one regular meeting each month. No meeting may be convened if city support staff is unavailable to participate in such meeting. Any adjourned meeting or special meeting requested by the commission shall be subject to the approval of the city manager based on the availability of city support staff to participate in such additional meetings. All meetings shall be subject to the provisions of the Ralph M. Brown Act (Government Code § 54950 et seq.).

Sec. 54-61. Quorum.

Three members of the commission shall constitute a quorum for the transaction of business, but a lesser number may adjourn from time to time for want of a quorum until a quorum can be obtained. Cultural arts liaisons shall not be counted to constitute a quorum.

Sec. 54-62. Absence from meetings.

- (a) Absence from three consecutive regular meetings of the commission by a member without the prior consent of the commission shall constitute an abandonment of the office and the absent commissioner's seat on the commission shall be deemed vacated. The vacancy thus created shall thereafter be filled by appointment by the city councilmember so assigned of a successor to fill the unexpired term of office.
- (b) Absence from three regular meetings of the commission in a 12-month period by a member without consent of the commission or absence from four regular meetings of the commission within a 12-month period by a member with the consent of the commission shall be deemed to constitute a retirement of such member, and the office shall become vacant. The vacancy thus created shall thereafter be filled by appointment by the city councilmember so assigned of a successor to fill the unexpired term of office. The city council shall comply with the provisions of Government Code § 54974 before filing any vacancy.

Sec. 54-63. Powers and duties generally.

The powers and duties of the commission shall be:

- (1) Initiating studies, investigations and surveys and making recommendations to the city council relative to the creation, operation, maintenance, management and control of the community recreation programs of parks, playgrounds and indoor and outdoor recreational activities.
- (2) Subject to the prior approval of the city council, adopting by resolution, rules and regulations not inconsistent with this Code and city ordinances, for the maintenance, improvement, use and operation of the parks, playgrounds, bathing facilities, recreation centers and other similar facilities of the city. A complete file of such rules and regulations shall be maintained in both the city clerk's office and that of the director of recreation and community services, with resolutions in the customary form and numbered numerically.
- (3) Participate in the development of a master plan for all parks and playgrounds owned and operated by the city and, upon approval of the plans by the city council, working consistently toward the achievement of the plan and for the improvement of the plan as originally approved.
- (4) Initiating studies, investigations and surveys and making recommendations to the city council relative to health, wellness and fitness, including such activities and programs created and/or maintained for the same by the director of recreation and community services.
- (5) Upon request of the city council, making other investigations, reports and recommendations upon subjects or other matters referred to it by the city council.
- (6) Planning and implementing cultural special events and planning and commissioning art in public places (e.g., murals, sculptures, city monuments, etc.).
- (7) Developing a list of activities that would be presented for council approval. Such activities will address a diverse and broad approach to culture, not any one culture. The activities would introduce the community to all cultures in this city and beyond.
- (8) Identifying and, subject to city council approval, securing outside funds to implement its activities, thereby saving city resources.

Sec. 54-64. Powers and duties concerning city-owned historic resources.

The following sites and improvements are declared by the city council to be historic resources. The commission shall have responsibility for programming the maintenance, improvement, use and operation of these city-owned historic resources, subject to approval by the city council:

- (1) The Lopez Adobe site at the southwesterly corner of the intersection of South Maclay Avenue and Pico Street.
- (2) Such other historic resources as the council shall from time to time select and add to this section by amendment.

Sec. 54-65. Rules and regulations.

Subject to the approval of the city council, the commission may make and alter such rules and regulations for its organization and procedures as are consistent with this article and other sections of this Code and city ordinances and with state laws.

Sec. 54-66. Reports and records.

The commission shall keep an accurate record of all its proceedings and transactions and shall render annually, on a calendar basis, a full report of the commission's transactions and recommendations to the council.

Sec. 54-67. Incurring financial liability.

Neither the commission nor any person connected with the commission shall incur any financial liability in the name of the city.

Subject: Report and Updates Regarding Park Renovation Projects

RECOMMENDATION:

It is recommended that the Parks, Wellness, and Recreation Commission (PWRC):

a. Receive and file a report updating the PWRC on the current park renovation projects; and

b. Provide staff with direction as appropriate.

BACKGROUND:

- The Recreation and Community Services (RCS) Department is currently managing three park renovation projects. The projects include the Layne Park Revitalization Project, the Las Palmas Park Revitalization Project, and the Pioneer Park Playground Renovation Project.
- 2. The City partnered with the Wild Horse Foundation in 2019 to establish sports programs and social services for the North San Fernando Valley community. The agreement with the Wild Horse Foundation included a renovation to the field house located at Pioneer Park. This facility became known as Puig's House and would serve as a home base for the Foundation's programs and services.

ANALYSIS:

Layne Park Revitalization Project

The design phase of the Layne Park project has been completed. RCS staff released a Notice Inviting Bids (NIB) requesting proposals for the construction of the Layne Park project on May 2, 2022. The available funds for construction were \$912,941. The engineer's cost estimate for the construction of the project is \$1,300,000.

A job walk for prospective bidders' was held at Layne Park to explain the revitalization project.

Staff from MIG (design firm), Public Works and the Recreation and Community Services Department facilitated the job walk detailing the renovation elements for the park. Four companies participated in the job walk, which included R.E. Schultz Construction, Inc., KASA Construction, Inc., Marina Construction, and Environmental Construction, Inc. Of the four companies that participated in the job walk only KASA Construction submitted a proposal for the project. Their bid is \$1,374,635.

At the October 3, 2022, City Council meeting, City Council members approved an allocation of an additional \$461,694 to fill the gap, and construct all of the renovations proposed in the project design. The Layne Park Revitalization Project will transform the neighborhood park and provide recreational opportunities for the residents. The park amenities that will be built include:

- A Restroom Facility
- A Sod Turf Soccer Field and Goals with a 10' High Wire Mesh Fence
- A Basketball Half Court with a 10' High Wire Mesh Fence
- ADA Playground Equipment Upgrades, Shaded Area
- Picnic Tables
- Educational Nature Feature "Bioswale"
- Drought Tolerant Landscaping and Trees
- A Decomposed Granite and Concrete Pathway, including Site Furnishings
- Green Alleyway 6'-8' Shrubs Along South Alleyway
- Three Rail Fencing at North Alleyway

A groundbreaking ceremony for the project is being planned for Mid-November. The exact day and time of the event are to be determined.

Las Palmas Park Revitalization Project

The RCS Department has identified RJM Design Group, Inc. to provide consulting services that will produce the project design, engineers' cost estimates, and construction specification documents for the Las Palmas Park Project. Staff has also released a Request for Proposals (RFP) to assist the RCS Department in gathering community feedback on what the vision of the Las Palmas Park Revitalization Project could be. Once the community engagement consultant is on board, a series of meetings will be held to gather residents' input.

The Las Palmas Park Revitalization Project will renovate the major recreation features of the park and some of the indoor features as well. The grant scope of the renovations includes:

- Renovation of the Playground Adding ADA Accessibly and Shading
- Renovation of the Basketball Court with Lighting
- Construction of a New Tennis/Pickleball Court with Lighting
- Construction of a New Splash Pad

- Renovation of Three Baseball Fields with Lighting
- Renovation of the Concession Stand
- Renovation of the Outside Restrooms
- Construction of a New Multi-Purpose Field with Lighting
- Renovation of the Outdoor Exercise Equipment
- Renovation of the Picnic Shelters and Walking Path Lighting
- Construction of New Landscaping Throughout the Park
- Renovation of the Recreation Center/Learning Center Including 2 Patio Restrooms

Similar to the Layne Park project, the final design of the Las Palmas Park Revitalization Project will depend on the community's input. However, any major recreation feature that is changed or altered significantly must be approved by the State.

Pioneer Park Playground Renovation Project

The Recreation and Community Services Department has released a Notice Inviting Bids for the design and installation of a new playground and outdoor exercise equipment at Pioneer Park. The renovation design for the project shall incorporate community feedback from the Pioneer Park neighborhood residents.

The major features of the renovation include ADA accessibility, inclusive play elements, and shading for the playground area. In addition, the renovation will include outdoor exercise equipment adjacent to the playground.

The firm selected to provide community engagement for the Las Palmas Park project will also gather feedback for this project as well. Addressing ADA accessibility for our playgrounds is very important to the City Council. All three park renovation projects will include design elements to make the City's parks and playgrounds all abilities accessible.

Puig's House

The Wild Horse Foundation has completed renovating the inside of the Puig House. The Foundation still needs to install kitchen equipment and office furniture. The outside back patio will have decomposed granite and a fence will surround the house in the future.

The Foundation's plan to provide youth sports and social service programs has not materialized to date. The Covid-19 shutdown created a great void in service for the foundation. The RCS Department is actively looking for NGO's to collaborate with in order to provide programs and services for the residents in and around Pioneer Park.

Subject: Discussion Regarding Developing a Community Theatre Program

RECOMMENDATION:

BACKGROUND:

- On or about September 10, 2020, the Recreation and Community Services Department hosted a meeting to establish a community theatre program in San Fernando. This initial meeting created synergy and enthusiasm among the meeting participants. Starting a community theatre looked promising and additional meetings were held to begin the planning process for the program
- 2. Due to the Covid-19 pandemic, all of the RCS Department programs were shut down. The only programming the Department offered was virtual. The online platform for conducting activities was not conducive to a Community Theatre program. Hence, the once vibrant individuals who showed interest in the program faded away, and the program was at a standstill.

ANALYSIS:

One of the biggest takeaways from the stoppage of the Community Theatre program is the need for a theatre director. This would require an individual with the ability to hold the program together. The misstep the Department took was to rely on volunteers to conduct the program. This was exacerbated by the pandemic shutdown.

RSP assistance is available for all recreational programs offered by the Department, including programs for youth, adults, and seniors. Scholarships cover 50% of the cost of the activity.

All residents are eligible for RSP assistance on a first-come, first-serve basis.
