RECOMMENDATION:

Subsequent to the preparation of the staff report, an update Delinquent Charges Report of Past Due Accounts for Commercial Municipal Solid Waste Collection and Disposal Services was received from Republic Services, the City's franchise solid waste contractor.

It is recommended that the City Council approve the final form of the updated Delinquent Charges Report for past due accounts for commercial municipal solid waste collection and disposal services, and authorize submittal of the updated Delinquent Charges Report to the Los Angeles County Auditor-Controller for collection on the 2023-2024 property tax roll.

BACKGROUND:

ADMINISTRATION DEPARTMENT

The Delinquent Charges Report in the agenda packet as Agenda Staff Report Item No. 7, includes 47 commercial/industrial delinquent accounts with outstanding fees totaling \$57,906.23 as of July 31, 2023.

An updated Delinquent Charges Report (Attachment "A"), received on August 7, 2023 from Republic Services, reflects the removal of 19 delinquent accounts from residential customers. This removal results in a fee reduction of \$16,482.18 in outstanding fees. The updated Delinquent Charges Report currently comprises 28 remaining delinquent commercial/industrial accounts, which total \$41,424.05 in outstanding fees.
