NEW BUSINESS

1. DISCUSSION OF UNLICENSED DRIVER PROGRAM (MOHR) – Chair Mohr recently participated in a DUI checkpoint and was surprised with the number of drivers driving in San Fernando without the proper license to be driving. Chair Mohr hopes the Commission can recommend more education and possibly an online citywide test preparation to help increase the number of people that take the test.
