### REQUIREMENTS

Applicants submitting an Application for the Issuance of a License to Carry a Concealed Firearm/Weapon (CCW) may be denied or have their licenses revoked if they are ineligible or are otherwise deemed unsuitable to own, possess or carry a firearm, as the case may be, for any of the reasons set forth below.

The list below is not exhaustive and there may be other circumstances in which the issuing authority may deny or revoke a license to carry a concealed firearm. By initialing in the spaces provided and signing this document under the penalty of perjury, applicants shall confirm that none of the reasons set forth below are applicable to them.

A conviction for a crime of Moral Turpitude including but not limited to (fraud, theft, tax evasion, issuing bad checks, robbery, bribery, perjury, extortion, arson, rape, terrorism, burglary, attempted lewd acts on a minor, child abuse, felon in possession of firearm, falsifying government records, forgery, receiving stolen property, burglary, vandalism, kidnapping). <i>I confirm that I do not meet any of the criteria set forth above.
