2. DEPARTMENT PROGRAMS AND SERVICES UPDATE

M. Perez reported that all the programs and services are up and running in the Recreation and Community Services Department. The Holiday Tree Lighting event was a great success. Senior programs paused for a short period during December, but now are in full swing. Youth Basketball is beginning this Saturday. Mission City Baseball will begin in February. Adult sports are making a comeback this spring. New leisure classes are now offered, such as the Academic Drawing Class and a new class introducing contact-free martial arts.

Commissioner Friend thanked staff and commented that she is looking forward to the programs and events offered by the RCS Department.

Commissioner Sanchez-Brooks commented that she is excited for baseball season to begin.

Vice Chair Lopez asked if there is a program and event calendar available. She also asked about outreach to seniors who may not have internet access. Staff reported that brochures and monthly calendars are available on the City website. Hardcopies are available at Las Palmas Park. Information can also be sent by U.S. mail upon request. Staff will email the winter brochure to commissioners.

STAFF COMMUNICATION

Staff informed the Commission that applications for the veteran banner program will be available in February. Banners will be displayed from November through May.

Movement for Life exercise class is offering a free demonstration on January 25th. The class will be offered monthly in February. Technology Workshops will be offered beginning in February to teach seniors the basics of navigating a computer. Classes are available in Spanish and English. Matinee afternoons are back at Las Palmas beginning in February. A workshop will be offered on February 6th to learn how to make a lovely Valentine's Day card. On February 14th, Las Palmas Park will host La Amistad Café. In partnership with Optum Health Group, a Café Lounge at Las Palmas Park will offer coffee, tea, and pastries and provide an opportunity to celebrate love and friendship on Valentine's Day.

Staff reported that the 3Wins Fitness Program will now be an in-house led program. Dr. Loy has retired but the program will continue to operate under the instruction of City staff. The goal is to continue offering this free and popular program to the community.

RECOMMENDATION:

It is recommended that the Parks, Wellness and Recreation Commission:

- a. Receive and file a report regarding the Food Security Ad Hoc Committee's strategies to address food insecurity in the community; and
- b. Provide recommendations as appropriate.

BACKGROUND:

- 1. On April 17, 2023, Mayor Celeste Rodriguez and Councilmember Mary Solorio recommended the establishment of a Food Security Ad Hoc Committee.
- 2. On April 17, 2023, the City Council voted and approved the committee.
- 3. The Food Security Ad Hoc Committee has been meeting and planning on offering various new programs such as a City-run food pantry, collaborating with Los Angeles Regional Food Bank in March 2024, and providing additional food resources to families.

ANALYSIS:

Food security is defined as all people, at all times, having access to sufficient, safe, and nutritious food to meet their dietary needs. Although there are a number of supermarkets, restaurants and healthy food vendors within the City of San Fernando, not all people have physical and economic access to these markets. Alternatively, access to fast food restaurants within the city is also notable. Prevalence and access of fast food within an area has been linked to poorer health outcomes associated with diabetes, weight gain and other health challenges.

Food security is also an important aspect of social justice. Nutritious food should be accessible regardless of socioeconomic status. Having the ability to meet this basic need contributes to overall community health, quality of life and can reduce the burden on healthcare systems.

Previous Food Access Programs

Between 2017 and 2019, the City collaborated with Los Angeles County to provide free lunches at Recreation Park to all children during the summer school break. This changed to a grab and go program during the COVID-19 lockdown. As the impacts of the pandemic continued throughout 2020, the Recreation and Community Services Department provided six monthly food box distributions to residents who registered through the City website. Each box contained facemasks, cleaning products, and over \$150 worth of food items. Over \$80,000 of food and products were purchased and distributed to residents between October 2020 and May 2021.

Current Food Access Programs

Currently, Las Palmas Park hosts the congregate Elderly Nutrition Program (ENP) in which seniors are able to eat a hot lunch five days per week in a social setting. The program also provides home delivered meals (HDM) to seniors who are ill or disabled and cannot physically attend the park to eat lunch. Las Palmas Park also hosts the Los Angeles Regional Food Bank once a month, where seniors can pick up a meal kit. Please see the following table illustrating program data gathered during 2023:

Staff recently finalized the food distribution calendar for the public to be informed of where they can obtain food in the City as well as in nearby communities (Attachment "A"). The calendar also has additional food resources such as CalFresh, WIC, and the Business and Community Resource Center.

In November 2023, the city celebrated the grand opening of the Business and Community Resource Center (BCRC), which was created to bring resources to the community. On Mondays and Wednesdays, Home Again LA has office hours at the BCRC to assist patrons in applying for

available social services such as CalFresh. CalFresh is a statewide program that provides an essential hunger safety net for those that qualify. Beginning in March 2024, Home Again LA will be providing two workshops every month related to nutrition, thereby strengthening the community to make informed decisions about their health and wellbeing.

Food Security Ad Hoc

The Food Security Ad Hoc was formed by Mayor Rodriguez and Councilmember Solorio to explore all of the potential partnerships that can be fostered. Organizations such as M.E.N.D., North Valley Caring Services, Los Angeles Regional Food Bank, local churches, and local food pantries, will be targeted for these new partnerships. In addition, after reviewing current food resources, it was recognized that the city is supporting seniors and can support expanding services to individuals and families. As such, the Ad Hoc has worked with staff to develop a resource guide that will be made available to the public that identifies the different programs and opportunities for those in need of food.

Future Food Access Programs

As part of their scope of work, the Food Security Ad Hoc is soliciting public feedback regarding potential partnerships, available resources, and any additional needs the community may have relating to food security. Specifically, the Ad Hoc is exploring the development of a dry foodbank, approved by City Council on October 16, 2023, and intentional connections between resources to promote CalFresh enrollment, available resources and upcoming events.

BUDGET IMPACT:

There is no budget impact to receive and file this report regarding the Food Security Ad Hoc Committee.

CONCLUSION:

It is recommended the Parks, Wellness and Recreation Commission receive and file this report regarding the Food Security Ad Hoc Committee's strategies to address food insecurity in the community, and make recommendations as appropriate.

RECOMMENDATION:

BACKGROUND:

- 1. The mission of the Recreation and Community Services Department (RCS) is to develop and implement enriching community, cultural, and recreational opportunities that foster the overall well-being and personal development of our community.
- 2. The RCS Department conducts a wide array of programs, services, activities, and business throughout the year. Staff provides a monthly update on items discussed at the Parks, Wellness, and Recreation Commission (PWRC) meetings and welcomes any guidance or recommendations regarding the items presented.

DEPARTMENT UPDATES:

Programs and Services

The RCS Department provides a variety of programming and services for the San Fernando community. All Los Angeles County Department of Public Health protocols and Best Practices guidelines for operating recreational facilities are strictly adhered to. Safety is the top priority for RCS staff when conducting activities for the community. All program participants and park visitors are made aware of safety guidelines being implemented to ensure patrons feel safe while participating in the Department's programs.

Los Angeles Regional Food Bank Distribution

The Regional Food Bank monthly distribution was held on February 5, 2024 from 9:00am-11:00am. This program continues to serve seniors age 60+ on a monthly basis at Las Palmas Park. This drive-through food program provides a free food kit containing nutritious items such as meats, canned fruits and vegetables, cereals and grains. The program serves an average of 150 seniors monthly. The next distribution will be held on March 4, 2024. SENIOR SERVICES

Senior Meals

In partnership with ONEgeneration, Las Palmas Park continues to host the Elderly Nutrition Program (ENP) for seniors. Free nutricious hot meals are served Monday through Friday. The program also provides meals five days a week for folks that are homebound, registration and home assessment required. The program is free for senior 60+ with a suggested donation of \$3.

Intro to Computers for Seniors

The program is designed to teach seniors the basics of technology such as navigating a computer and registering for an email address. Workshops are offered in English and Spanish on Wednesday mornings at Las Palmas Park.

La Amistad Café

In honor of Valentine's Day, Las Palmas Park is partnering with Optum to host a café social on February 14th. All are welcome to stop by and enjoy a delicious cup of coffee or tea with tasty pastries.

Charla con Dra. Janet Yanez

On February 8th, Alzheimer's Los Angeles hosted a workshop on brain health and how to communicate with your doctor when addressing symptoms related to cognitive function. This particular workshop was offered in Spanish, attendees enjoyed light refreshments and learned some valuable tips.

Complete a workout, set a goal and drink some water are all examples of the challenges on the bingo card. Those that achieve a "bingo" will be able to submit their cards into a drawing at the end of the month for some fun prizes.

Inclusive Zumba will host a special Friendship class during the month of February in honor of Valentines Day. Particpants will be encouraged to dress in their Valentines' best and showcase their dance moves. The monthly class themes are a collaboration between the instructor and staff to keep the special needs participants motivated and engaged.

Youth Sports

The winter season of Youth Basketball is underway serving over 90 participants ages 7-15. Catch all the action on Saturday mornings now through mid-March at Recreation Park from 9am-2pm.

Spring season of Mission City Baseball is just around the corner. Staff held a coach's meeting on January 31st and player tryouts on February 3rd. Depending on registrations, the league will plan to interlock with surrounding Pony leagues for games this coming Spring.
