Subject: April 2024 Notable Police Department Events and Activities

RECOMMENDATION:

It is recommended that the Transportation and Public Safety (TPS) Commission receive and file this informational report.

BACKGROUND:

Each month at the City of San Fernando Transportation and Public Safety Commission meeting, the Police Department submits and provides the governing board a brief overview of the previous month's community engagement activities, noteworthy incidents, and proactive enforcement.

ANALYSIS:

The San Fernando Police Department (SFPD) has recently heightened and further integrated its community profile in three major areas: Community Engagement, Proactive Enforcement and Quality of Life Enhancements.

For the month of April, the SFPD has the following activities and incidents to report:

COMMUNITY ENGAGEMENT:

1. Community Academy:

The Third Class of the SFPD Community Academy commenced on Tuesday, April 16, 2024, at 6 PM in the City Council Chambers. Session 1 included a Welcome, Meet and Greet with City Manager Nick Kimball, Chief Fabian Valdez, and A/Lieutenant Chiasson, as well as an overview of the syllabus and the Academy. Additionally, the functions of the Federal, State, and Local Government were discussed.

Session 2 of the Community Academy took place on Tuesday, April 23, 2024, at 6 PM in the City Council Chambers. This session featured an introduction to City Government by City

Manager Nick Kimball and a presentation on Constitutional Law and Judicial Procedures by Detective Jorge Cervantes.

Session 3 of the Community Academy was held on Tuesday, April 30, 2024, in the City Council Chambers. A/Lieutenant Walter Dominguez conducted a presentation on patrol functions and procedures, while A/Lieutenant Chiasson conducted a presentation on Use of Force Case Law and Policy.

2. Parent Academy:

Session 3 of the Parent Academy took place on Thursday, April 4, 2024, at 9 AM at the Cesar Chavez Learning Academies (CCLA), focusing on the topic of social media safety.

Session 4 of the Parent Academy was held on Thursday, April 11, 2024, at 9 AM at CCLA. This session addressed how to assist children and teenagers in coping with family crises, divorce, and parental separation.

Session 5 of the CCLA Parent Academy occurred on Wednesday, April 17, 2024, at 9 AM; covering topics such as dating, conflict resolution for teenagers, as well as gang and drug prevention and intervention.

Session 6 of the CCLA Parent Academy was held on Thursday, April 25, 2024, at 9 AM. This session focused on establishing healthy boundaries and positive behavior correction (discipline) for children and teenagers.

3. Neighborhood Watch Meeting:

The monthly Neighborhood Watch Meeting was held on Wednesday, April 17, 2024 at 6 PM in the City Council Chambers.

4. Business Watch Meeting:

SFPD held its monthly Business Watch Meeting on April 24, 2024 at 12 PM in the City Council Chambers. Attendees discussed Part 1 Crime Statistics for March and participated in a Question and Answer Session.

NOTEWORTHY EVENTS:

1. On Monday, April 1, 2024, around 1:58 AM, an SFPD Officer observed a male subject inside a vehicle in the area of Celis Street and South Workman Street. The officer approached the subject and began a conversation with him. The officer later learned that the subject had a DUI warrant issued for his arrest. During a vehicle search, the Officer found a nitrous oxide tank and balloons. The subject was subsequently arrested for the DUI warrant, possession of nitrous oxide, and possession of a controlled substance.

- 2. On Wednesday, April 3, 2024, SFPD participated in Pre-Migration Testing for the Next Generation 9-1-1 (NG 9-1-1) system. This testing encompassed a thorough series of tests to confirm the readiness of the Department's Public Safety Answering Point (PSAP) for migration to the NG 9-1-1 network. The objective was to minimize or eliminate functional changes following the migration to NG 9-1-1.
- 3. On Saturday, April 13, 2024, around 11:07 PM, SFPD Officers were dispatched to a domestic disturbance in the 600 Block of North Meyer Street. When they arrived, officers interviewed both parties involved in the altercation and noted injuries on both individuals. Both parties were arrested for domestic violence.
- 4. On Sunday, April 14, 2024, around 7:53 PM, SFPD Officers received a report of a violation of a restraining order at a residence in the 1900 Block of Knox Street. When officers arrived, a family member directed officers to the location of the suspect. The suspect was found in a bedroom and detained for further investigation. Following interviews with all parties involved, the suspect was arrested for violating of a court order.
- 5. On Monday, April 15, 2024, around 10:12 PM, SFPD Officers responded to a request to keep-the-peace from a victim of robbery and domestic violence that had occurred the previous week in the 400 Block of Harps Street. When officers arrived, they located the suspect standing in the middle of the street. The suspect was arrested for robbery and domestic violence. An emergency protective order was obtained for the victim, and her stolen items were recovered and returned.
- 6. On Tuesday, April 16, 2024, around 11:19 PM, an SFPD Officer conducted a traffic stop near the intersection of Hubbard Street and Eighth Street. While approaching the vehicle, the Officer smelled a strong odor of cannabis emanating from the vehicle. Subsequent investigation revealed approximately 11 pounds of cannabis and \$3,200 in cash. The driver, who claimed to be from Georgia, admitted intent to sell the cannabis in California. The driver was subsequently arrested for possession of marijuana with intent to sell.
- 7. On Tuesday, April 16, 2024, at approximately 3 AM, SFPD Officers responded to a report of unusual noises heard inside the Poverello of Assisi Retreat, located in the 1500 Block of Woodworth Street. Two of the nuns heard what sounded like a person inside of the Covent kitchen area. When Officers arrived, they checked the inside of the Convent and did not locate anyone. Officers walked across the property and noticed a blanket outside of the laundry room, and smelled an unknown burning odor coming from the laundry room. Officers entered the laundry room and located a male suspect inside. They detained him for trespassing. The suspect claimed that he was burning his hair inside the laundry room. He also was in possession of methamphetamine and a methamphetamine pipe. He was arrested for criminal trespassing, possession of methamphetamine, and possession of drug paraphernalia.

8. On Wednesday, April 17, 2024, around 9:47 PM, SFPD Officers responded to a solo vehicle rollover traffic collision at Truman Street and South Workman Avenue. The vehicle overturned after striking an Edison power pole and came to rest in the KFC parking lot on San Fernando Road, causing a city-wide power outage. Witnesses estimated the vehicle was travelling at 100 miles per hour before the crash. The Los Angeles Fire Department (LAFD) responded to the scene and transported the suspect to the hospital for medical treatment. Prior to transport, LAFD personnel found methamphetamine in the suspect's pants pocket.

While at the hospital, the suspect stated that he was trying to kill himself by overdosing on fentanyl, but was only able to smoke methamphetamine. Based on these statements, the suspect was placed on a WIC 5150 WIC, 72-hour hold for attempted suicide and suicidal ideations. An arrest warrant will be sought at a later date.

9. On Friday, April 19, 2024, at 6:45 PM, the SFPD Officers received a Flock ALPR camera alert indicating a stolen car in the parking lot of the Home Depot on Foothill Boulevard. Officers arrived on scene and located the vehicle that was captured by the Flock camera in the parking lot. A traffic stop was attempted, but the stolen vehicle did not pull over and a vehicle pursuit ensued. The chase ended when the vehicle evaded officers in the area of Foothill Boulevard and Lopez Canyon Road.

During the pursuit, one of the officers visually identified the suspect as a Pacoima gang member. SFPD officers informed the Los Angeles Police Department (LAPD) about the incident and provided a description of the suspect. LAPD was notified of the stolen vehicle's presence in the Foothill Boulevard and Lopez Canyon area.

At 4:45 AM, SFPD received notification from LAPD that they had located the vehicle and apprehended the suspect.

- 10. On Monday, April 22, 2024, at about 4:30 PM, a SFPD Officer responded to a report of an altercation between two females. One of the women was arrested for child endangerment and robbery. The child present during the altercation was placed in police care until a responsible family member arrived to take custody of the child.
- 11. On Tuesday, April 23, 2024, around 11:38 AM, SFPD received a Flock ALPR camera alert for a stolen vehicle that had been involved in a theft incident at the Target on Foothill Boulevard on April 20, 2024 and returned to the area. Officers responded, located the vehicle and initiated a traffic stop. The passenger of the vehicle fled on foot. However, the driver was subsequently arrested for grand theft auto and shoplifting.


