Subject: Annual Reorganization of the Commission – Selection of Chair and Vice Chair

RECOMMENDATION:

It is recommended that the Transportation and Public Safety Commission proceed with its annual reorganization of the Commission and the selection of its Chair and Vice Chair

BACKGROUND:

1. The Transportation and Public Safety Commission is composed of five members – each appointed by a different councilmember.
2. Each year, the members shall elect a Chair and Vice Chair per Municipal Code 1957, § 13.25, Section 90-71 (Attachment “A”).
3. On April 18, 2024, the position of Chair held by Chair Adriana Gomez became vacant.
4. On August 1, 2024, the reorganization of the Transportation and Safety Commission meeting was tabled.

ANALYSIS:

In accordance with Municipal Code 1957, § 13.25, Section 90.71, the Traffic and Public Safety Commission shall meet annually to choose one of its members as Chair and another of its members as Vice Chair. The terms of office of the Chair and Vice Mayor shall be for one year.

BUDGET IMPACT:

There is no budget impact associated with the annual reorganization of the Transportation and Public Safety Commission.

CONCLUSION:

Staff recommends that the Transportation and Public Safety Commission select a Chair and Vice Chair in accordance with Municipal Code 1957, §13.25, Section 90.71.

ATTACHMENT:

A. Municipal Code 1957, §13.25, Section 90.71

Sec. 90-71. Established; composition; appointment and compensation of members; officers.

- (a) There is established a transportation and public safety commission of five members to be appointed by a different appointing councilperson, with such appointment to be ratified by the city council. Each member shall have full participation and voting rights. Each member shall also be a registered voter and city resident. Such members so appointed shall be persons who do not hold any office or position with the city. The terms of office of each member shall be one year.
- (b) The members shall organize the transportation and public safety commission and shall elect a chair and vice-chair. In the absence of the chair and vice-chair, any other member shall call the commission to order, whereupon a chair shall be elected from the members present to preside for that meeting.

Subject: June-July 2024 Notable Police Department Events and Activities

RECOMMENDATION:

It is recommended that the Transportation and Public Safety (TPS) Commission receive and file this informational report.

BACKGROUND:

Each month at the City of San Fernando Transportation and Public Safety Commission meeting, the Police Department submits and provides the governing board a brief overview of the previous month's community engagement activities, noteworthy incidents, and proactive enforcement.

ANALYSIS:

The San Fernando Police Department (SFPD) has recently heightened and further integrated its community profile in three major areas: Community Engagement, Proactive Enforcement and Quality of Life Enhancements.

For the months of June and July 2024, the SFPD has the following activities and incidents to report:

COMMUNITY ENGAGEMENT:

1. Community Academy:

Session 8 of the SFPD Community Academy was held on Tuesday, June 4, 2024, in the City Council Chambers. FTO Talbot provided attendees with a lectures on Accident Investigations, Driving Under the Influence of Alcohol/Narcotics, and First Aid.

Session 9 of the SFPD Community Academy was held on Tuesday, June 11, 2024, in the City Council Chambers. CSO Herrera provided the attendees with a presentation on Community Services/Parking Enforcement. Senior Lead Desk Officer provided a presentation on the Communications Division. Reserve Captain Fandino Sr., provided a presentation on SFPD's

Reserve Division, and Reserve Sergeant Miranda provided a presentation on the Police Explorer Post.

Session 10 of the SFPD Community Academy was held on Tuesday, June 18, 2024, in the City Council Chambers. Records Bureau Supervisor Sylvia Ortega, Records Specialist Isabell Rodriguez, Cadet Cruz and Cadet Valle, provided attendees with a presentation of the functions of Records Bureau. Property Control/Evidence Control Officer Marlene Martinez provided participants with a presentation on the functions of Property Control/Evidence Bureau.

On June 25, 2024, San Fernando Police Community Academy Class 3 celebrated its Academy Culmination after 11 weeks. Eight attendees, all local residents or business owners, received certifications for their completion of the program.

On Tuesday, July 16, 2024, members of Community Academy, Class #3, participated in the Inveris Simulator and conducted various training scenarios.

2. **Neighborhood Watch Meeting:**

The monthly Neighborhood Watch meeting was held on Thursday, June 27 and Wednesday July 17, 2024 at 6 PM in the City Council Community Room. Detective Jorge Cervantes reviewed May and June 2024 crime statistics and responded to questions and concerns from residents.

3. **Business Watch Meeting:**

The monthly Business Watch meeting was held on Wednesday, June 26 and Wednesday, July 24, 2024 at 12 PM, in the City Council Chambers. Detective Jorge Cervantes reviewed May and June 2024 crime statistics and responded to questions and concerns from business owners.

4. **Special Olympics Torch Run:**

On Wednesday, June 5, 2024, Team San Fernando made up of SFPD officers, Police Department professional staff, City employees, Los Angeles School Police Department Personnel, Department of Motor Vehicles Investigators, and California Department of Alcoholic Beverage Control personnel, participated in the Annual Law Enforcement Torch Run. The participants ran alongside Special Olympians, carrying the "Flame of Hope" torch through the City of San Fernando along a 2.5-mile route. This annual event supports the Special Olympics of Southern California.

NOTEWORTHY EVENTS:

1. On Monday, June 3, 2024, around 6:30 PM, SFPD Dispatch received a call about an attempted kidnapping of a 14-year-old girl from the bus stop in front of Denny's (1041 Truman Street). According to the victim, the suspect, a 62-year-old registered sex offender from San Fernando, drove up to her in a van and offered money for a sexual encounter. When she rejected his offer, he tried to pull her into his van. She escaped and reported the incident.

SFPD Officers and Detectives reviewed footage from the Flock camera system and obtained evidence placing the van at the crime scene. Following an investigation, the suspect was arrested. The District Attorney has filed the following charges: attempted kidnapping with intent to rape, battery with intent to rape, providing false information to a peace officer, failing to register as a sex offender, and possession of a forged ID.

2. On Thursday, June 6, 2024, at approximately 3:45 PM, SFPD received a Flock alert for a stolen vehicle in the area of Glenoaks Boulevard and North Maclay Avenue. An officer responded to the area and located the stolen vehicle, which was occupied by one female adult. The driver was subsequently arrested for grand theft auto.
3. On Friday, June 7, 2024, at approximately 12:49 AM, SFPD officers responded to a report of a suspicious individual circling a vehicle in the 1000 block of North Brand Boulevard. Officers made contact with the individual and detained him for further investigation. It was discovered that he had three outstanding warrants, one of which was for a DUI arrest in the City of San Fernando. The individual was subsequently arrested for the outstanding warrants.
4. On Sunday, June 9, 2024, at approximately 12:34 PM, SFPD officers responded to a report of a robbery in progress in the 9000 block of Maclay Avenue. Witnesses reported that a male subject, armed with a knife, had forcibly taken a bicycle from another person. After conducting an investigation, officers arrested the suspect for assault with a deadly weapon and robbery.
5. On Friday, June 14, 2024, at around 11 PM, SFPD officers observed a male subject defacing the roll-up doors of the vacant Firestone building at the corner of Maclay Avenue and Truman Street. When officers approached him, he fled on foot. Following a pursuit, the subject was apprehended and found in possession of a spray can. He was arrested for vandalism and resisting arrest.
6. On Thursday, June 20, 2024, SFPD received a Flock alert of a vehicle involved in repeated theft of Lego sets from Target. The vehicle had entered the Target parking lot. Detectives and patrol officers set up a containment in the shopping center parking lot and observed two suspects exiting the van and entering the Target store. Target's Loss Prevention personnel was notified of the situation and began monitoring the suspects. They witnessed the suspects committing theft of Lego sets and other merchandise totaling approximately \$460 while being monitored.

The suspects exited the store with the stolen merchandise and got back into the van. The vehicle with the suspects attempted to flee, but finally stopped after being surrounded by police. Three adults were arrested for burglary, grand theft, and conspiracy.

7. On Thursday, June 27, 2024, around 11:30 AM, SFPD Dispatch received a Flock alert of a stolen vehicle at the intersection of North Maclay Avenue and Glenoaks Boulevard. Officers searched the area and located the stolen vehicle at the intersection of Glenoaks Boulevard and Orange Grove Avenue. The suspects, who were still in the vehicle, fled on foot when they saw the Officers approaching them. One suspect was arrested for grand theft auto.
8. On Thursday, June 27, 2024, around 12:23 PM, SFPD received a Flock alert of a stolen vehicle at the intersection of Wolfskill Avenue and Truman Street. An Officer searching the area located the vehicle at San Fernando Road and Paxton Street and pursued the vehicle to the intersection of Van Nuys Boulevard and Tamarack Street, where the suspect vehicle came to a stop. A traffic stop was conducted and two suspects were detained. One suspect was arrested for grand theft auto and another for possessing a fake California identification card. The stolen vehicle was subsequently recovered and stored.
9. On Thursday, June 27, 2024, at approximately 1:26 PM, SFPD Officers responded to a shoplifting investigation in the 1200 Block of North Maclay Avenue. They made contact with the subject, who fled on foot. The suspect was arrested for resisting arrest, possession of drug paraphernalia, and a parole and burglary warrant.
10. On Friday, June 28, 2024, at about 11:27 AM, SFPD received a FLOCK alert of a stolen vehicle. An Officer located the vehicle at San Fernando Road and South Brand Boulevard. A traffic enforcement stop was initiated, but the vehicle, driven by a female suspect, failed to yield. A pursuit ensued. The suspect crashed into a parked vehicle at Fox Street and Celis Street, then fled on foot. She was arrested felony reckless evading, grand theft auto, resisting arrest, possession of methamphetamine, and possession of methamphetamine.
11. On Saturday, June 29, 2024, around 11:14 AM, SFPD Officers responded to a neighbor dispute in the 200 Block of North Huntington Street. During their investigation, they learned that one of the parties had stabbed the victim in the neck and vandalized his vehicle with a key. The subject was arrested for assault with a deadly weapon and vandalism.
12. On Thursday, July 4, 2024, around 7:46 AM, SFPD Officers responded to a non-injury traffic collision in the 500 Block of Arroyo Avenue, where a vehicle had collided with a curb. The driver was arrested for driving under the influence of alcohol and his vehicle impounded.
13. On Thursday, July 4, 2024, at approximately 7:33 PM, a SFPD Officer received a Flock notification about a stolen vehicle near the 12900 block of Foothill Boulevard. The officer located the vehicle near the McDonald's parking lot at 12950 Foothill Boulevard.

The officer requested additional units for backup and then attempted to conduct a high-risk traffic stop. The vehicle failed to yield, initiating a high-speed pursuit throughout the East San Fernando Valley. The pursuit ended at an apartment complex in the 8000 block of Wyngate Place in Los Angeles, where the driver rammed the complex gate and then backed into an officer's unit. The driver then fled into the apartment complex and into an open garage. SFPD and LAPD officers formed a perimeter around the residence and the Burbank PD K9 searched for the driver. The driver was eventually arrested for felony reckless driving, evading a police officer, burglary, grand theft auto, driving without a license, and resisting arrest.

14. On Saturday, July 6, 2024, around 11:52 AM, an SFPD Officer conducted a traffic enforcement stop in the 400 Block of Hagar Street. During the Officer's investigation, the officer discovered that the vehicle was stolen. The driver was subsequently arrested for grand theft auto, possession of a burglary tool, and driving without a license.
15. On Monday, July 8, 2024, at approximately 1 PM, a SFPD officer observed a possible shoplifting incident in the parking lot of 12920 Foothill Boulevard. After an investigation, he arrested an adult female for shoplifting and outstanding warrants.
16. On Monday, July 8, 2024, at approximately 8:16 PM, a SFPD officer conducted a traffic stop at Glenoaks Boulevard and North Maclay Avenue. During the traffic stop, officers discovered the driver of the vehicle was unlicensed. The officer removed the driver from the vehicle and, during a pat down search, retrieved a firearm from the driver's front waistband. The driver was arrested on multiple gun charges.
17. On Tuesday, July 9, 2024, at approximately 12:50 PM, SFPD officers responded to a report of a structure fire in the 1500 block of Glenoaks Boulevard. The fire, located on the roof of the building, was extinguished by LAFD.
18. On Tuesday, July 9, 2024, at approximately 1:13 AM, a SFPD Officer attempted to conduct a traffic stop at Fourth Street and Alexander Street. The driver eventually stopped at First Street and Harding Avenue, where the driver and two passengers were detained. A search was conducted and during their search, Officers found one bag containing narcotics and one bag containing a firearm. All three subjects were arrested.
19. On Wednesday, July 10, 2024, at approximately 11:30 AM, SFPD officers conducted a traffic stop on a vehicle without license plates at North Maclay Avenue and Second Street. Officers contacted the driver and passenger. The driver admitted to possessing a methamphetamine pipe. The driver was arrested for possession of methamphetamine with intent to sell, possession of a controlled substance for sale, possession of marijuana for sale, possession of drug paraphernalia, and driving without a license. The passenger was also found in possession of contraband and arrested for possession of methamphetamine with intent to sell, possession of a controlled substance for sale, possession of marijuana for sale, violating parole, and a DUI warrant.

21. On Monday, July 15, 2024, at 8:27 PM, SFPD officers responded to the 500 block of San Fernando Mission Boulevard on reports of an injury traffic collision in the area. Officers found two individuals in damaged white sedan severely injured. One of the severely injured parties in the white sedan was transported to the hospital and died a short time later from her injuries. The deceased party was identified Yadira Caamal, a 45-year old resident of San Fernando. The driver of the white sedan was transported to Providence Holy Cross Hospital with life-threatening injuries and remains in critical condition. The driver of the other vehicle involved was a juvenile who was transported to Providence Holy Cross Hospital with non-life-threatening injuries. This case is currently under investigation by the San Fernando Police Detective Bureau.

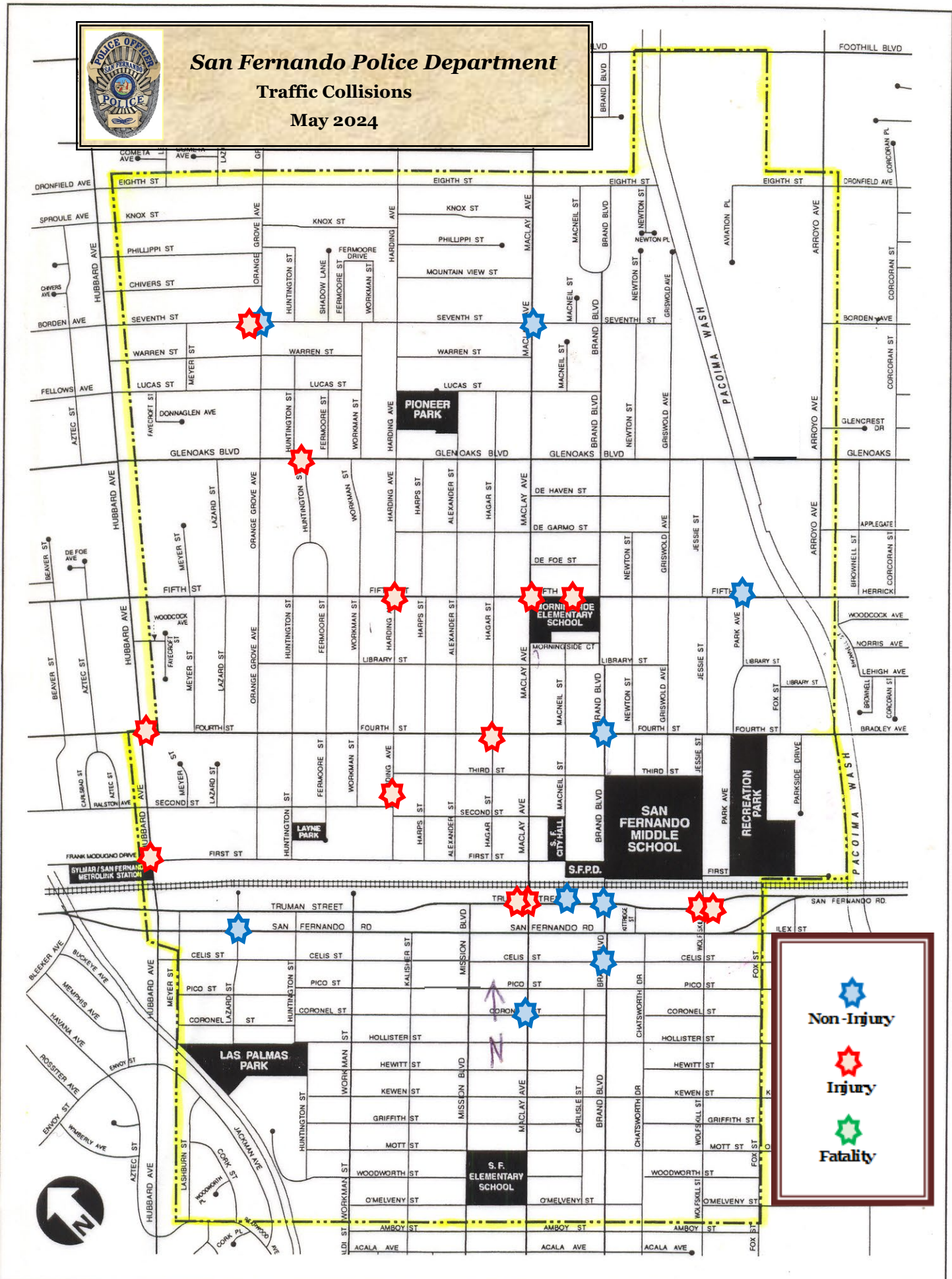

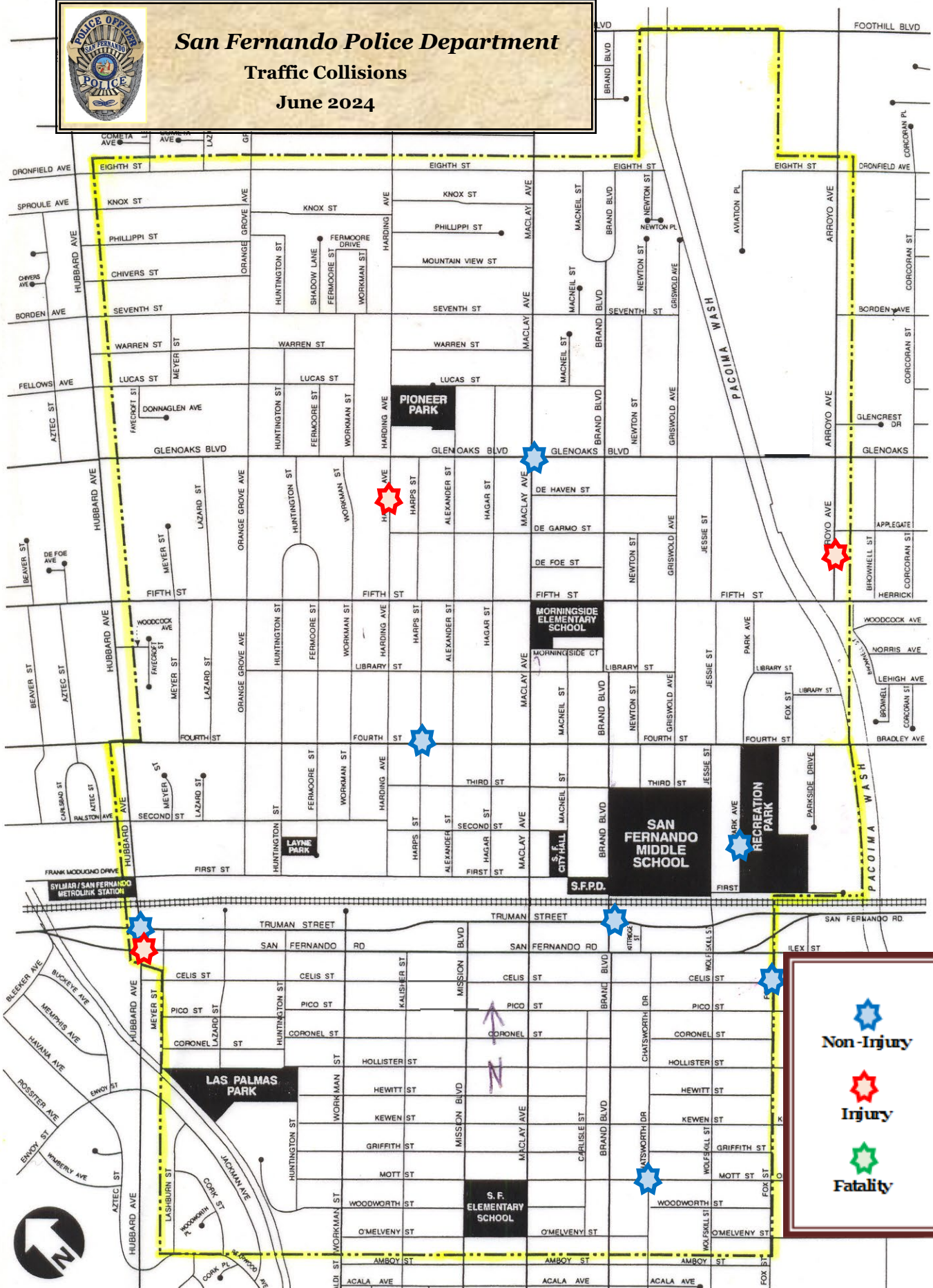

Subject: August 2024 Notable Police Department Events and Activities

RECOMMENDATION:

It is recommended that the Transportation and Public Safety (TPS) Commission receive and file this informational report.

BACKGROUND:

Each month at the City of San Fernando Transportation and Public Safety Commission meeting, the Police Department submits and provides the governing board a brief overview of the previous month's community engagement activities, noteworthy incidents, and proactive enforcement.

ANALYSIS:

The San Fernando Police Department (SFPD) has recently heightened and further integrated its community profile in three major areas: Community Engagement, Proactive Enforcement and Quality of Life Enhancements.

For the month of August, 2024, the SFPD has the following activities and incidents to report:

COMMUNITY ENGAGEMENT:

1. Community and Business Watch:

A special Community Watch meeting was held on Wednesday, August 21, 2024 at 6 PM at Bodevi (909 San Fernando Road). Chief Valdez, Acting Lieutenant Chiasson, Acting Lieutenant Brian Woodward, Sergeant Aguirre, and Detective Cervantes met with business owners and members of the community to discuss current crime trends and issues of concern with community members.

NOTEWORTHY EVENTS:

1. On Thursday, August 1, 2024, around 11:18 AM, SFPD Officers received a Flock notification of a stolen vehicle in the 12900 Block of Foothill Boulevard. Officers located the vehicle and conducted a high-risk felony traffic stop. The driver of the vehicle was arrested for Grand Theft Auto.
2. On Thursday, August 1, 2024, at approximately 6:12 PM, SFPD officers responded to a report of a shooting at 55 North Maclay Avenue (Auto Zone). Upon arrival, officers located an adult male inside the business who was the victim of an apparent gunshot wound, who later succumbed to his injuries. SFPD detectives are working alongside detectives from the Los Angeles County Sheriff's Department Homicide Bureau to investigate this case.
3. On Sunday, August 4, 2024, at approximately 6:20 PM, SFPD Officers responded to a Flock notification of a stolen vehicle. Officers located the vehicle at the 76 Gas Station on Foothill Boulevard and Maclay Avenue and conducted a high-risk traffic stop. The driver was subsequently arrested for Grand Theft Auto.
4. On Sunday, August 4, 2024, at about 6:50 AM, an SFPD Reserve Officer observed a driver asleep at the wheel in the 76 gas station parking lot at Foothill Boulevard and Maclay Avenue. Officers contacted the driver, who displayed signs of drug intoxication. Following an investigation, the driver was arrested for possession of methamphetamine, possession of sedatives or benzodiazepines, possession of a controlled substance, possession of drug paraphernalia, driving under the influence of drugs, and driving on a suspended license.
5. On Friday, August 9, 2024, around 1:10 AM, SFPD officers responded to a report of a burglary in progress at a business on the 1400 Block of Truman Street (Flor de Lima), which was observed via video surveillance. Officers arrived on the scene within three minutes of being notified, but the suspects fled prior to their arrival. Surveillance footage showed four individuals, one carrying a gray safe, fleeing the location in a dark-colored sedan. An employee who arrived at the scene confirmed that the safe was stolen. The investigation into this incident is still ongoing.
6. Sunday, August 11, 2024, at approximately 5:00 PM, SFPD officers responded to a report of a disturbance at San Fernando Road and Kittridge Street. Upon arrival, officers located and detained a male and a female subject. After conducting an investigation, the male subject was arrested for corporal injury to a spouse, cohabitant, or fellow parent, while the female subject was arrested for assault with a deadly weapon.
7. On Monday, August 12, 2024, at approximately 9:05 PM, SFPD officers observed a subject riding a motorcycle without a helmet on the sidewalk in the 1000 block of Truman Street. Officers detained the subject and discovered that the motorcycle was stolen and that the

subject was in possession of methamphetamine. The subject was subsequently arrested for grand theft auto and possession of methamphetamine.

8. On Tuesday, August 13, 2024, at about 11:05 AM, an SFPD Officer responded to a report of a male subject possibly cleaning a gun outside the property in the 1100 Block of Hewitt Street. Following an investigation, the subject was arrested for brandishing a firearm replica.
9. On Wednesday, August 14, 2024, at about 4:45 AM, Deputies from the Los Angeles County Sheriff's Department Special Enforcement Bureau, (SEB) alongside Sheriff's Homicide detectives and San Fernando Police Department personnel executed an arrest warrant in the 1500 block of Knox Street in San Fernando in connection with a homicide that occurred in December of 2022. Officers took 30-year-old Juan Figueroa Jr. into custody and transported him to the San Fernando Police jail facility where he was booked on first degree murder charges.
10. On Saturday, August 17, 2024, An SFPD Undercover Unit patrolled the City for crime suppression during the evening hours.
11. On Saturday, August 17, 2024 at about 8:57 PM, SFPD Officers observed a vehicle swerving into opposing lanes of traffic and nearly colliding with their patrol vehicle. The Officers conducted a traffic stop on the vehicle in the area of Hubbard Street and Hubbard Place. A DUI investigation was conducted and results indicated that the driver had a Blood Alcohol Content approximately three times the legal limit. The subject was booked for driving under the influence, driving with a BAC of .08 percent or higher and driving without a license.
12. On Sunday, August 18, 2024, at approximately 1:50 AM, an SFPD Officer conducted a traffic stop of a vehicle near North Maclay Avenue and Glenoaks Boulevard. Upon making contact with the driver, the Officer detected a strong odor of alcohol. Following a DUI investigation, the driver was arrested for driving under the influence of an alcoholic beverage, driving with a BAC of 0.08 or higher, and driving without a license.
13. On Monday, August 19, 2024, around 11:50 AM, an SFPD Officer responded to a child abuse investigation in the 100 Block of Harding Avenue. After an investigation lasting several hours, a male suspect was arrested for lewd and lascivious acts with a minor.
14. On Tuesday, August 20, 2024, at about 10:30 AM, SFPD Officers responded to a report of an assault in the 1900 Block of Glenoaks Boulevard. Officers conducted an investigation and, subsequently, arrested a male adult for battery.
15. On Thursday, August 22, 2024, at approximately 4:20 AM, SFPD Officers conducted a traffic stop of a bicyclist in the area of Maclay and Coronel. The subject was subsequently arrested for possession of methamphetamine.

16. On Friday, August 23, 2024, around 8:20 AM, SFPD Officers observed a homeless encampment near South Hubbard Avenue and the bike path. They detained four individuals and conducted an investigation. One individual was arrested for possession of drug paraphernalia, and another was cited for drinking in public.
17. On Saturday, August 24, 2024, at about 11:30 PM, an SFPD Officer conducted a traffic enforcement stop in the area of Fourth Street and Meyer Street. The Officer detected an odor of alcohol and initiated a DUI investigation. The driver was subsequently arrested for driving under the influence of alcohol.
18. On Sunday, August 25, 2024, at approximately 6:35 AM, an SFPD Officer received a Flock notification about a stolen vehicle near Maclay Street and Glenoaks Boulevard. Additional units arrived to assist with a high-risk traffic stop. During the stop, a passenger exited the vehicle and fled on foot. The driver was detained at the scene, and the passenger was later located in the Auto Zone parking lot and also detained. The passenger was arrested for carrying a concealed weapon without a permit, carrying a loaded firearm while not being the registered owner, possession of a large-capacity magazine, and grand theft auto. The driver was arrested for vehicle theft.
19. On Sunday, August, 25, 2024, around 10:09 PM, SFPD Officers responded to a report of an assault with a deadly weapon in the 1300 Block of Woodworth Street. Additional units responded to assist and located the suspect near Hollister Street and Kallister Street. The suspect fled the scene, but officers were later able to detain the suspect and, following an investigation, arrested him for assault with a deadly weapon, resisting arrest and vandalism.
20. On Monday, August 26, 2024 at about 12:47 AM, SFPD Officers responded to a report of a carjacking near Alexander Street and Lucus Street. The victim had been lured to the area by a female acquaintance, who took his car keys. When the victim followed her to retrieve his keys, he was confronted by two individuals wearing ski masks. The victim returned to his car and locked the doors to escape, but the suspects used his keys to unlock the vehicle. One suspect brandished a knife and demanded the victim's property. When the victim refused, the suspects punched him multiple times, then fled in his vehicle. Officers later located the female suspect on Fernmore Street, conducted an investigation, and arrested her for carjacking.

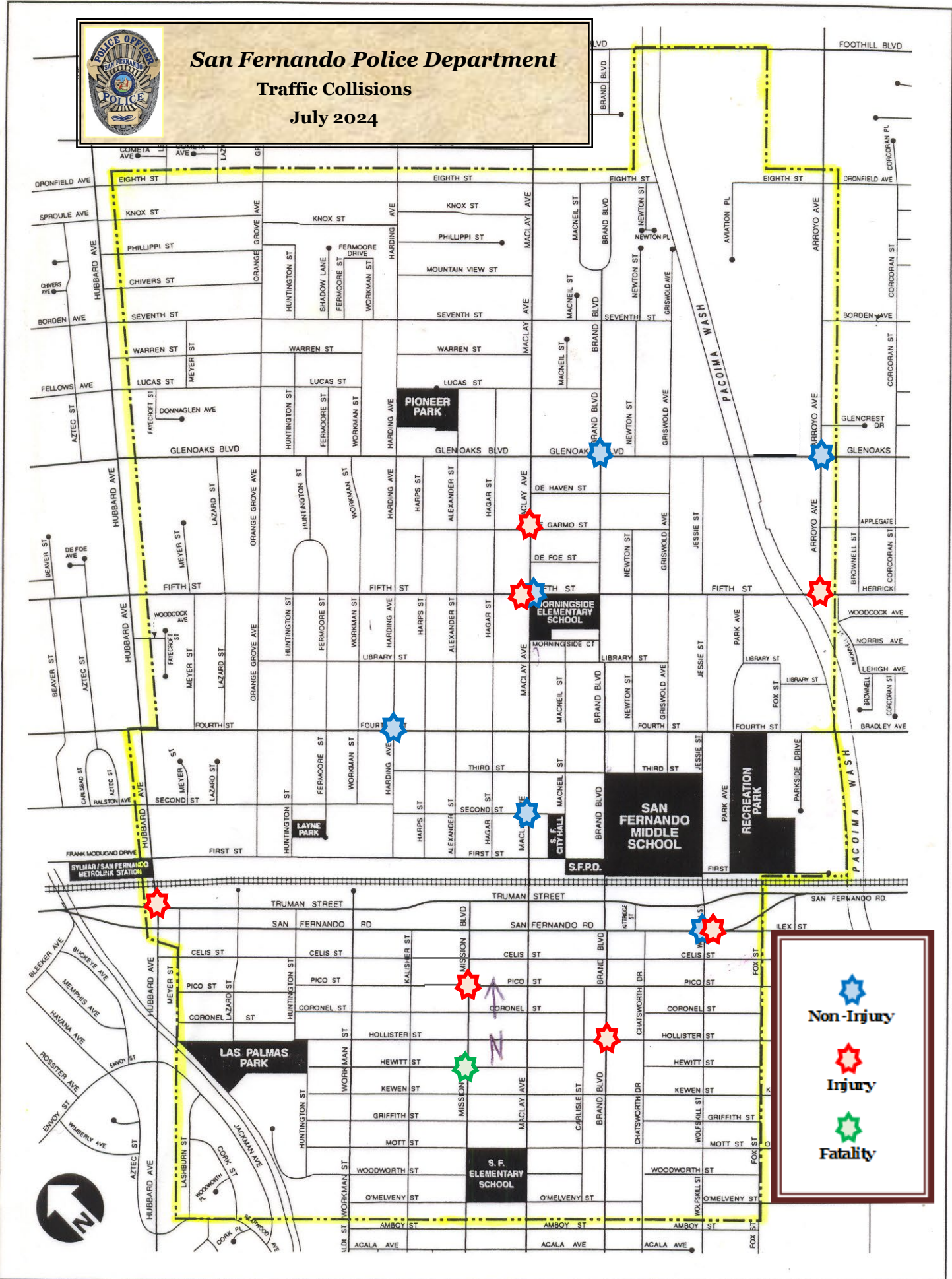
