PROGRAM INFORMATION

The City is proud to launch the Small Business Assistance Program (SBAP), offering grants of up to \$10,000 for exterior façade improvements, such as graffiti-resistant window coverings, green walls, signage (up to \$3,000), paint, awnings, security cameras with police access, and architectural upgrades. Priority will be given to businesses with a high incidence of graffiti. This initiative supports local businesses while enhancing San Fernando's aesthetic and economic vitality.

ELIGIBLE CRITERIA

A business must meet the following criteria to participate in the SBAP Program:

- Must be located in a commercial or mixed-used area of the City with priority for businesses with a high incidence of graffiti.
- Must be existing for a minimum of three years, or have a minimum of a two-year lease or mortgage on the commercial property where the business is located and operated.
- Have an active San Fernando business license.
- Have 50 or fewer employees.
- Provides goods or services to San Fernando residents.
- Current on water and trash bill payments.
