Subject: April 2025 Notable Police Department Events and Activities

RECOMMENDATION:

It is recommended that the Transportation and Public Safety (TPS) Commission receive and file this informational report.

BACKGROUND:

Each month at the City of San Fernando Transportation and Public Safety Commission meeting, the Police Department submits and provides the governing board a brief overview of the previous month's community engagement activities, noteworthy incidents, and proactive enforcement.

ANALYSIS:

The San Fernando Police Department (SFPD) has recently heightened and further integrated its community profile in three major areas: Community Engagement, Proactive Enforcement and Quality of Life Enhancements.

For the month of March 2025, the SFPD has the following activities and incidents to report:

COMMUNITY ENGAGEMENT:

1. ABC Minor Decoy Operation

On Tuesday, April 15, 2025, at 5PM, SFPD detectives conducted a Department of Alcoholic Beverage Control (ABC) Alcohol Policing Partnership (APP) Minor Decoy Operation. The goal of the Minor Decoy program is to reduce the number of alcohol licensees who sell to minors and to reduce youth access to alcohol. Minor decoys visited a 10 ABC establishments and attempted to purchase alcohol. Employees/clerks at all 10 establishments checked the decoys' IDs, resulting in 100 percent compliance.

2. Neighborhood Watch Meeting

The Neighborhood Watch meeting was held on Wednesday, April 16, 2025 at 6:00 PM in the San Fernando City Council Chambers. Detective Sergeant Aguirre reviewed March 2025 Part I Crime statistics. Agent Villanueva from the Department of Alcoholic Beverage Control (ABC) provided a presentation about SFPD's current 2024-2025 ABC Alcohol Policing Partnership Grant.

3. Business Watch Meeting

The monthly Business Watch meeting was held on Wednesday, April 23, 2025 at noon in the San Fernando City Council Chambers. Detective Cervantes reviewed, March 2025 Part I Crime statistics. Agent Villanueva from the Department of Alcoholic Beverage Control (ABC) provided a presentation about SFPD's current 2024-2025 ABC Alcohol Policing Partnership Grant.

4. Community Academy

The Community Academy met on Wednesday, April 23, 2025 at 5:30 PM at San Fernando Middle School. Chief Valdez and representatives from School2Home and San Fernando Parks and Recreation addressed participants.

NOTEWORTHY EVENTS:

- On Tuesday, April 1, 2025, at about 1:45 AM, an SFPD officer stopped a suspicious vehicle near Maclay Avenue and Celis Street. The driver consented to a vehicle search during which officers found a key fob programmer and cloner, several Dodge and Infiniti key fobs, three ski masks, a window punch, and a small-caliber firearm. All three occupants were arrested for conspiracy and grand theft.
- 2. On Tuesday, April 1, 2025, at approximately 2:30 PM, SFPD officers responded to a domestic violence call in the 900 block of North Maclay Avenue. They located the victim and a male suspect. The investigation revealed the suspect had held the victim at an Airbnb against her will, assaulted her, kidnapped her to another location, and threatened her. He was arrested for multiple counts of kidnapping, assault with a deadly weapon, criminal threats, false imprisonment, and felony domestic violence.
- 3. On Wednesday, April 2, 2025, at around 1:15 AM, an SFPD officer conducted a traffic stop near First Street and Huntington Street. A female subject was arrested for possession of a controlled substance and methamphetamine.
- 4. On Saturday, April 5, 2025, at about 12:20 AM, an SFPD officer observed a vehicle speeding and weaving in and out of traffic in the area of Hubbard Avenue at San Fernando Mission Boulevard. The officer initiated a traffic stop and noticed that the driver displayed signs of

intoxication. Following an investigation, the male driver was arrested for DUI and driving without a license.

- 5. On Saturday, April 5, 2025, at approximately 7:40 PM, SFPD officers responded to a report of a female screaming and yelling for help in a vehicle at a local brewery. Upon arrival, officers contacted a male subject near the vehicle, who attempted to flee. Officers detained the subject who was on parole for assault and arrested him for corporal injury to a spouse and resisting arrest.
- 6. On Monday, April 7, 2025, around 4:30 AM, an SFPD officer stopped a bicyclist near San Fernando Road and San Fernando Mission Boulevard. The subject had a felony warrant and was arrested for a Post Release Community Supervision violation.
- 7. On Monday, April 7, 2025, at approximately 12:20 AM, SFPD officers responded to a report of a family dispute in the 200 Block of Alexander Street. They arrested a male subject for domestic battery.
- 8. On Tuesday, April 8, 2025, at about 6:30 PM, an SFPD officer responded to a report of shoplifting at the Home Depot located in the 12900 Block of Foothill Boulevard. Following an investigation, the subject was arrested for shoplifting and possession of methamphetamine.
- 9. On Thursday, April 10, 2025, around 12:39 AM, an SFPD officer stopped a vehicle with an obstructed license plate near Hubbard Avenue and San Fernando Road. Following an investigation, the driver was arrested for an outstanding warrant.
- 10. On Friday, April 11, 2025, at approximately 5:20 AM, SFPD officers responded to a report of a domestic dispute in the 2000 Block of Second Street. Following an investigation, they arrested a male and female for domestic battery.
- 11. On Friday, April 11, 2025, at about 8:50 PM, SFPD officers responded to multiple reports of a three-vehicle traffic collision with injuries in the area of Glenoaks Boulevard and Orange Grove Avenue. One driver was extricated and transported to the hospital by LAFD. Another driver showed signs of intoxication and, following an investigation, was arrested for felony DUI.
- 12. On Friday, April 11, 2025, around 10:30 PM, an SFPD officer managing the scene of the traffic collision near Glenoaks Boulevard and Orange Grove Avenue observed a vehicle driving through the crash scene on the wrong side of the road, nearly causing another collision. The officer conducted a traffic stop, and following a DUI investigation, arrested the male driver for driving under the influence and for having a blood alcohol content of 0.08 percent or higher.

- 13. On Saturday, April 12, 2025, at approximately 1:20 PM, an SFPD officer observed a vehicle parked in a handicap parking spot without a disabled placard. The officer contacted the occupants of the vehicle and learned that one of them had a methamphetamine pipe in his pocket. He arrested the subject for possession of drug paraphernalia.
- 14. On Saturday, April 12, 2025, around 4:20 PM, SFPD officers responded to a report of a vandalism in progress in the 100 Block of South Brand Boulevard. They arrested the juvenile subject for vandalism.
- 15. On Saturday, April 12, 2025, at about 11:30 PM, an SFPD officer responded to a report of a possible domestic dispute in the 400 Block of Hagar Street. A male and female were arrested for domestic battery.
- 16. On Tuesday, April 15, 2025, at approximately 10:05 PM, SFPD officers responded to a report of a male trespassing in front of a closed business in the 1100 block of Pico Street. The subject refused to leave when contacted. As officers attempted to arrest him, he resisted and tried to flee. He was arrested for trespassing, resisting a police officer, and resisting arrest.
- 17. On Wednesday, April 16, 2025, around 10:35 PM, an SFPD officer stopped a vehicle with no headlights and no front license plate near Laurel Canyon Blvd and Rinaldi Street. The driver was on felony probation for assault with a deadly weapon; the passenger was on post-release community supervision. The officer found a large quantity of methamphetamine in the vehicle. Both subjects were arrested for possession of methamphetamine for sale and probation violations
- 18. On Thursday, April 17, 2025, at about 8:45 AM, SFPD officers received a Flock ALPR notification of a stolen vehicle in the area of Eighth Street and North Maclay Avenue. Officers located the vehicle in the 1000 Block of North Maclay. Following surveillance of the vehicle, officers conducted a traffic stop and arrested the female driver for grand theft auto.
- 19. On Friday, April 18, 2025, at approximately 8:10 PM, an SFPD officer observed a vehicle commit several traffic violations in the area of Laurel Canyon Boulevard and Rinaldi Street and conducted a traffic stop. Following an investigation, the female subject, who had prior convictions for drug-related offenses, was arrested for driving with a suspended license, possession of methamphetamine, and possession of drug paraphernalia.
- 20. On Saturday, April 19, 2025, around 1:30 PM, SFPD officers stopped a vehicle with an expired registration near First Street and North Maclay Avenue and found methamphetamine and drug paraphernalia during their investigation. The driver, who had prior drug-related convictions, was arrested for possession of methamphetamine and paraphernalia. The vehicle was linked to a February 2025 Dollar Tree robbery, held for evidence, and the investigation remains ongoing.

- 21. On Saturday, April 19, 2025, at approximately 10:45 PM, an officer observed a vehicle driving without headlights and running a red light near O'Melveny Avenue and San Fernando Mission Boulevard. The officer initiated a traffic stop and DUI investigation. The female driver was arrested for driving under the influence.
- 22. On Monday, April 21, 2025, around 10:40 PM, an SFPD officer conducted a traffic stop of a vehicle with an expired registration in the 1400 Block of San Fernando Road. Following an investigation, the officer arrested the driver of the vehicle for driving with a suspended license, possession of methamphetamine and an outstanding warrant. One passenger was arrested for possession of a controlled substance, and another passenger was arrested for outstanding warrants.
