Greater Los Angeles Vector Control District Representative

The City of San Fernando City Council is now accepting applications for appointment to serve as its representative to the [Greater Los Angeles County Vector Control District](#) Board of Trustees. As the City's representative, you will assist the District in making decisions that shape its public health program for Los Angeles County.

Vector Control District requires that volunteers be a resident and registered voter of the City of San Fernando. Monthly travel reimbursements are paid by the Vector Control District of \$100 and by the City of \$150 for each monthly Board meeting attended. The term of office is for a two- or four-year period.

About the District

The Greater Los Angeles County Vector Control District is an independent Special District and public health agency dedicated to protecting communities from vectors and vector-borne diseases. The District serves over 6 million residents across 36 cities and unincorporated areas in Los Angeles County.

About the Board of Trustees

The Board of Trustees is comprised of 37 members. Members are appointed by their City or the County Board of Supervisors, but represent the mission and interest of the District at large rather than the individual interest of the appointing body. A Trustee is appointed pursuant to the State Health and Safety Code for either a 2- or 4-year term.

Eligibility Requirements

To be appointed, the member must **1)** be an elector and resident of the city or county area in the District and **2)** be willing to actively participate and serve as a liaison between the District and their City.

Roles & Expectations of a Board Member

- ✓ Attends in-person monthly Board meetings (2nd Thursday of each month at 7 PM, Santa Fe Springs)
- ✓ Sets general District policy and oversees the District budget
- ✓ Participates in the selection of the General Manager
- ✓ Serves on committees and participates in educational opportunities
- ✓ Provides updates to their City Council on District activities and programs

Compensation

This appointment does not receive any compensation but there is a travel stipend of \$100 per monthly Board meeting attended.
