ADMINISTRATIVE REPORTS

2. DISCUSSION ON MAKING A RECOMMENDATION TO REVITALIZE THE MURAL AT LAS PALMAS

PARK – This item was added by Commissioner E. Friend at last month's meeting. RCS Director Julio Salcedo reported to the Commission that Las Palmas Park is on the calendar to undergo a major revitalization, which includes picnic areas, parking lot, exercise equipment, playground and sports fields.

Maribel Perez has been involved with the project design aspect. The community provided input regarding their priorities, however, the mural was not presented as a priority. This project has

been handed over to the Public Works Department to continue working on the revitalization project.

Commissioner E. Friend inquired about the mural fund that was available in the past and would like to propose accessing those funds to improve this mural. It would be a simple project which should not incur a significant cost and could include community volunteers to participate.

Discussion continued regarding seeking local colleges to partner, checking if the existing construction of the wall is sound, and if the mural came up in any of the community engagements.

Julio Salcedo will follow up with the requested information including funding sources.

3. MAKE A RECOMMENDATION TO SELECT NEW AD HOC MEMBERS FOR THE CESAR CHAVEZ MEMORIAL RENOVATION PROJECT – This item was added by Commissioner E. Friend. Julio Salcedo provided some background information regarding the Cesar Chavez Memorial and the activity by the previous Ad Hoc Committee. The last meeting with Pueblo Y Salud was about six months ago.

Commissioners E. Friend and F. Sanchez volunteered to be Ad Hoc Committee members for the Cesar Chavez Memorial project.

Chair J. Cuellar motioned to appoint Commissioners E. Friend and F. Sanchez as the two Ad Hoc Committee members for the Cesar Chavez Memorial Renovation Project. Commissioner C. Garcia seconded the motion. The motion passed unanimously with the following roll call vote:

4. DISCUSSION ON MAKING A RECOMMENDATION TO IDENTIFY A LOCATION FOR A DOG PARK

This item was added by Commissioner F. Sanchez. Staff provided the commission with the agenda reports and background regarding the work that was completed by KDI Design Company in 2023-2024. KDI conducted a land and open space survey and several community engagement events to identify priorities in developing a conceptual design as part of the Parks Master Plan. This is a guide to follow once funding sources are identified to move forward.

Additional discussion ensued regarding the possibility of identifying any potential spaces for a dog park, and the community engagement participation being a very small percentage of the total number of residents. Staff provided many opportunities for the community to get involved by attending community meetings and participate in surveys.

Julio Salcedo will invite a Public Works staff member to discuss available spaces, costs, and Kalisher Pocket Park as an option.

5. DISCUSSION ON MAKING A RECOMMENDATION TO EXPLORE CREATING WILDLIFE HABITATS IN CITY PARKS- This item was added to the agenda by Commissioner F. Sanchez who discussed the importance of creating habitats for hummingbirds due to the declining population as a result of climate change. Creating a sustainable microhabitat could bring local community members and organizations together in this important effort.

The consensus of the Commission is to support this item. Staff will invite a representative from Public Works to provide information on this item.

- **6. DISCUSSION ON MAKING A RECOMMENDATION TO POST SIGNAGE WITH QR CODES ON MAJOR THOROUGHFARES IN SAN FERNANDO** This item was added by Vice Chair N. Sanchez-Brooks. Staff will invite a representative from Public Works to address this issue as public signage falls under the purview of the Public Works Department.

RECOMMENDATION

It is recommended that the Parks, Wellness and Recreation (PWR) Commission discuss the possibility of making a recommendation to revitalize the mural at Las Palmas Park.

BACKGROUND/ANALYSIS

The mural was completed in 1996 and is located at Las Palmas Park along an exterior wall, measuring about 400 feet long and depicting the history of San Fernando. Commissioner Erica Friend made a request at the April 10, 2025 PWRC regular meeting to add this item to the agenda.

This was an agenda item discussed at the May 8, 2025 PWRC regular meeting. Staff discussed the Las Palmas Park Revitalization project and the community engagement that did not identify the mural as a priority.

Commissioners inquired about the status of the Mural Fund, the structural integrity of the wall, and suggested collaborating with local colleges to assist in this effort.

BUDGET IMPACT

There is no impact to the budget by discussing this item.

Subject: Cesar E. Chavez Memorial Renovation Project Update

RECOMMENDATION:

It is recommended that the Parks, Wellness, and Recreation Commission:

- a. Discuss Ad Hoc Committee Updates;
- b. Continue to meet with Pueblo Y Salud until a renovation plan for the Memorial Plaza can be developed; and
- c. Provide staff direction as appropriate.

BACKGROUND:

- 1. On June 7, 1993, the City Council approved of declaring March 31 an official City holiday honoring the late farmworker and civil rights leader, Cesar E. Chavez, thus becoming the first City in the country to establish the Cesar E. Chavez Holiday.
- 2. In 2004, the City of San Fernando in collaboration with the Cesar E. Chavez Commemorative Committee honored the great civil rights and labor leader through the creation of the largest Cesar E. Chavez Memorial in the nation.
- 3. On October 6, 2014, the City Council approved a partnership with Pueblo Y Salud for fundraising efforts to repair and restore the Cesar E. Chavez Memorial.
- 4. On March 14, 2023, Commissioner Lopez requested information regarding the condition and possible beautification of the Cesar E. Chavez Memorial.
- 5. On April 11, 2023, the PWRC directed staff to draft a letter to Pueblo Y Salud that would start a potential collaboration to restore the Cesar E. Chavez Memorial Plaza.

- 6. On May 11, 2023, the PWRC tabled discussion on the item until the Commissioners had an opportunity to review the MOU with Pueblo Y Salud and provide feedback on the draft letter to Pueblo Y Salud.
- 7. On June 8, 2023, an Ad Hoc Committee (Commissioners Lopez & Gonzales) was formed to gather information on the Cesar E. Chavez Memorial and how renovations would be funded.
- 8. On August 17, 2023, the Ad Hoc Committee and the RCS Director met with Ruben Rodriguez of Pueblo Y Salud.
- In 2024, the Ad Hoc Committee met with RCS Director Julio Salcedo to review the existing MOU with Pueblo Y Salud. The Ad Hoc agreed to meet after the July 11, 2024 PWR Commission regular meeting
- 10. On August 9, 2024, the Ad Hoc, RCS Department staff and Pueblo Y Salud met and reviewed the MOU agreement. Consensus was reached to schedule a tour of the Cesar E. Chavez Memorial and Recreation Park Facility.
- 11. As a result of the November 5, 2024, San Fernando City Council elections, Robert Gonzales and Patty Lopez would no longer serve on the PWRC.
- 12. At the PWRC meeting held on April 10, 2025, Commissioner Erica Friend requested to add an agenda item to select new members for the Ad Hoc Committee.
- 13. At the May 8, 2025 PWRC regular meeting, Commissioners Erica Friend and Flor Sanchez volunteered to be Ad Hoc Committee members.

ANALYSIS:

The City has an MOU with Pueblo Y Salud (PYS), which allows access for the organization to program and maintain the monument. In past years, PYS has spearheaded fundraising efforts to help the City offset costs associated with the restoration and maintenance of the monument. The Department of Public Works reinstalled commemorative plaques that had been stolen. Staff reported that the installation involved cutting into the base and the use of industrial strength adhesive to secure the new plaque in place. Public Works also conducts periodic maintenance, which includes trimming shrubs, removing weeds, and cleaning graffiti.

The Ad Hoc committee has met regularly with Ruben Rodriguez, from Pueblo Y Salud, to discuss possible renovations for the Cesar E. Chavez Memorial Plaza. The discussions have revolved around the history of the Memorial. Mr. Rodriguez noted that Pueblo Y Salud had started

investigating renovations to the Memorial back in 2014, but the project stalled and had been dormant for some time.

The cost was a big factor in putting the renovation on hold. The restoration project needed to raise the funds to pay for the repairs. A breakdown of those costs in 2014 determined that the renovation would cost about \$19,000 at that time. In March of 2024, the Ad Hoc Committee determined that it would need to look into today's cost and determine how these funds would be raised.

In order to proceed with the beautification efforts of the Cesar E. Chavez Memorial, it is recommended that the Ad Hoc Committee Members continue collaborating with Pueblo Y Salud and discuss funding options for this project.

BUDGET IMPACT:

There is no budget to review and discuss this item. However, any possible beautification or restoration of the Cesar E. Chavez Memorial will incur a cost. Per Sec. 54-67. - Incurring financial liability - Neither the Commission nor any person connected with the Commission shall incur any financial liability in the name of the City.

CONCLUSION:

It is recommended that the Parks, Wellness, and Recreation Commission and Ad Hoc Committee members to continue collaborating with Pueblo Y Salud and continue to look into funding opportunities and provide staff with direction as appropriate

RECOMMENDATION

Recommend that the Parks, Wellness, and Recreation Commission receive and file an informational report from the Public Works Department regarding available spaces and cost associated with developing a dog park.

BACKGROUND/ANALYSIS

On August 7, 2023, City Council awarded a Professional Services Agreement to Kounkuey Design Initiatives, Inc. (KDI) to conduct a land and open space inventory study. The results of the Land and Open Space Inventory report (Attachments "A" and "B"), also known as the San Fernando Park Opportunity Plan (SF POP), were presented to the Parks, Wellness and Recreation Commission at the September 12, 2024 regular meeting.

This item was added as an agenda item by Commissioner Flor Sanchez at the April 10, 2025, PWRC regular meeting. This item was discussed at the May 8, 2025, PWRC regular meeting. Staff provided Commissioner Flor Sanchez with the agenda report, meeting minutes and the YouTube meeting link from the PWRC regular meeting held on September 12, 2024.

At the May 8, 2025 PWRC regular meeting, staff received direction from the Commission to invite a Public Works staff member to discuss available spaces, costs, and consider Kalisher Pocket Park as a possible option for a dog park.

There is no impact to the budget by discussing this item.

Fernando Park Opportunity Plan (LOSIS/SF POP) Report from Kounkuey Design

Initiatives, Inc. (KDI).

RECOMMENDATION:

It is recommended that the Parks, Wellness and Recreation Commission:

- a. Receive and File the Land and Open Space Inventory Study Report/San Fernando Park Opportunity Plan from KDI; and
- b. Provide staff direction as appropriate.

BACKGROUND:

- 1. On February 5, 2018, the City Council adopted the Park and Recreation Master Plan (PMP) as an instrument for developing a comprehensive vision for park facility improvements and recreational programs offered to the residents of San Fernando. The PMP identified a lack of recreational facilities such as bike paths, walking trails and dog parks, but also recognized the scarcity of available land to build new park facilities.
- 2. On June 21, 2022, the City Council amended the Fiscal Year 2022-2023 budget to appropriate \$50,000 of American Rescue Plan Act (ARPA) funds for a Feasibility Study to identify New City Park Space.
- 3. On July 5, 2022, the City Council requested that staff look into the possibility of developing a dog park in the city.
- 4. On July 14, 2022, Los Angeles County RPOSD announced a \$185,000 allocation in TAP Services for the City of San Fernando. The funds are earmarked to assist in the development of new park facilities. Subsequently the City entered into a Master Agreement with RPOSD guaranteeing such funds.

- 5. On August 15, 2022, staff presented a concept for a Dog Park at San Fernando Recreation Park that could be funded with RPOSD annual allocation funds. While open to the idea, the City Council directed staff to take a broader approach for developing new park facilities. That approach would take the form of updating the PMP by conducting a land and open space inventory to define potential land for new park facilities.
- 6. On March 6, 2023, the City Council adopted Resolution No. 8220 allocating the \$185,000 Regional Parks and Open Space TAP Grant towards the study and authorized staff to circulate a Notice Inviting Bids.

The Land and Open Space Inventory report, also known as the San Fernando Park Opportunity Plan (SF POP), serves as a critical tool in this endeavor. It's aimed at enhancing the park system of San Fernando through identifying opportunities for the strategic development of new parks and recreation spaces. It provides an assessment of the city's current land use, highlighting areas designated for residential, commercial, industrial, and recreational purposes as well as expanding the scope to include development consideration of open spaces on public school properties and churches. The report also identifies existing open spaces including parks, underused parcels, tree canopy coverage, and transit lines that contribute to the resident's quality of life.
