Motion by Councilmember Fajardo, seconded by Vice Mayor Solorio to receive and file City's Position Vacancy and Recruitment and Retention Efforts Report for Fiscal Year 2024-2025. The motion carried, unanimously.

Mayor Mendoza closed the public hearing.

#### **ADMINISTRATIVE REPORTS**

10) DISCUSSION AND CONSIDERATION TO AWARD A PROFESSIONAL SERVICES CONTRACT WITH PLANSMAN INC. FOR DESIGN SERVICES FOR THE DOWNTOWN TRASH ENCLOSURE PROJECT

Director of Public Works Johnson presented the staff report and responded to Councilmember questions.

Motion by Councilmember Lopez, seconded by Vice Mayor Solorio to award a Professional Services Contract to Plansman Inc. (Contract No. 2365) in an amount not to exceed \$60,000, for design services for the Downtown Trash Enclosure Project; and authorize the City Manager, or designee, to make non-substantive changes and execute the contract and all related documents. The motion carried, unanimously.

11) DISCUSSION OF FISCAL YEAR 2025-2026 BUDGET STUDY SESSION NO. 2

The City Council continued discussions to the June 16, 2025 City Council meeting for the FY 2025-2026 Proposed Budget Public Hearing; and Councilmembers will submit a list of enhancement requests to the City Manager by June 6, 2025, regarding the allocation of the remaining surplus funds of \$149,340.

It was noted that the City Council recessed the meeting at 9:02 p.m. and reconvened at 9:19 p.m. with all Councilmembers present.

12) DISCUSSION AND CONSIDERATION TO APPROVE OUTREACH LETTER TO THE MEXICAN CONSULATE

Councilmember Patty Lopez presented the staff report and responded to Councilmember questions.

Motion by Councilmember Lopez, seconded by Councilmember Garcia, to approve the letter as amended to include all five City Council signatures, and to direct staff to contact the consulate to determine whether certain requirements can be modified to accommodate the City's current available facilities. The motion carried, unanimously.

13) DISCUSSION AND CONSIDERATION REGARDING DISPLAYING OFFICIAL PHOTOS AT CITY HALL

Councilmember Patty Lopez presented the staff report and responded to Councilmember questions.

Motion by Councilmember Lopez, seconded by Councilmember Garcia to approve displaying elected official's photos at City Hall to include current Councilmembers, Assemblymember, Los Angeles County Board Supervisor, Congresswoman and State Senator. The motion carried, unanimously.

14) DISCUSSION AND CONSIDERATION TO ADOPT A RESOLUTION RECOGNIZING JUNE AS FATHERS' MONTH

Councilmember Patty Lopez presented the staff report and responded to Councilmember questions.

Motion by Councilmember Fajardo, seconded by Councilmember Garcia to approve the proposed Resolution, as amended to: Add to the Resolution title "Fatherhood Wellbeing Month" and in Section 1 - amend "Fathers Month" to "Fathers Wellbeing Month". The motion carried, unanimously.

15) DISCUSSION AND CONSIDERATION REGARDING PROACTIVE RESPONSE TO ILLEGAL FIREWORKS

Vice Mayor Mary Solorio presented the staff report and responded to Councilmember questions.

Motion by Vice Mayor Solorio, seconded by Councilmember Garcia to direct staff to continue current enforcement and educational outreach efforts to include: a. Add a reporting option in "My San Fernando" app; b. Add a QR code to existing outreach materials and communications; and c. Seek possible collaboration with LAFD to add to current outreach program resources. The motion carried, unanimously.

Stated she attended the 2025 JAAP LA Democratic Party event, the Valley Economic Board of Directors meeting, and thanked the Republic for the bulky item drop-off; met with staff and Congressman Rivas to discuss funding needs, attended the Education Commission Scholarship Awards, the grand opening of the Mainland Literacy Center, and represented the district as a delegate at the California Democratic Party Convention.
