ADMINISTRATIVE REPORTS

2. DISCUSSION REGARDING ADDING PARKING VIOLATION REPORTING TO THE CITY APP - Will Pettener, Assistant to the City Manager, provided background on the City's My San Fernando App. Mr. Pettener oversees the management of the City's GoGov contract, monitoring and reporting status reports to City Council on the app's progress. To date, about 4500 requests have been submitted by the public and staff members. Chair Cuellar would like to see an option added to report illegal parking. Commissioner Garcia had questions regarding incidents requiring immediate attention, such as handicap parking violations. Commissioner Sanchez asked about including surveys on the app and suggested providing reports to this Commission highlighting the top issues and complaints.

Mr. Pettener conveyed that the most frequent reported topics are in reference to graffiti and illegal dumping. He will look into providing updates to this Commission regarding requests and concerns submitted by residents. In addition, the City's new website will soon offer a feature to submit requests directly through the website, thereby offering yet another option for reporting issues.

3. UPDATE ON IDENTIFYING A LOCATION FOR A DOG PARK – Public Works Director Wendell Johnson discussed available grant opportunities that may include the development of a dog park. Part of the grant could include constructing a retaining wall along the Pacoima Wash, from Jesse St. to Fourth St. This location could be a multi-use space, which may include a dog park. Staff will plan to apply for this \$5 million grant.

Commissioners had questions regarding the status of the Kalisher Pocket Park. Mr. Wendell will look into this matter and provide more information. Overall, the Commission was pleased with the recommendations made by Mr. Johnson.

4. UPDATE ON THE RECOMMENDATION TO CREATE WILDLIFE HABITATS IN THE CITY – Public Works Director Wendell Johnson discussed the possibility of utilizing a portion of the San Fernando Mission Bike Trail. Staff is working on putting together a plant palette of trees and shrubbery that support hummingbird habitats. The Green Street projects involving parking lot number four, located in the middle of downtown, may be a consideration. There may be an opportunity to include native plants in that particular project, as well as shrubbery and potted plants attractive to hummingbirds. Beautification is one of the Council's top ten priorities this year. Creating a green corridor that supports wildlife and nature would beautify the City and also falls in line with Council's priorities.

Commissioner Garcia suggested considering Commissioner Friend's recommendation to utilize the existing pots along Maclay Ave. Planting foliage that would attract humming birds in these

pots is a very feasible option.

Public Works will provide an update on capital improvement projects, which also includes updates on Las Palmas Park.

5. CESAR E. CHAVEZ MEMORIAL RENOVATION PROJECT UPDATE – RCS Director Julio Salcedo provided Commissioners with the current MOU with Pueblo Y Salud. He informed the commission that a meeting was held with City Council, the Public Works Director and the RCS Director. A walk-through of the memorial was conducted to identify areas requiring repairs and improvements. A day of service may be planned in March of 2026 for a community clean up. Once staff receives direction from the Council, this Commission, specifically the Ad Hoc, will be updated on the renovation efforts and invite those wishing to participate in beautifying the memorial. The Commission is supportive of the renovation of this project and looks forward to more information as it becomes available.

The Commission had questions regarding seeking collaboration with additional non-profit organizations to assist in the renovation effort and inquired about identifying the names of the missing plaques.

6. DEPARTMENT PROGRAMS AND SERVICES UPDATE – Staff provided a presentation with updates on the programs, events and activities at the parks. Upcoming events include the concerts at the park series, including the City's 114th Birthday Celebration. Other updates included youth and adult sports programs, senior programs, and the cooling centers. Staff opened the floor for questions and comments.

Commissioner Sanchez had questions regarding how to find the calendar of activities and events. Staff reported that ongoing programs, activities and special events are promoted on the City's website and social medial. There is also an option on the City website to sign up for notifications.

STAFF COMMUNICATION

Mr. Salcedo reported cooling centers are activated and open to the community anytime the temperature hits 95 degrees or higher.

Commissioner Garcia commented that in visiting the parks, maintenance looks good and parks are in a tidy appearance.

Commissioner Friend mentioned the upcoming hot weather and reminded all to visit the cooling centers.

Commissioner Sanchez reported that Cindy Montañez Natural Park has over grown vegetation and inquired about the maintenance schedule. Mr. Johnson reported that the Tataviam Tribe was handling the maintenance at this location. He will look into the status and provide an update on all capital projects.

Chair Cuellar would like to address park safety issues such as cameras, locking park gates, safety in restrooms, etc. In light of the recent incident at Recreation Park with the person experiencing mental health issues, Chair Cuellar would like to address these issues at the parks. Mr. Salcedo advised that these items would be addressed at an upcoming City Council meeting. Staff recommended Commissioners provide a list of concerns prior to the next PD quarterly update as this is a standing item on the agenda.

Chair Cuellar requested an update on programming at the Puig House. Mr. Salcedo reported that City Council approved an MOU with UCLA Early Head Start Program. By the next Commission meeting, staff should have a more detailed schedule of programming. UCLA Early Head Start Program team will be invited to provide an update.

Subject: Update on Programming at the Pioneer Park Puig House

RECOMMENDATION

It is recommended that the Parks, Wellness and Recreation (PWR) Commission receive and file an update on the status of the planned programming and activities at the Puig House.

BACKGROUND/ANALYSIS

In February 2025, UCLA Early Head Start Program and the City met to research a possible collaboration to provide services for infants, toddlers, pregnant women and their families.

A proposed contract service agreement with the UCLA Head Start Program was presented and approved by City Council at the August 4, 2025 City Council meeting. Through this collaboration, both agencies will increase the number of families that are served, offer parenting classes to families in the community free of charge, implement an obesity prevention program (Let's Play Outside Again) for children two (2) to five (5) years of age and utilize park space to host UCLA Head Start meetings and events. This partnership will also increase awareness among families of the many Recreation and Community Services resources. Collaborating with UCLA Early Head Start Program directly aligns with the City's number one strategic goal for 2025-2026, which is to Focus on Community First by providing a high standard of service, safety and quality of life.

BUDGET IMPACT

There is no budget impact incurred by this collaboration as any maintenance costs incurred for these programs by the use of City facilities have already been accounted for in the Fiscal Year 2025-2026 Adopted Budget.

Subject: Update on the City App

RECOMMENDATION

It is recommended that the Parks, Wellness and Recreation (PWR) Commission receive and file an update on the City App in regards to the top reported issues and the possibility of adding additional topic areas. Assistant to the City Manager, Will Pettener.

BACKGROUND/ANALYSIS

At the July 10, 2025, PWRC regular meeting, Commissioner Christian Garcia, reported seeing frequent parking violations such as vehicles parked in handicapped parking without the appropriate placard. A discussion ensued on reporting parking violations on the City App.

An informational report was presented by the Assistant to the City Manager, Will Pettener at the August 14, 2025 PWR Commission meeting. Discussion included details on how to submit requests on the City App and the total number of requests submitted by the public and staff. Commissioner Sanchez had questions regarding the top reported issues and inquired about adding surveys to the app. Commissioner Garcia had questions regarding reporting incidents requiring immediate attention and Chair Cuellar added she would like to see an option to report illegal parking.

Mr. Pettener will gather additional information and provide an update to this commission.

Commissioner Sanchez had questions regarding the maintenance schedule at the Cindy Montañez Natural Park.

Subject: Cesar E. Chavez Memorial Renovation Project Update

RECOMMENDATION:

It is recommended that the Parks, Wellness, and Recreation Commission:

a. Discuss Ad Hoc Committee Updates;

b. Continue to meet with Pueblo Y Salud until a renovation plan for the Memorial Plaza can be developed; and

c. Provide staff direction as appropriate.

BACKGROUND:

- 1. On June 7, 1993, the City Council approved of declaring March 31 an official City holiday honoring the late farmworker and civil rights leader, Cesar E. Chavez, thus becoming the first City in the country to establish the Cesar E. Chavez Holiday.
- 2. In 2004, the City of San Fernando in collaboration with the Cesar E. Chavez Commemorative Committee honored the great civil rights and labor leader through the creation of the largest Cesar E. Chavez Memorial in the nation.
- 3. On October 6, 2014, the City Council approved a partnership with Pueblo Y Salud for fundraising efforts to repair and restore the Cesar E. Chavez Memorial.
- 4. On March 14, 2023, Commissioner Lopez requested information regarding the condition and possible beautification of the Cesar E. Chavez Memorial.
- 5. On April 11, 2023, the PWRC directed staff to draft a letter to Pueblo Y Salud that would start a potential collaboration to restore the Cesar E. Chavez Memorial Plaza.

- 6. On May 11, 2023, the PWRC tabled discussion on the item until the Commissioners had an opportunity to review the MOU with Pueblo Y Salud and provide feedback on the draft letter to Pueblo Y Salud.
- 7. On June 8, 2023, an Ad Hoc Committee (Commissioners Lopez & Gonzales) was formed to gather information on the Cesar E. Chavez Memorial and how renovations would be funded.
- 8. On August 17, 2023, the Ad Hoc Committee and the RCS Director met with Ruben Rodriguez of Pueblo Y Salud.
- In 2024, the Ad Hoc Committee met with RCS Director Julio Salcedo to review the existing MOU with Pueblo Y Salud. The Ad Hoc agreed to meet after the July 11, 2024 PWR Commission regular meeting
- 10. On August 9, 2024, the Ad Hoc, RCS Department staff and Pueblo Y Salud met and reviewed the MOU agreement. Consensus was reached to schedule a tour of the Cesar E. Chavez Memorial and Recreation Park Facility.
- 11. As a result of the November 5, 2024, San Fernando City Council elections, Robert Gonzales and Patty Lopez would no longer serve on the PWRC.
- 12. At the PWRC meeting held on April 10, 2025, Commissioner Erica Friend requested to add an agenda item to select new members for the Ad Hoc Committee.
- 13. At the May 8, 2025 PWRC regular meeting, Commissioners Erica Friend and Flor Sanchez volunteered to be Ad Hoc Committee members.
- 14. At the July 10, 2025 PWRC regular meeting, RCS Director J. Salcedo reported that the City Council Ad Hoc has reactivated to continue working with Pueblo Y Salud on this project.
- 15. At the August 14, 2025 PWR Commission meeting, Mr. Salcedo informed the commission that a meeting and walk-through of the memorial was held with City Council, the Public Works Director and the RCS Director. A day of service may be planned in March of 2026 for a community clean up.

ANALYSIS:

The City has an MOU with Pueblo Y Salud (PYS), which allows access for the organization to program and maintain the monument. In past years, PYS has spearheaded fundraising efforts to help the City offset costs associated with the restoration and maintenance of the monument. The

Department of Public Works reinstalled commemorative plaques that had been stolen. Staff reported that the installation involved cutting into the base and the use of industrial strength adhesive to secure the new plaque in place. Public Works also conducts periodic maintenance, which includes trimming shrubs, removing weeds, and cleaning graffiti.

The Ad Hoc committee has met regularly with Ruben Rodriguez, from Pueblo Y Salud, to discuss possible renovations for the Cesar E. Chavez Memorial Plaza. The discussions have revolved around the history of the Memorial. Mr. Rodriguez noted that Pueblo Y Salud had started investigating renovations to the Memorial back in 2014, but the project stalled and had been dormant for some time.

The cost was a big factor in putting the renovation on hold. The restoration project needed to raise the funds to pay for the repairs. A breakdown of those costs in 2014 determined that the renovation would cost about \$19,000 at that time. In March of 2024, the Ad Hoc Committee determined that it would need to look into today's cost and determine how these funds would be raised.

In order to proceed with the beautification efforts of the Cesar E. Chavez Memorial, it is recommended that the Ad Hoc Committee Members stay informed on updates provided by the City Council Ad Hoc and continue collaborating with Pueblo Y Salud to identify funding options for this project.

BUDGET IMPACT:

There is no budget to review and discuss this item. However, any possible beautification or restoration of the Cesar E. Chavez Memorial will incur a cost. Per Sec. 54-67. - Incurring financial liability - Neither the Commission nor any person connected with the Commission shall incur any financial liability in the name of the City.

CONCLUSION:

It is recommended that the Parks, Wellness, and Recreation Commission and Ad Hoc Committee members to continue collaborating with Pueblo Y Salud and continue to look into funding opportunities and provide staff with direction as appropriate

RECOMMENDATION:

It is recommended that the Parks, Wellness, and Recreation Commission:

BACKGROUND:

- The mission of the Recreation and Community Services (RCS) Department is to develop and implement enriching community, cultural, and recreational opportunities that foster the overall well-being and personal development of our community.
- 2. The RCS Department conducts a wide array of programs, services, activities, and business throughout the year. Staff provides a monthly update on items discussed at the Parks, Wellness, and Recreation Commission (PWRC) meetings and welcomes any guidance or recommendations regarding the items presented.

DEPARTMENT UPDATES:

Programs and Services

The RCS Department provides a variety of programming and services for the San Fernando community. All Los Angeles County Department of Public Health protocols and Best Practices guidelines for operating recreational facilities are strictly adhered to.
