7) CONSIDERATION TO APPROVE A CONTRACT SERVICES AGREEMENT WITH IGNITE THE LIGHT OF HOPE FOUNDATION FOR FOOD DISTRIBUTIONS AND HOME GROCERY DELIVERY

Motion by Councilmember Garcia, seconded by Councilmember Lopez to approve a contract services agreement with Ignite the Light of Hope Foundation (Contract No. 2412) to provide food distributions and direct to home grocery delivery in San Fernando and authorize the City Manager or designee to make non substantive changes and execute the agreement. The motion carried, with Vice Mayor Solorio absent.

ADMINISTRATIVE REPORTS

13) DISCUSSION AND CONSIDERATION TO APPROVE A SECOND READING TO ADOPT ORDINANCE NO. 1735 AMENDING CHAPTER 90 (TRAFFIC AND VEHICLES) OF THE SAN FERNANDO MUNICIPAL CODE TO IMPLEMENT A RESIDENTIAL PARKING PERMIT PROGRAM AND TO MODIFY PARKING RESTRICTIONS OF CERTAIN VEHICLES INCLUDING FOR USE AS HUMAN HABITATIONS

Director of Public Works Wendell Johnson, Police Commander CJ Chiasson, and Interim Management Analyst Isabella Tapia presented the staff report and responded to Councilmember questions.

Motion by Councilmember Lopez, seconded by Mayor Mendoza to adopt Ordinance No. 1735 that was introduced for first reading at the City Council meeting of July 7, 2025, in title only, and waive all further readings titled, "An Ordinance Of The City Council of the City Of San Fernando, California, Amending Chapter 90 (Traffic And Vehicles) of the San Fernando Municipal Code to implement a Residential Parking Permit (RPP) Program and to modify parking restrictions of Campers, Recreational Vehicles, Utility Trailers and other Vehicles including those used for human habitation". The motion failed as the ordinance requires a majority vote by the Council and below are the following vote results:

The City Council City Council directed staff to return to the next meeting with separate ordinances (Residential Parking Permit, Parking Meters, and RV Parking Restrictions as stand-alone ordinances).

14) RECEIVE AND FILE AN INFORMATIONAL REPORT REGARDING FEASIBILITY OF INCREASING FINANCIAL ASSISTANCE PROGRAM AWARD THRESHOLDS

Assistant to the City Manager Will Pettener presented the staff report and responded to Councilmember questions. The City Council received and filed the report and confirmed maintaining the maximum threshold at \$250 per individual and \$500 per family.

15) DISCUSSION AND CONSIDERATION TO ADOPT A RESOLUTION HONORING LALO GARCIA FOR HIS OUTSTANDING CONTRIBUTIONS TO ART, CULTURE, AND THE COMMUNITY

Councilmember Patty Lopez presented the staff report.

Motion by Councilmember Lopez, seconded by Councilmember Fajardo to direct staff to revise the resolution and convert the wording into a Certificate of Proclamation. The motion carried, with Vice Mayor Solorio absent.

16) DISCUSSION AND CONSIDERATION TO ADOPT A RESOLUTION HONORING SALVADOR RODRIGUEZ FOR HIS ARTISTIC LEGACY AND COMMUNITY CONTRIBUTIONS

Councilmember Patty Lopez presented the staff report.

Motion by Councilmember Lopez, seconded by Councilmember Fajardo to direct staff to revise the resolution and convert the wording into a Certificate of Proclamation. The motion carried, with Vice Mayor Solorio absent.

17) DISCUSSION AND CONSIDERATION TO SUPPORT THE SAN FERNANDO WRESTLING YOUTH CROSSROADS PROGRAM

Councilmember Victoria Garcia presented the staff report and responded to Councilmember questions.

Motion by Councilmember Garcia, seconded by Mayor Mendoza to direct staff to reach out, either formally through a letter or informally by a City representative, to LAUSD to request a waiver of the fee charged to San Fernando Wrestling Youth Crossroads to use the facilities at San Fernando High School. The motion carried, with Vice Mayor Solorio absent.

18) DISCUSSION AND DIRECTION REGARDING GUIDELINES AND LIMITATIONS FOR CERTIFICATES OF RECOGNITION, PROCLAMATIONS, RESOLUTIONS PER MEETING

Mayor Mary Mendoza presented the staff report and responded to Councilmember questions.

The City Council directed staff to bring back a report Direction to bring staff report with proposed revisions to the City Recognition Requests Policy/Procedure. These revisions will add clear descriptions (e.g. formatting, design and frame) and guidelines for City Council issued Proclamations, and other forms of written recognition; to potentially include an option to adopt a resolution as a form of recognition, funding analysis, and include this project in the Council Enhancements Update staff report. By consensus, the City Council agreed that presentation certificates requests per Councilmember be limited to three (3) for the quarterly Recognition Celebration Special meetings.

STAFF COMMUNICATION INCLUDING COMMISSION UPDATES

City Clerk Fritz had no updates to report.

Interim Director of Community Development Garcia commented on community outreach progress efforts for the City's Climate Action Resilience Plan and the Housing Implementation Program.

Director of Recreation and Community Services Salcedo provided updates to upcoming recreation and community service activities and events.

Director of Public Works Johnson mentioned construction occurring at the Pacoima Wash Bikeway project related to the removal of bollards.

Director of Administrative Services Melton had no updates to report.

Police Chief Valdez had no updates to report.

Interim City Manager Kith expressed appreciation to the Public Works team for their quick response to the incident at the lower water reservoir, which prevented any interruption to the City's water distribution.
