

RESOLUTION NO. 8409

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN FERNANDO,
CALIFORNIA, IN SUPPORT OF PROPOSITION 50

WHEREAS, the State of Texas and other states have undertaken mid-decade redistricting to redraw congressional district maps in a manner designed to diminish California's representation in the federal legislature at the 2026 United States midterm elections; and

WHEREAS, officials in the states of Florida, Ohio, Indiana, Missouri, New Hampshire, Nebraska, and South Carolina have either started, or are strongly considering, similar mid-decade redistricting of congressional seats designed to unfairly favor Republicans; and

WHEREAS, California Proposition 50 ("Prop 50"), officially known as the Use of Legislative Congressional Redistricting Map Amendment is a legislatively referred constitutional amendment that will appear on the special election ballot in California on November 4, 2025; and

WHEREAS, Prop 50 was crafted in direct response to redistricting efforts in Texas and elsewhere; and

WHEREAS, Proposition 50 is an attempt to counterbalance the congressional redistricting efforts by other states in order to support the democratic process and protect Californians; and

WHEREAS, the taking of a position on a ballot measure in an open and public meeting where all perspectives may be shared is permissible (*Vargas v. City of Salinas*, 46 Cal.4th 1, 35-37 (2009)). See also *Choice-In Education League vs. Los Angeles Unified Sch. District*, 17 Cal.App.4th 415, 429-430 (1993)).

NOW, THEREFORE, the City Council of the City of San Fernando does hereby resolve and find as follows:

SECTION 1. City Council finds that the foregoing Recitals are true and correct.

SECTION 2. The San Fernando City Council supports **Proposition 50** and endorses its passage by California voters.

SECTION 3. The Mayor shall sign this Resolution and the City Clerk shall attest and certify to the passage and adoption thereof. This Resolution shall take effect immediately upon its adoption.

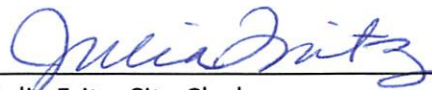
