ACTIVITY CALENDAR General Municipal Election June 2, 2026	
DATE	EVENT
February 9 – March 6, 2026	Nomination Period – First and Last day for candidates to file nomination documents with the City Clerk
March 7 – March 11, 2026	Extended Nomination Period to file nomination documents with City Clerk if an incumbent does not file for re-election.
March 12, 2026 (11:00 a.m.)	California Secretary of State to Determine Order of Names on Ballot by Random Alphabet Drawing
April 23, 2026	First pre-election Campaign Finance Reporting statement due for the period of 1/1/2026 through 04/18/2026
May 4, 2026	Mailing of Vote By Mail Ballots Begin
May 18, 2026	Last Day to Transfer or Register to Vote for June 2, 2026 Election
May 21, 2026	Second pre-election Campaign Finance Reporting statement due for the period of 4/19/2026 through 5/16/2026
May 12, 2026	Mailing of Official Sample Ballot Booklets Begin
May 23, 2026 – June 2, 2026	In-Person voting period begins for 10 consecutive days and voters may visit any participating 10-day early Vote Center in the County.
JUNE 2	ELECTION DAY
June 2, 2026	Vote Centers will open from 7:00 am to 8:00 pm. Follow election results: www.lavote.net
July 2, 2026	The Registrar-Recorder/County Clerk (RR/CC) is <u>tentatively</u> scheduled to certify the election results. <i>Elections Codes §§ 15301, 15372, 15400, 15401 - The official canvass must be completed within 30 days of the election.</i>
July 6, 2026 - Tentative	If the results are certified by the RR/CC on July 2, 2026, the City Council may adopt a resolution reciting the results of the election and install newly elected Councilmembers at the July 6, 2026 City Council meeting. <i>Elections Code § 10263 - When a City election is consolidated with a statewide election, a newly elected official is to be installed in office no later than the next regularly scheduled City Council meeting after a certified statement of the results of the election is submitted by the county elections official to the city council, or at a Regular meeting called for this purpose.</i>
July 3, 2026	The County of Los Angeles Board of Supervisors is tentatively scheduled to declare the June 2, 2026 Election, officially concluded.

January 31, 2026	Last Day to File Campaign Expenditure Statements - Semi-Annual Statement for the period of 5/17/26 – 6/30/26
